AN ACT 1 APPROPRIATING MONEYS TO THE DIVISION OF VETERANS SERVICES FOR FISCAL YEAR 2 2017; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSI-3 TIONS; APPROPRIATING AND TRANSFERRING MONEYS FROM THE FEDERAL GRANT 4 5 FUND TO THE RESIDENT TRUST FUND FOR FISCAL YEAR 2016; AND DECLARING AN EMERGENCY. 6

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. There is hereby appropriated to the Division of Veterans Services, the following amounts to be expended for the designated expense classes, from the listed funds for the period July 1, 2016, through June 30, 10 2017:

SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519, Idaho Code, the Division of Veterans Services is authorized no more than three hundred thirty-three (333) full-time equivalent positions at any point during the period July 1, 2016, through June 30, 2017, unless specifically authorized by the Governor. The Joint Finance-Appropriations Committee will be notified promptly of any increased positions so authorized.

In addition to the appropriation made in Section 1, Chapter 161, Laws of 2015, and any other appropriation provided for by law, there is hereby appropriated to the Division of Veterans Services and the State

- 1 Controller shall transfer, as soon as practicable, \$1,500 from the Federal 2 Grant Fund to the Resident Trust Fund, for the period July 1, 2015, through 3 June 30, 2016.
- SECTION 4. An emergency existing therefor, which emergency is hereby declared to exist, Section 3 of this act shall be in full force and effect on and after passage and approval.
