STATEMENT OF PURPOSE

This is the Fiscal Year 2017 appropriation for the Teachers Division of the Public Schools Educational Support Program, in the amount of \$855,733,000. This budget includes nondiscretionary adjustments of \$42,238,200. Of this amount \$39,561,000 is for the second year of instructors who are on the career ladder compensation system. There is also \$1,955,500 to move pupil service staff onto the career ladder, \$582,500 for an increase in leadership awards, and \$139,200 for increases in math and science requirements. There are two line items. Line item 3 provides \$5,000,000 for academic and college or career advisors and student mentors to be implemented according to Sections 33-1002(s) and 33-1212A, Idaho Code. Line item 4 provides \$2,375,000 for professional development. With the \$10,625,000 already in the base, the addition of this line item will result in \$13,000,000 distributed to school districts and charter schools for teacher and pupil service staff professional development. This appropriation results in a General Fund increase of 6.3% above the previous year and a total fund increase of 6.2%.
