IDAPA 24.24.01 - Rules of the Genetic Counselors Licensing Board (Fee Rule) - Proposed Rule (Docket No. 24-2401-1701)

The Bureau of Occupational Licenses submits notice of a proposed fee rule at IDAPA 24.24.01 - Rules of the Genetic Counselors Licensing Board. The proposed rule reduces the fees charged by the Board for applications, original licenses, annual renewals, provisional licenses and licenses by endorsement. The reduction in fees is intended to reduce the Board's cash balance and bring it within audit recommendations of 100-150% of their annual budget.

The Bureau states that negotiated rulemaking was not conducted because the proposed changes were discussed during open, noticed meetings of the Board. The Bureau further states that the fee rule will have no impact on the general fund and that the impact on the Bureau of Occupational Licenses' dedicated fund will be a reduction of approximately \$16,200 per year. The proposed fee rule appears to be within the statutory authority granted to the Board pursuant to sections 54-5607 and 54-5613, Idaho Code.

The cash balance of the Genetic Counselors Licensing Board exceeds that amount. Accordingly, the Board wants to lower its balance and leave more money in the hands of its licensees.

Rule 250 reduces the fees for application, original license, annual renewal, provisional license, and license by endorsement from \$500 each to \$200.
