160. NURSING HOME ADMINISTRATOR QUALIFICATIONS FOR LICENSE (RULE 160). Any applicant who holds a valid Idaho nursing home administrator license must meet the requirements provided in Section 54-4211(2), Idaho Code, and must take and pass the Board-approved residential care administrator examination.
