46 Be It Enacted by the Legislature of the State of Idaho:

47 SECTION 1. That Section 67-5201, Idaho Code, be, and the same is hereby
48 amended to read as follows:

1 67-5201. DEFINITIONS. As used in this act:

2 (1) "Administrative code" means the Idaho administrative code estab-
3 lished in this chapter.

4 (2) "Agency" means each state board, commission, department or officer
5 authorized by law to make rules or to determine contested cases, but does not
6 include the legislative or judicial branches, executive officers listed in
7 section 1, article IV, of the constitution of the state of Idaho in the exer-
8 cise of powers derived directly and exclusively from the constitution, the
9 state militia or the state board of correction.

10 (3) "Agency action" means:

11 (a) ~~The whole or part~~ Issuance of a rule or order;

12 (b) The failure to issue a rule or order; or

13 (c) An agency's performance of, or failure to perform, any duty placed
14 on it by law.

15 (4) "Agency decision" means an agency action in a proceeding other than
16 rulemaking.

17 (5) "Agency head" means an individual or body of individuals in whom the
18 ultimate legal authority of the agency is vested by any provision of law.

19 (56) "Bulletin" means the Idaho administrative bulletin established in
20 this chapter.

21 (67) "Contested case" means a proceeding an adjudication proceeding
22 arising out of an agency decision or failure to issue an agency decision,
23 from which results in the issuance of an order an opportunity for an eviden-
24 tiary hearing is required by the federal constitution, a federal statute
25 or the constitution or a statute of this state. A contested case commences
26 when a request for a contested case proceeding is filed with the office of
27 administrative hearings under section 67-5243, Idaho Code.

28 (78) "Contested case order" means an order issued by a hearing officer
29 resolving issues in a contested case and includes all findings of fact and
30 conclusions of law upon which the order is based, which is intended to be the
31 final order submitted to the agency head.

32 (9) "Coordinator" means the administrative rules coordinator pre-
33 scribed in section 67-5202, Idaho Code.

34 (810) "Document" means any executive order, notice, rule or statement
35 of policy of an agency.

36 (11) "Final order" means:

37 (a) A contested case order that is final as provided in sections 67-5253
38 and 67-5254, Idaho Code; or

39 (b) A declaratory ruling order that is a final agency action subject to
40 judicial review.

41 (912) "Final rule" means a rule that has been adopted by an agency under
42 the regular rulemaking process and is in effect.

43 (13) "Hearing officer" means an individual, appointed by the chief ad-
44 ministrative hearing officer of the office of administrative hearings pur-
45 suant to section 67-5271, Idaho Code.

46 (104) "License" means the whole or part of any agency permit, certifi-
47 cate, approval, registration, charter, or similar form of authorization re-
48 quired by law, but does not include a license required solely for revenue
49 purposes.

1 (145) "Official text" means the text of a document issued, prescribed,
2 or promulgated by an agency in accordance with this chapter, and is the only
3 legally enforceable text of such document. Judicial notice shall be taken
4 of all documents issued, prescribed, or promulgated in accordance with this
5 chapter.

6 (126) "Order" means an agency action of particular applicability that
7 determines the legal rights, duties, privileges, immunities, or other legal
8 interests of one (1) or more specific persons. The granting of an applica-
9 tion for a license that is unconditional in respect to the license requested,
10 and that does not affect the rights of a third party who may have a right to
11 commence a contested case, is not an order.

12 (137) "Party" means each person or agency named or admitted as a party,
13 or properly seeking and entitled as of right to be admitted as a party.

14 (148) "Pending rule" means a rule that has been adopted by an agency un-
15 der the regular rulemaking process and remains subject to legislative re-
16 view.

17 (159) "Person" means any individual, partnership, corporation, associ-
18 ation, governmental subdivision or agency, or public or private organiza-
19 tion or entity of any character.

20 (20) "Preliminary review" means the receipt, collection, processing,
21 and analyzing of information, or other activity of an agency preparatory to
22 and including the making of an agency decision.

23 (1621) "Proposed rule" means a rule published in the bulletin as pro-
24 vided in section 67-5221, Idaho Code.

25 (1722) "Provision of law" means the whole or a part of the state or fed-
26 eral constitution, or of any state or federal:

27 (a) Statute; or

28 (b) Rule or decision of court.

29 (1823) "Publish" means to bring before the public by publication in the
30 bulletin or administrative code, by electronic means or as otherwise specif-
31 ically provided by law.

32 (24) "Record" means information that is inscribed on a tangible medium
33 or that is stored in an electronic or other medium and is retrievable in per-
34 ceivable form.

35 (1925) "Rule" means the whole or a part of an agency statement of general
36 applicability that has been promulgated in compliance with the provisions of
37 this chapter and that implements, interprets, or prescribes:

38 (a) Law or policy; or

39 (b) The procedure or practice requirements of an agency. The term in-
40 cludes the amendment, repeal, or suspension of an existing rule, but
41 does not include:

42 (i) Statements concerning only the internal management or in-
43 ternal personnel policies of an agency and not affecting private
44 rights of the public or procedures available to the public; or

45 (ii) Declaratory rulings issued pursuant to section ~~67-5232~~
46 ~~67-5268~~, Idaho Code; or

47 (iii) Intra-agency memoranda; or

48 (iv) Any written statements given by an agency which pertain to
49 an interpretation of a rule or to the documentation of compliance
50 with a rule.

1 (206) "Rulemaking" means the process for formulation, adoption, amend-
2 ment or repeal of a rule.

3 (217) "Standard" means a manual, guideline, criterion, specification,
4 requirement, measurement or other authoritative principle providing a model
5 or pattern in comparison with which the correctness or appropriateness of
6 specified actions, practices or procedures may be determined.

7 (228) "Submitted for review" means that a rule has been provided to the
8 legislature for review at a regular or special legislative session as pro-
9 vided in section 67-5291, Idaho Code.

10 (239) "Temporary rule" means a rule authorized by the governor to be-
11 come effective before it has been submitted to the legislature for review and
12 which expires by its own terms or by operation of law no later than the con-
13 clusion of the next succeeding regular legislative session unless extended
14 or replaced by a final rule as provided in section 67-5226, Idaho Code.

15 SECTION 2. That Section 67-5240, Idaho Code, be, and the same is hereby
16 repealed.

17 SECTION 3. That Chapter 52, Title 67, Idaho Code, be, and the same is
18 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
19 ignated as Section 67-5240, Idaho Code, and to read as follows:

20 67-5240. CONTESTED CASE EXEMPTIONS. A proceeding by an agency, other
21 than the public utilities commission, the industrial commission, the de-
22 partment of water resources or the water resources board that may result in a
23 contested case order is governed by the provisions of this chapter, except
24 as provided by other provisions of law.

25 SECTION 4. That Section 67-5241, Idaho Code, be, and the same is hereby
26 amended to read as follows:

27 67-5241. ~~INFORMAL DISPOSITION BY AGREEMENT~~. (1) Unless prohibited by
28 other provisions of law, informal disposition by written agreement prior to
29 filing a request for a contested case proceeding by a party is not a contested
30 case. Informal settlement of matters is to be encouraged.

31 ~~(a) an agency or a presiding officer may decline to initiate a contested~~
32 ~~case;~~

33 ~~(b) any part of the evidence in a contested case may be received in writ-~~
34 ~~ten form if doing so will expedite the case without substantially preju-~~
35 ~~dicating the interests of any party;~~

36 ~~(c) informal disposition may be made of any contested case by negoti-~~
37 ~~ation, stipulation, agreed settlement, or consent order. Informal settle-~~
38 ~~ment of matters is to be encouraged;~~

39 ~~(d) the parties may stipulate as to the facts, reserving the right to~~
40 ~~appeal to a court of competent jurisdiction on issues of law.~~

41 (2) ~~An agency or a presiding officer may request such additional in-~~
42 ~~formation as required to decide whether to initiate or to decide a contested~~
43 ~~case as provided in subsection (1) of this section After filing of a request~~
44 ~~for a contested case, disposition of all or part of the issues in a case may~~

 12 final contested case order resolving all of the issues.

13 ~~(4) The agency may not abdicate its responsibility for any informal~~
 14 ~~disposition of a contested case. Disposition of a contested case as provided~~
 15 ~~in this section is a final agency action~~ A contested case order based upon
 16 agreement or consent order disposing of all the issues is subject to judicial
 17 review when final, as any other final order, unless as part of the agreement
 18 or consent order the right to judicial review has been expressly waived.

19 (5) Any disposition by agreement is a public record except as otherwise
 20 exempt under chapter 1, title 74, Idaho Code, and any nondisclosure provi-
 21 sion protecting nonexempt information is void as against public policy.

 40 sign an employee or contract with a private individual or entity to perform
 41 such fact-finding. Such fact finder shall not be from the office of adminis-
 42 trative hearings, and any fact-finding shall be for the use of the agency in
 43 making an agency decision, and is not binding in any way as findings of fact
 44 in a contested case proceeding.

4 67-5243. COMMENCEMENT OF CONTESTED CASES. (1) This section applies to
5 an emergency adjudication under section 67-5247, Idaho Code, except as oth-
6 erwise provided in that section.

7 (2) A contested case commences when a request for a contested proceed-
8 ing is filed as provided in this section by:

9 (a) A person who has received notice of an agency decision;

10 (b) A person challenging the failure of an agency to timely issue an
11 agency decision;

12 (c) A person challenging an emergency order issued pursuant to section
13 67-5247, Idaho Code, when the order is not included within the subject
14 matter of an existing contested case proceeding;

15 (d) An agency seeking to revoke, suspend, annul or withdraw an existing
16 license as provided in section 67-5259, Idaho Code; or

17 (e) An agency decision to take other adverse action against a person in
18 connection with which the person or the agency is entitled by law to an
19 opportunity for an evidentiary hearing.

20 (3) An agency shall give notice to a person of an agency decision that
21 would entitle the person to initiate a contested case proceeding. The no-
22 tice must be in writing, set forth the agency decision, inform the person
23 of the right, procedure and time limit to file a contested case request, and
24 provide a copy of the procedures governing contested cases. Within twenty-
25 eight (28) days of receipt of the notice provided for in this subsection, the
26 affected person may file a request for a contested case proceeding that sets
27 forth the grounds for the request for a contested case proceeding.

28 (4) A person or agency filing a request for a contested case proceeding
29 as provided in subsection (2) of this section shall file the request with the
30 office of administrative hearings. The request shall identify the matter
31 that is the subject of the request, including the agency and person or per-
32 sons that are parties, the nature of the contested case, and the grounds upon
33 which the matter is contested.

34 (5) A person may also file a request for a contested case proceeding
35 with the agency. The agency shall then, within seven (7) days of receipt of
36 the request for a contested case proceeding, file the request with the office
37 of administrative hearings.

38 (6) When a request for a contested case proceeding is filed with the of-
39 fice of administrative hearings by a person, the office shall, within seven
40 (7) days of receipt of the request for a contested case proceeding, forward a
41 copy of the same to the agency.

42 (7) When an agency files a request for a contested case proceeding, it
43 shall simultaneously serve a copy of the request upon the other parties.
44 When a request for a contested case proceeding is filed by an agency with
45 the office of administrative hearings, the office shall, within seven (7)
46 days of receipt, forward a copy of the same to the other named parties giving
47 notice of filing of the request with the office.

48 (8) In a contested case proceeding initiated by a person, not later than
49 seven (7) days after the filing of the contested case proceeding request with

1 the office of administrative hearings, the office of administrative hear-
 2 ings shall give notice to all parties that the case has been commenced. The
 3 notice must contain:

- 4 (a) A statement that a case has been commenced that may result in an or-
 5 der affecting the rights of the parties;
 6 (b) A short and plain statement of the matters asserted in the request
 7 for a contested case proceeding;
 8 (c) A statement of the legal authority under which the hearing will be
 9 held citing the statutes and any rules involved;
 10 (d) The official file or other reference number and the name of the pro-
 11 ceeding;
 12 (e) The name, official title and mailing address of the hearing officer
 13 and the name, official title, mailing address and telephone number of
 14 the agency's representative;
 15 (f) A statement that a party who fails to attend or participate in any
 16 subsequent proceeding in the case may be held in default;
 17 (g) A statement of the date, time, place and nature of the prehearing
 18 conference or hearing, if any;
 19 (h) The names and last known addresses of all parties and other persons
 20 to which notice is being given; and
 21 (i) Any other information that the hearing officer considers desirable
 22 to expedite the proceedings.

23 SECTION 10. That Chapter 52, Title 67, Idaho Code, be, and the same is
 24 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
 25 ignated as Section 67-5244, Idaho Code, and to read as follows:

26 67-5244. CONTESTED CASE PROCEDURE. (1) In a contested case, the hear-
 27 ing officer shall give all parties a timely opportunity to file pleadings,
 28 motions and objections. The hearing officer may give all parties the oppor-
 29 tunity to file briefs, proposed findings of fact and conclusions of law, and
 30 proposed contested case orders. The hearing officer, with the consent of all
 31 parties, may refer the parties in a contested case to mediation or other dis-
 32 pute resolution procedure.

33 (2) In a contested case, to the extent necessary for full disclosure of
 34 all relevant facts and issues, the hearing officer shall give all parties the
 35 opportunity to respond, present evidence and argument, conduct cross-exami-
 36 nation and submit rebuttal evidence.

37 (3) Except as otherwise provided by law other than this act, the hear-
 38 ing officer may conduct all or part of an evidentiary hearing or a prehearing
 39 conference by telephone, television, video conference or other electronic
 40 means. The hearing may be conducted by telephone or other method by which the
 41 witnesses may not be seen only if all parties consent or the hearing officer
 42 finds that this method will not impair reliable determination of the credi-
 43 bility of testimony. Each party must be given an opportunity to attend, hear
 44 and be heard at the proceeding as it occurs.

45 (4) Any part of the evidence in a contested case may be received in writ-
 46 ten form if doing so will expedite the case without substantially prejudic-
 47 ing the interests of any party.

48 (5) Except as otherwise provided by law or in subsection (6) of this
 49 section, a hearing in a contested case must be open to the public. A hearing

1 conducted by telephone, television, video conference or other electronic
2 means is open to the public if members of the public have an opportunity to
3 attend the hearing at the place where the hearing officer is located or to
4 hear or see the proceeding as it occurs.

5 (6) A hearing officer may close a hearing to the public on a ground on
6 which a court of this state may close a judicial proceeding to the public or
7 pursuant to law of this state other than this act.

8 (7) Unless prohibited by law of this state other than this act, a party,
9 at the party's expense, may be advised or represented by counsel. If allowed
10 by administrative rule or statute, a party may be advised or represented by
11 another individual. A corporate or other business entity may be represented
12 by an officer, general partner or manager of the corporation or business en-
13 tity.

14 (8) A hearing officer shall ensure that a hearing record is created that
15 complies with section 67-5246, Idaho Code.

16 (9) The order in a contested case must be based on the hearing record
17 and contain a statement of the findings of fact and conclusions of law upon
18 which the order is based. The order must be prepared electronically and, on
19 request, made available in writing.

20 (10) The parties may stipulate as to the facts, reserving the right to
21 appeal to a court of competent jurisdiction on issues of law.

22 (11) Unless prohibited by law of this state other than this act, a hear-
23 ing officer may dispose of a contested case without a hearing by stipulation.

24 SECTION 11. That Chapter 52, Title 67, Idaho Code, be, and the same is
25 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
26 ignated as Section 67-5245, Idaho Code, and to read as follows:

27 67-5245. EVIDENCE IN CONTESTED CASES. The following rules apply in a
28 contested case:

29 (1) Except as otherwise provided in subsection (2) of this section, all
30 relevant evidence is admissible, including hearsay evidence, if it is of a
31 type commonly relied on by a reasonably prudent individual in the conduct of
32 the affairs of the individual.

33 (2) The hearing officer may exclude evidence with or without objection
34 if the evidence is irrelevant, immaterial, unduly repetitious, or exclud-
35 able on constitutional or statutory grounds or on the basis of an evidentiary
36 privilege recognized in the courts of this state.

37 (3) If the hearing officer excludes evidence with or without objection,
38 the offering party may make an offer of proof before further evidence is pre-
39 sented or at a later time determined by the hearing officer.

40 (4) Documentary evidence may be received in the form of a copy if the
41 original is not readily available. On request, parties must be given an op-
42 portunity to compare the copy with the original.

43 (5) Testimony must be made under oath or affirmation.

44 (6) Evidence must be made part of the hearing record of the case. Infor-
45 mation or evidence may not be considered in determining the case unless it is
46 part of the hearing record. If the hearing record contains information that
47 is confidential, the hearing officer may conduct a closed hearing to discuss
48 the information, issue necessary protective orders, and seal all or part of
49 the hearing record.

1 (7) The hearing officer may take official notice of all facts of which
2 judicial notice may be taken and of scientific, technical or other facts
3 within the specialized knowledge of the agency. A party must be notified at
4 the earliest practicable time of the facts proposed to be noticed and their
5 source, including any staff memoranda or data. The party must be afforded
6 an opportunity to contest any officially noticed fact before the decision
7 becomes final.

8 SECTION 12. That Chapter 52, Title 67, Idaho Code, be, and the same is
9 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
10 ignated as Section 67-5246, Idaho Code, and to read as follows:

11 67-5246. HEARING RECORD IN CONTESTED CASES. (1) The hearing officer
12 and office of administrative hearings shall cause the hearing to be recorded
13 at the agency's expense. Any party, at that party's expense, may have a
14 transcript prepared or may cause additional recordings to be made during the
15 hearing if the making of the additional recording does not cause distraction
16 or disruption.

17 (2) The office of administrative hearings shall maintain the hearing
18 record in each contested case for a period of not less than six (6) months
19 after the expiration of the last date for judicial review, unless otherwise
20 provided by law.

21 (3) The hearing record must contain:

22 (a) A recording of each hearing;

23 (b) Notice of each hearing;

24 (c) Any prehearing order;

25 (d) Any motion, pleading, brief, request and intermediate ruling;

26 (e) Evidence admitted;

27 (f) A statement of any matter officially noticed;

28 (g) Any proffer of proof and objection and ruling thereon;

29 (h) Any proposed finding, requested order, and exception;

30 (i) Any transcript of the proceeding;

31 (j) Any contested case order and any orders preliminary thereto, or any
32 order on reconsideration; and

33 (k) Any matter placed on the record after an ex parte communication un-
34 der section 67-5248, Idaho Code.

35 (4) The hearing record constitutes the exclusive basis for hearing of-
36 ficer action in a contested case.

37 SECTION 13. That Chapter 52, Title 67, Idaho Code, be, and the same is
38 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
39 ignated as Section 67-5247, Idaho Code, and to read as follows:

40 67-5247. EMERGENCY ADJUDICATION PROCEDURE. (1) If otherwise autho-
41 rized by law of this state, an agency may take action and issue an order to
42 address an immediate danger to the public health or safety. The agency shall
43 take only such actions as are necessary to prevent or avoid the immediate
44 danger to the public health or safety that justifies the use of an emergency
45 order.

46 (2) Before issuing an order under this section, an agency, if practica-
47 ble, shall give notice and an opportunity to be heard to the person to which

1 the agency action is directed. The notice of the hearing and the hearing may
2 be oral or written and may be by telephone, facsimile or other electronic
3 means.

4 (3) An order issued under this section must briefly explain the factual
5 and legal reasons for using emergency adjudication procedures. The order is
6 effective when signed by the agency head or the designee of the agency head.

7 (4) As soon as practicable, but not more than seven (7) days after is-
8 suance of an order, an agency shall give notice to the person to which the
9 agency action is directed that an order has been issued. The notice shall
10 contain the information required under section 67-5243 (3), Idaho Code, and
11 shall contain a copy of the emergency order.

12 (5) A person receiving a notice of issuance of an emergency order may
13 within twenty-one (21) days file a request for a contested case proceeding
14 pursuant to section 67-5243, Idaho Code, if the emergency order is not oth-
15 erwise part of an existing contested case proceeding. The office of adminis-
16 trative hearings shall, as soon as practicable, but no more than thirty (30)
17 days after the filing of the request for a contested case proceeding, conduct
18 a hearing following the procedure under section 67-5244, Idaho Code, to de-
19 termine the issues underlying the emergency order. The time for hearing may
20 be extended upon request of the person against whom the order was issued. The
21 hearing officer may shorten times and limit discovery, which in his discre-
22 tion are consistent with both an expedited hearing and equity. In the event
23 that a contested case proceeding was previously initiated regarding the sub-
24 ject matter of the emergency order, the hearing officer shall set an expe-
25 dited hearing only with regard to the issuance of the emergency order follow-
26 ing procedures consistent with this section.

27 (6) An order issued under this section, unless stayed after hearing or
28 otherwise, may be effective for not longer than one hundred twenty (120) days
29 or until the expiration date of any order issued under subsection (1) of this
30 section, whichever is shorter. Provided however, an emergency order may be
31 extended for a reasonable time upon motion of the agency with notice to all
32 parties, and for good cause determined after hearing by the hearing officer.

33 SECTION 14. That Chapter 52, Title 67, Idaho Code, be, and the same is
34 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
35 ignated as Section 67-5248, Idaho Code, and to read as follows:

36 67-5248. EX PARTE COMMUNICATIONS. (1) Except as otherwise provided in
37 subsection (2) of this section, while a contested case is pending, the hear-
38 ing officer may not make to or receive from any person any communication con-
39 cerning the case without notice and opportunity for all parties to partici-
40 pate in the communication. For the purpose of this section, a contested case
41 is considered pending upon the filing of a request for a contested case pro-
42 ceeding with the office of administrative hearings. A contested case is no
43 longer pending once a final order is issued by an agency.

44 (2) A hearing officer may communicate about a pending contested case
45 with any person if the communication is required for the disposition of ex
46 parte matters authorized by statute or if it concerns an uncontested proced-
47 dural issue.

48 (3) If a communication prohibited by this section is made, the hearing
49 officer shall notify all parties of the prohibited communication and permit

1 parties to respond in a record not later than fourteen (14) days after the
2 notice is given. For good cause, the hearing officer may permit additional
3 testimony in response to the prohibited communication.

4 (4) If necessary to eliminate the effect of a communication received in
5 violation of this section, a hearing officer may be disqualified under sec-
6 tion 67-5274, Idaho Code, the parts of the record pertaining to the communi-
7 cation may be sealed by protective order, or other appropriate relief may be
8 granted, including an adverse ruling on the merits of the case or dismissal
9 of the application.

10 SECTION 15. That Chapter 52, Title 67, Idaho Code, be, and the same is
11 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
12 ignated as Section 67-5250, Idaho Code, and to read as follows:

13 67-5250. SUBPOENAS. (1) On request by a party in a contested case, the
14 hearing officer, on a showing of general relevance and reasonable scope of
15 the evidence sought for use at the hearing, shall issue a subpoena for the
16 attendance of a witness and the production of books, records and other evi-
17 dence.

18 (2) Unless otherwise provided by law or agency rule, a subpoena issued
19 under subsection (1) of this section shall be served and, on application to
20 the court by a party or the agency, enforced in the manner provided by law for
21 the service and enforcement of a subpoena in a civil action.

22 (3) Witness fees shall be paid by the party requesting a subpoena in the
23 manner provided by law for witness fees in a civil action.

24 (4) The provisions of this section shall provide the exclusive method
25 for the issuance of subpoenas in all contested cases.

26 SECTION 16. That Chapter 52, Title 67, Idaho Code, be, and the same is
27 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
28 ignated as Section 67-5251, Idaho Code, and to read as follows:

29 67-5251. DISCOVERY. (1) In this section, "statement" includes a
30 record of a person's written statement signed by the person and a record that
31 summarizes an oral statement made by the person.

32 (2) Except as otherwise provided for in an emergency hearing under
33 section 67-5247, Idaho Code, a party, on written notice to another party
34 at least thirty (30) days before an evidentiary hearing, unless otherwise
35 ordered by the hearing officer under this section, may:

36 (a) Obtain the names and addresses of witnesses the other party will
37 present at the hearing to the extent known to the other party; and

38 (b) Inspect and copy any of the following materials in the possession,
39 custody or control of the other party:

40 (i) Statements of parties and witnesses proposed to be called by
41 the other party;

42 (ii) All records, including reports of mental, physical, and
43 blood examinations, and other evidence the other party proposes to
44 offer;

45 (iii) Investigative reports made by or on behalf of the agency or
46 other party pertaining to the subject matter of the adjudication;

1 (iv) Statements of expert witnesses proposed to be called by the
2 other party;

3 (v) Any exculpatory material in the possession of the agency; and

4 (vi) Other materials for good cause.

5 (3) Parties to a contested case have a duty to supplement responses pro-
6 vided under subsection (2) of this section to include information thereafter
7 acquired, to the extent that the information will be relied on in the hear-
8 ing.

9 (4) On request, the hearing officer may issue a protective order for
10 any material for which discovery is sought under this section that is exempt,
11 privileged, or otherwise made confidential or protected from disclosure by
12 law of this state other than this act, and material, the disclosure of which
13 would result in annoyance, embarrassment, oppression or undue burden or ex-
14 pense to any person.

15 (5) On request, the hearing officer may issue an order compelling dis-
16 covery for refusal to comply with a discovery request unless good cause ex-
17 ists for refusal. Failure to comply with the order may be enforced according
18 to the rules of civil procedure.

19 (6) On request and for good cause, the hearing officer may issue an or-
20 der authorizing additional discovery tools allowed under the Idaho rules of
21 civil procedure.

22 SECTION 17. That Chapter 52, Title 67, Idaho Code, be, and the same is
23 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
24 ignated as Section 67-5252, Idaho Code, and to read as follows:

25 67-5252. DEFAULT. (1) Unless otherwise provided by law of this state
26 other than this act, if a party without good cause fails to attend or partic-
27 ipate in a prehearing conference or hearing in a contested case, the hearing
28 officer may issue a default order.

29 (2) If a default order is issued, the hearing officer may conduct any
30 further proceedings necessary to complete the adjudication without the de-
31 faulting party and shall determine all issues in the adjudication, including
32 those affecting the defaulting party, and issue a contested case order.

33 (3) A contested case order issued against a defaulting party may be
34 based on the defaulting party's admissions or other evidence that may be used
35 without notice to the defaulting party. If the burden of proof is on the
36 defaulting party to establish that the party is entitled to the agency action
37 sought, the hearing officer may issue a contested case order without taking
38 evidence.

39 (4) Not later than sixty (60) days after notice to a party subject to
40 a default order that any resulting contested case order has been rendered
41 against the party, the party may request the hearing officer to vacate the
42 contested case order. If good cause is shown for the party's failure to
43 appear, the hearing officer shall vacate the contested case order and, af-
44 ter proper service of notice, conduct another evidentiary hearing. If good
45 cause is not shown for the party's failure to appear, the hearing officer
46 shall deny the motion to vacate.

1 SECTION 18. That Chapter 52, Title 67, Idaho Code, be, and the same is
2 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
3 ignated as Section 67-5253, Idaho Code, and to read as follows:

4 67-5253. CONTESTED CASE ORDERS. (1) A contested case order must sep-
5 arately state findings of fact and conclusions of law on all material is-
6 sues of fact, law, or discretion, the remedy prescribed, and, if applica-
7 ble, the action taken on a request for a stay. The hearing officer may per-
8 mit a party to submit proposed findings of fact and conclusions of law. A
9 contested case order must state any circumstances under which the contested
10 case order, without further notice, may become a final order.

11 (2) Findings of fact must be based on the evidence and matters offi-
12 cially noticed in the hearing record in the contested case.

13 (3) A contested case order is issued under this section when it is
14 signed by the hearing officer.

15 (4) A contested case order must be served by the office of administra-
16 tive hearings in a record on each party and the agency head not later than
17 sixty (60) days after the hearing ends, the record closes, or memoranda,
18 briefs, or proposed findings are submitted, whichever is latest. The hear-
19 ing officer may extend the time by stipulation of the parties or upon motion
20 and finding of good cause. The contested case order shall be accompanied by
21 proof of service stating the service date, each party who was served and the
22 method of service.

23 (5) A contested case order is final twenty-eight (28) days after its
24 service date unless reconsideration is granted under section 67-5256, Idaho
25 Code, or if there is an agency review under section 67-5254, Idaho Code.

26 (6) The hearing officer shall attach to the contested case order the
27 available procedures and time limits for seeking reconsideration or other
28 administrative relief and must state the time limits for seeking judicial
29 review of the contested case order.

30 SECTION 19. That Chapter 52, Title 67, Idaho Code, be, and the same is
31 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
32 ignated as Section 67-5254, Idaho Code, and to read as follows:

33 67-5254. AGENCY REVIEW OF CONTESTED CASE ORDER. (1) An agency head may
34 review a contested case order before the order is final. If the agency head
35 decides to review a contested case order, the agency head shall give notice
36 in a record to the parties and the administrative hearing officer that he in-
37 tends to review the order. A notice of review of a contested case order by
38 an agency head must be filed with the office of administrative hearings not
39 later than twenty-eight (28) days after the service date of the hearing of-
40 ficer's order. The agency head shall also contemporaneously serve a copy of
41 the notice of review on the parties. The office of administrative hearings
42 shall serve notice within three (3) days to all parties that a notice of re-
43 view has been filed by the agency head, and the date of the filing.

44 (2) A party may request an agency head to review a contested order be-
45 fore it is final. The party shall serve a request for review upon the office
46 of administrative hearings. If the request is timely, the office of admin-
47 istrative hearings shall serve the request within three (3) days upon the
48 agency head, with notice of service to all parties. The agency head shall

1 have fourteen (14) days from the service of the request for review upon the
2 agency head to file a notice with the office of administrative hearings with
3 service upon the other parties either accepting or declining the request for
4 review. If no timely notice accepting or declining the review is filed by
5 the agency head, the request shall be deemed declined. If the request is de-
6 clined, the contested case order shall be final from the date of the notice of
7 or last day for declining the review or twenty-eight (28) days after filing
8 of the contested case order, whichever is later. If the agency head accepts
9 the request for review, the time for review under subsection (6) of this sec-
10 tion commences on the date of the filing of the notice of acceptance of the
11 request for review.

12 (3) If a request for review is not filed or the agency head does not
13 elect to review the contested case order within the prescribed time limit,
14 the order becomes a final order as provided in section 67-5253 (5), Idaho
15 Code.

16 (4) A notice of agency review or a request for agency review may not
17 be filed during the pendency of a request for reconsideration under section
18 67-5256, Idaho Code. If request for reconsideration is filed after a notice
19 of agency review, the request for reconsideration takes precedence and shall
20 be decided first by the hearing officer. If the reconsideration is granted,
21 a pending notice shall be deemed moot, subject to filing of a new notice fol-
22 lowing filing of the reconsidered contested case order. If the request for
23 reconsideration is denied, the agency head review process shall proceed as
24 if the request for reconsideration had not been filed with any relevant time
25 periods tolled during the pendency of the request for reconsideration.

26 (5) When reviewing a contested case order, the agency head shall ex-
27 ercise the decision-making power that the agency head would have had if the
28 agency head had conducted the hearing that produced the order, except that
29 the agency head shall not modify findings of fact.

30 (6) If an agency head reviews a contested case order, the agency head
31 shall issue a final order disposing of the proceeding not later than sixty
32 (60) days after the notice to review the contested case order was filed with
33 the office of administrative hearings.

34 (7) An order issued by the agency head after agency head review of a con-
35 tested case order must identify any difference between the final order and
36 the contested case order and must state the law that supports any difference
37 in legal conclusions and the policy reasons that support any difference in
38 the exercise of discretion. Findings of fact shall not be modified in the re-
39 view process.

40 (8) A final order under this section must include, or incorporate by
41 express reference to the contested case order, the matters required by sec-
42 tion 67-5253(1), Idaho Code. The agency head shall file the order with the
43 office of administrative hearings, which order shall be final upon filing,
44 and which shall be a final contested case order. The agency head shall also
45 simultaneously serve the parties with a copy of the final order.

46 (9) A party may request a reconsideration by the agency head of an
47 agency review order by filing a request with the agency head within four-
48 teen (14) days of the order. The agency head shall notify the office of
49 administrative hearings promptly upon receipt of such a request for recon-
50 sideration. The request for reconsideration by the agency head shall be

1 procedurally treated as a notice of agency review under this section, and
2 any order previously filed under subsection (8) of this section shall not
3 be considered final until an order denying the request for reconsideration
4 or modifying the previous order is filed with the office of administrative
5 hearings and served upon the parties.

6 SECTION 20. That Chapter 52, Title 67, Idaho Code, be, and the same is
7 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
8 ignated as Section 67-5256, Idaho Code, and to read as follows:

9 67-5256. RECONSIDERATION. (1) A party, not later than fourteen (14)
10 days after the service date of a contested case order, may file a request for
11 reconsideration with the office of administrative hearings that states the
12 specific grounds on which relief is requested.

13 (2) If a request for reconsideration is timely filed, and if the re-
14 quester has complied with procedural rules for reconsideration, the time for
15 filing a request for judicial review does not begin until the hearing officer
16 fully disposes of the request for reconsideration as provided in subsection
17 (3) of this section. Provided that if an agency review is conducted under
18 this section, time for filing a request for judicial review shall be governed
19 by this section. A party is not required to file a request for or notice of
20 agency head review to exhaust remedies under section 67-5265, Idaho Code.

21 (3) Not later than twenty-one (21) days after a request is filed under
22 subsection (1) of this section, the hearing officer shall issue a written or-
23 der denying the request, granting the request and modifying the contested
24 case order, or granting the request and setting the matter for further pro-
25 ceedings. The parties may extend the time by filing a stipulation for exten-
26 sion of time before the expiration of the twenty-one (21) days. If the hear-
27 ing officer fails to act upon the request within the twenty-one (21) days or
28 extension thereof, the request is deemed denied. The tolling under subsec-
29 tion (2) of this section ends on the date the request is deemed denied.

30 SECTION 21. That Chapter 52, Title 67, Idaho Code, be, and the same is

33 67-5257. STAY. Except as otherwise provided by law of this state other
34 than this act, a party, not later than seven (7) days after the service date
35 of the final order, may request the agency to stay a final order pending judi-
36 cial review. The agency may grant the request for a stay pending judicial re-
37 view if the agency finds that justice requires. The agency may grant or deny
38 the request for stay of the order before, on, or after the effective date of
39 the order.

40 SECTION 22. That Chapter 52, Title 67, Idaho Code, be, and the same is
41 hereby amended by the addition thereto of a NEW SECTION, to be known and des-

43 67-5258. AVAILABILITY OF ORDERS -- INDEX -- INDEXING OF GUIDANCE DOC-

45 section, an agency shall create an index of all final orders in contested

1 cases and make the index and all final orders available for public inspection
2 and copying, at cost, in its principal offices.

3 (2) Final orders that are exempt, privileged, or otherwise made confi-
4 dential or protected from disclosure by the public records law of this state
5 are not public records and may not be indexed.

6 (3) An agency may not rely on a final order adverse to a party other than
7 the agency as precedent in future adjudications, unless the agency desig-
8 nates the order as a precedent and the order has been published, placed in an
9 index, and made available for public inspection.

10 (4) Unless otherwise prohibited by any provision of law, each agency
11 shall index by subject all agency guidance documents. The index and the
12 guidance documents shall be available for public inspection and copying at
13 cost in the main office and each regional or district office of the agency.
14 As used in this section, "agency guidance" means all written documents,
15 other than rules, orders, and pre-decisional material, that are intended to
16 guide agency actions affecting the rights or interests of persons outside
17 the agency. "Agency guidance" shall include memoranda, manuals, policy
18 statements, interpretations of law or rules, and other materials that are
19 of general applicability, whether prepared by the agency alone or jointly
20 with other persons. The indexing of a guidance document does not give that
21 document the force and effect of law or other precedential authority.

22 (5) If the index and order or document is publicly available on an
23 agency website, the obligation to provide copies is deemed satisfied.

24 SECTION 23. That Chapter 52, Title 67, Idaho Code, be, and the same is
25 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
26 ignated as Section 67-5259, Idaho Code, and to read as follows:

27 67-5259. LICENSES. (1) If a licensee has made timely and sufficient
28 application for the renewal of a license or a new license for any activity
29 of a continuing nature, the existing license does not expire until the agency
30 takes final action on the application and, if the application is denied or
31 the terms of the new license are limited, until the last day for seeking re-
32 view of the agency order or a later date fixed by the reviewing court.

33 (2) Before an agency institutes proceedings to revoke, suspend, annul
34 or withdraw a license, the agency shall notify the licensee of: (a) the facts
35 or conduct that warrants the intended action; and (b) provide the licensee
36 with any options available to cure deficiencies. The agency shall also give
37 the licensee a reasonable opportunity to show compliance with all lawful re-
38 quirements for the retention of the license.

39 (3) A proceeding to revoke, suspend, annul or withdraw a license is a
40 contested case and shall be commenced in accordance with section 67-5243,
41 Idaho Code.

42 (4) If the agency finds that immediate danger to the public health or
43 safety requires emergency action in connection with continued use of the li-
44 cense by the licensee, an emergency order may be issued in accordance with
45 section 67-5247, Idaho Code, and shall be filed together with a request for a
46 contested case proceeding. The emergency order shall be reviewed in accor-
47 dance with the provisions of section 67-5247, Idaho Code, as part of the con-
48 tested case.

1 (5) A revocation, suspension, annulment, or withdrawal of a license
2 that is in conflict with the provisions of this section shall be null, void
3 and of no force and effect.

4 SECTION 24. That Chapter 52, Title 67, Idaho Code, be, and the same is
5 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
6 ignated as Section 67-5260, Idaho Code, and to read as follows:

7 67-5260. RIGHT TO JUDICIAL REVIEW -- FINAL AGENCY ACTION REVIEW-
8 ABLE. (1) In this section and sections 67-5262 through 67-5267, Idaho Code,
9 "final agency action" means a final order or an agency action that imposes an
10 obligation, grants or denies a right, confers a benefit, or determines a le-
11 gal relationship. The term includes a disposition by agreement as provided
12 in section 67-5241, Idaho Code. The term does not include agency action that
13 is a failure to act unless in the form of a contested case order that is final.

14 (2) Except to the extent that a statute of this state other than this act
15 limits or precludes judicial review, a person who meets the requirements of
16 this section is entitled to judicial review of a final agency action.

17 (3) A person entitled to judicial review of a final agency action under
18 subsection (2) of this section is entitled to judicial review of an agency
19 action that is not final if postponement of judicial review would result in
20 an inadequate remedy or irreparable harm that outweighs the public benefit
21 derived from postponing judicial review.

22 (4) A court may compel an agency to take action that is unlawfully with-
23 held or unreasonably delayed.

26 ignated as Section 67-5262, Idaho Code, and to read as follows:

27 67-5262. TIME TO SEEK JUDICIAL REVIEW OF AGENCY ACTION -- LIMITA-
28 TIONS. (1) A petition for judicial review of a temporary or final rule may be
29 filed at any time, except as limited by section 67-5231, Idaho Code.

30 (2) A petition for judicial review of a final order must be filed within
31 twenty-eight (28) days of the service date of the final order, or, if recon-
32 sideration is sought, within twenty-eight (28) days after the service date
33 of the decision thereon. A cross-petition for judicial review may be filed
34 within fourteen (14) days after a party is served with a copy of the notice of
35 the petition for judicial review.

36 (3) A petition for judicial review of a final agency action other than
37 a rule or final order must be filed within twenty-eight (28) days of the
38 agency action, except as provided by other provision of law. The time for
39 filing a petition for review shall be extended during the pendency of the
40 petitioner's timely attempts to exhaust administrative remedies, if the
41 attempts are clearly not frivolous or repetitious. A cross-petition for ju-
42 dicial review may be filed within fourteen (14) days after a party is served
43 with a copy of the notice of the petition for judicial review.

44 (4) The time for seeking judicial review under this section is tolled
45 during any time a party pursues an administrative remedy before the agency,
46 which remedy must be exhausted as a condition of judicial review.

1 (5) A party may not petition for judicial review while seeking recon-
2 sideration under section 67-5256, Idaho Code. During the time a petition for
3 reconsideration is pending before an agency, the time for seeking judicial
4 review in subsection (1) of this section is tolled.

5 SECTION 26. That Chapter 52, Title 67, Idaho Code, be, and the same is
6 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
7 ignated as Section 67-5263, Idaho Code, and to read as follows:

8 67-5263. STAYS PENDING APPEAL. A petition for judicial review does not
9 automatically stay an agency decision. A challenging party may petition
10 the reviewing court for a stay on the same basis as stays are granted under
11 the Idaho rules of civil procedure, and the reviewing court may grant a stay
12 regardless of whether the challenging party first sought a stay from the
13 agency.

35 a prerequisite for seeking judicial review.

36 (3) The court may relieve a requester of the requirement to exhaust any
37 or all administrative remedies to the extent the administrative remedies are
38 inadequate or the requirement would result in irreparable harm.

2 view is confined to that record and to matters arising from that record.

3 (2) In any case to which subsection (1) of this section does not apply,
4 the record for review consists of the unprivileged materials that the hear-
5 ing officer or agency decision-maker directly or indirectly considered or
6 that were submitted for consideration by any person in connection with the
7 action under review, including information that is adverse to the agency's
8 position. If the agency action was ministerial or was taken on the basis of a
9 minimal or no administrative record, the court may receive evidence relating
10 to the agency's basis for taking the action.

13 low discovery or other evidentiary proceedings and consider evidence out-

26 (h) Monitor the quality of all contested case proceedings, and any
27 other hearings, mediations and arbitrations conducted by the office of
28 administrative hearings;

29 (i) Submit a written report on the activities of the office, the quality
30 of its work, its compliance with the code of conduct, and such other mat-
31 ters as he deems appropriate for the immediately preceding fiscal year
32 to the governor, the judiciary, rules and administration committee of
33 the house of representatives, the judiciary and rules committee of the
34 senate and to the advisory council to the office of administrative hear-
35 ings on or before the first day of each legislative session;

36 (j) As he deems appropriate, create specialized subject matter divi-

39 tious and equitable process, retain independent contractor hearing offi-

5 (3) The chief administrative hearing officer shall receive the same
6 compensation and benefits as a member of the Idaho industrial commission.

7 (4) A chief administrative hearing officer may be removed from office
8 only:

9 (a) By the governor with consent of the senate; or

10 (b) By the governor upon conviction of a felony, or disbarment or sus-
11 pension by the Idaho state bar.

1 (6) Conduct such contested case proceedings pursuant to this chapter,
2 duly promulgated rules, guidelines and practices, as well as other hearings,
3 mediations and arbitration as may be assigned by the chief administrative
4 hearing officer, and perform such other duties as may be assigned by the
5 chief administrative hearing officer.

47 (d) The entry into contracts with service provider agencies within a

1 (e) The development of procedures to monitor services that are provided
2 to infants and toddlers with disabilities and their families;

3 (f) The development of procedures to ensure that services are provided
4 to infants and toddlers with disabilities and their families in a timely
5 manner pending resolution of any disputes among public agencies or ser-
6 vice providers;

7 (g) The writing of all policy and procedures and administrative rules

17 accepted accounting principles, available for the purpose of making
18 loans under this chapter;

19 (c) The applicant has had a license, substantially equivalent to a
20 license under this chapter and issued by any state, denied, revoked or
21 suspended under the law of such state;

22 (d) The applicant has filed an application for a license which is false
23 or misleading with respect to any material fact;

24 (e) The application does not contain all of the information required by
25 the administrator; or

26 (f) The application is not accompanied by an application fee of three
27 hundred fifty dollars (\$350).

28 (2) A licensee under this chapter shall meet the requirements of sub-
29 section (1) of this section at all times while licensed pursuant to this
30 chapter. The administrator is empowered to conduct investigations as he may
31 deem necessary, to enable him to determine the existence of the requirements
32 set out in subsection (1) of this section.

33 (3) Upon written request, the applicant is entitled to a hearing on the
34 question of his qualifications for a license if:

35 (a) The administrator has notified the applicant in writing that his
36 application has been denied, or objections filed; or

37 (b) The administrator has not issued a license within sixty (60) days
38 after the application for the license was filed.

39 If a hearing is held, the applicant and those filing objections shall

36 (b) The fees required to apply for license renewal unless previously
37 paid for the period for which the license renewal applies; and

38 (c) A reinstatement fee of two hundred dollars (\$200).

39 SECTION 49. That Section 28-46-404, Idaho Code, be, and the same is
40 hereby amended to read as follows:

41 28-46-404. APPLICATION FOR PAYDAY LOAN LICENSE. (1) Each application
42 for a license shall be in writing and under oath to the administrator, in a
43 form prescribed by the administrator, and shall include at least the follow-
44 ing:

45 (a) The legal name, residence and business address of the applicant
46 and, if the applicant is an entity, of every member, partner, director,
47 senior officer or twenty-five percent (25%) or more equity owner of the
48 applicant;

1 (b) The location at which the principal place of business of the appli-
2 cant is located; and

3 (c) Other data and information the administrator may require with re-
4 spect to the applicant, and if the applicant is an entity, such data and

32 days of receipt of the deficiency notice. A written deficiency notice shall
33 be deemed received by a license applicant when:

35 address provided by the applicant on the license application; or

2 SECTION 50. That Section 33-5209C, Idaho Code, be, and the same is
3 hereby amended to read as follows:

4 33-5209C. ENFORCEMENT -- REVOCATION -- APPEAL. (1) An authorized
5 chartering entity shall continually monitor the performance and legal com-
6 pliance of the public charter schools it oversees, including collecting and
7 analyzing data to support ongoing evaluation according to the performance
8 certificate. Every authorized chartering entity shall have the authority
9 to conduct or require oversight activities that enable the authorized char-
10 tering entity to fulfill its responsibilities pursuant to the provisions
11 of this chapter, including conducting appropriate inquiries and investiga-
12 tions, ~~se~~ as long as those activities are consistent with the intent of this
13 chapter, adhere to the terms of the performance certificate and do not unduly
14 inhibit the autonomy granted to public charter schools.

15 (2) Each authorized chartering entity shall annually publish and make
16 available to the public a performance report for each public charter school
17 it oversees, in accordance with the performance framework set forth in the
18 performance certificate and section 33-5209A, Idaho Code. The authorized
19 chartering entity may require each public charter school it oversees to sub-
20 mit an annual report to assist the authorized chartering entity in gather-
21 ing complete information about each school consistent with the performance
22 framework. Each public charter school shall publish its annual performance
23 report on the school's website.

24 (3) If an authorized chartering entity has reason to believe that a
25 public charter school cannot remain fiscally sound for the remainder of its
26 certificate term, it shall provide the state department of education with
27 written notification of such concern. Upon receiving such notification,
28 the state department of education shall have the authority to modify the
29 percentage of the total appropriation to be paid to the public charter school
30 pursuant to the provisions of section 33-1009(1), Idaho Code, such that
31 equal percentages are paid on each of the prescribed dates.

32 (4) If an authorized chartering entity has reason to believe that a
33 charter holder or public charter school has violated any provision of law, it
34 shall notify the charter holder and the entity responsible for administering
35 said law of the possible violation.

36 (5) If an authorized chartering entity revokes or does not renew a char-
37 ter, the authorized chartering entity shall clearly state, in a resolution
38 of its governing board, the reasons for the revocation or nonrenewal.

39 (6) Within fourteen (14) days of taking action to renew, not renew or
40 revoke a charter, the authorized chartering entity shall report to the state
41 board of education the action taken and shall provide a copy of the report to
42 the charter holder at the same time that the report is submitted to the state
43 board of education. The report shall include a copy of the authorized char-
44 tering entity's resolution setting forth the action taken and reasons for
45 the decision and assurances as to compliance with all of the requirements set
46 forth in this chapter.

47 (7) A charter may be revoked by the authorized chartering entity if the
48 public charter school has failed to meet any of the specific, written con-
49 ditions for necessary improvements established pursuant to the provisions

1 of section 33-5209B(1), Idaho Code, by the dates specified. Revocation may
 2 not occur until the charter holder has been afforded a public hearing, un-
 3 less the authorized chartering entity determines that the continued opera-
 4 tion of the public charter school presents an imminent public safety issue,
 5 in which case the charter may be revoked immediately. Public hearings shall
 6 be conducted by the authorized chartering entity or such other person or per-
 7 sons appointed by the authorized chartering entity to conduct public hear-
 8 ings and receive evidence as a contested case in accordance with the provi-
 9 sions of ~~section 67-5242~~ chapter 52, title 67, Idaho Code. Notice and oppor-
 10 tunity to reply shall include, at a minimum, written notice setting out the
 11 basis for consideration of revocation, a period of not less than thirty (30)
 12 days within which the charter holder can reply in writing, and a public hear-
 13 ing within thirty (30) days of the receipt of the written reply.

14 (8) A decision to revoke or nonrenew a charter or to deny a revision of
 15 a charter may be appealed directly to the state board of education. With re-
 16 spect to such appeal, the state board of education shall substantially fol-
 17 low the procedure as provided in section 33-5207(5)(b), Idaho Code. In the
 18 event the state board of education reverses a decision of revocation or non-
 19 renewal, the charter holder subject to such action shall then be placed under
 20 the chartering authority of the public charter school commission.

21 SECTION 51. That Section 40-709A, Idaho Code, be, and the same is hereby
 22 amended to read as follows:

23 40-709A. PETITION FOR HIGHWAY MAINTENANCE. (1) Any county or highway
 24 district may petition the Idaho transportation board to take action, as pro-
 25 vided in this section, to provide for the maintenance of a highway or portion
 26 thereof under the jurisdiction of a county or highway district.

27 (2) The petition and supporting materials shall establish the follow-
 28 ing facts:

29 (a) That the subject highway or relevant portion thereof provides the
 30 only practical access to a city, town or other developed area;

31 (b) That the county or highway district with jurisdiction over the sub-
 32 ject highway, or relevant portion thereof, is obligated to maintain the
 33 highway or relevant portion thereof;

34 (c) That said county or highway district historically has provided
 35 maintenance to the subject highway or relevant portion thereof suffi-
 36 cient to allow safe motorist access to the city, town or other developed
 37 area; and

38 (d) Said county or highway district is now failing to provide main-
 39 tenance sufficient to allow safe motorist access to the city, town or
 40 other developed area.

41 The petition shall not be based on failure to improve the highway or to ex-
 42 pand maintenance beyond what historically has been provided. The petition
 43 shall also document the petitioner's efforts to communicate its concerns to
 44 the subject county or highway district and explain why the issue could not be
 45 resolved. The petitioner shall provide notice to the subject county or high-
 46 way district, including a copy of the petition and all supporting materials.

47 (3) The Idaho transportation department shall publish notice of the
 48 petition as set forth in section 40-206, Idaho Code, and shall provide the
 49 subject county or highway district a reasonable opportunity to respond to

1 the petition, to take corrective action, to explain any extenuating cir-
2 cumstances or to otherwise address the concerns presented in the petition.
3 Based on all information available to it, including such independent inves-
4 tigation as it deems appropriate, the Idaho transportation department shall
5 make a recommendation for action to the Idaho transportation board.

6 (4) The Idaho transportation board shall review the petition and the
7 recommendation of the Idaho transportation department.

8 (5) If the Idaho transportation board determines that the petition is
9 without merit, it may deny the petition without hearing and issue written
10 findings and conclusions stating its reasons therefor.

11 (6) If the Idaho transportation board determines that the petition may
12 have merit, it shall hold a hearing on the matter and allow all affected enti-
13 ties and interested persons an opportunity to be heard.

14 (7) Following the hearing provided in subsection (6) of this section,
15 the Idaho transportation board shall either grant or deny the petition and
16 issue findings and conclusions stating its reasons therefor. The petition
17 shall be granted only upon a finding that the public safety, health or wel-
18 fare would be endangered because the subject county or highway district is
19 inappropriately and unreasonably failing to maintain a highway or portion
20 thereof that it is obligated to maintain and that the facts set out in subsec-
21 tion (2) (a), (b), (c) and (d) of this section have been established. In de-
22 termining the reasonableness of the subject county or highway district's ac-
23 tions with respect to the highway, the Idaho transportation board shall take
24 into account the authority of the county or highway district to temporarily
25 close a highway, the availability of funding and other considerations ad-
26 dressed in sections 40-1311 and 40-1315, Idaho Code. The Idaho transporta-
27 tion board shall not approve a petition with respect to a highway or portion
28 thereof that has been vacated or is subject to an ongoing vacation or valida-
29 tion proceeding.

30 (8) If the petition is granted, the transportation department may un-
31 dertake itself the maintenance of the highway or portion thereof or it may
32 contract with another political subdivision to undertake the maintenance.
33 In either case, the transportation department shall certify to the state
34 controller the actual cost of maintenance undertaken by the transportation
35 department or by the contracted political subdivision. The state controller
36 shall pay into the state highway account of the Idaho transportation depart-
37 ment, or directly to the contracted political subdivision, the actual costs
38 incurred as certified by the transportation department. Such funds shall be
39 deducted from the funds that would otherwise have been allocated pursuant to
40 section 40-709, Idaho Code, to the county or highway district that failed to
41 provide adequate maintenance.

42 (9) Political subdivisions that acquire funds for roadwork of any type,
43 either pursuant to this section or by separate voluntary agreement with an-
44 other political subdivision or the state, are hereby authorized to expend
45 such funds outside of their jurisdictional boundaries notwithstanding any
46 other provision of law.

47 (10) A county or highway district that has been the subject of a peti-
48 tion granted pursuant to this section may request a termination or modifi-
49 cation of the arrangement authorized by the Idaho transportation department
50 for maintenance by the Idaho transportation department or another entity. A

1 request for termination shall be accompanied by appropriate documentation
 2 showing that the requesting entity is prepared to resume its maintenance re-
 3 sponsibility for the highway. The Idaho transportation board shall consider
 4 the request for termination or modification, taking into account the infor-
 5 mation presented by the requesting entity and any other information avail-
 6 able to the Idaho transportation board. If the Idaho transportation board
 7 determines that the concerns giving rise to the petition have been addressed
 8 and the entity is committed to resume maintenance of the highway, the Idaho
 9 transportation board shall terminate its prior action and allow the entity
 10 to resume responsibility for maintenance of the highway upon the beginning
 11 of the next fiscal year. The Idaho transportation board may also modify the
 12 existing arrangement for funding of maintenance.

13 (11) A decision by the Idaho transportation board granting or denying a
 14 petition or request under this section is a final agency action for purposes
 15 of section 67-5270(2)~~60~~, Idaho Code.

16 SECTION 52. That Section 41-227, Idaho Code, be, and the same is hereby
 17 amended to read as follows:

18 41-227. EXAMINATION REPORT. (1) The director or his examiner shall
 19 make a full and true written report of every examination made by him under
 20 this chapter, and shall verify the report by his oath.

21 (2) The report shall comprise only facts appearing upon the books, pa-
 22 pers, records or documents of the person being examined, or ascertained from
 23 testimony of individuals under oath concerning the affairs of such person,
 24 together with such conclusions and recommendations as may reasonably be war-
 25 ranted from such facts.

26 (3) Prior to a hearing and prior to any modifications, the report shall
 27 be subject to disclosure according to chapter 1, title 74, Idaho Code.

28 (4) No later than sixty (60) days following completion of the examina-
 29 tion, the examiner in charge shall file with the department a verified writ-
 30 ten report of examination under oath. Upon receipt of the verified report,
 31 the department shall transmit the report to the company examined, together
 32 with a notice which shall afford the company examined a reasonable opportu-
 33 nity of not more than thirty (30) days to make a written submission or rebut-
 34 tal with respect to any matters contained in the examination report.

35 (5) Within thirty (30) days of the end of the period allowed for the re-
 36 ceipt of written submissions or rebuttals, the director shall fully consider
 37 and review the report, together with any written submissions or rebuttals
 38 and any relevant portions of the examiner's work papers, and enter an order:

39 (a) Adopting the examination report as filed or with modifications or
 40 corrections. If the examination report reveals that the company is op-
 41 erating in violation of any law, regulation or prior order of the direc-
 42 tor, the director may order the company to take any action the director
 43 considers necessary and appropriate to cure such violation;

44 (b) Rejecting the examination report with directions to the examiners
 45 to reopen the examination for purposes of obtaining additional data,
 46 documentation or information, and refile pursuant to subsection ~~(2)~~
 47 of this section; or

1 (c) Calling for an investigatory hearing with no less than twenty (20)
2 days' notice to the company for purposes of obtaining additional docu-
3 mentation, data, information and testimony.

4 (6) (a) All orders entered pursuant to subsection (5) (a) of this sec-
5 tion shall be accompanied by findings and conclusions resulting from
6 the director's consideration and review of the examination report, rel-
7 evant examiner work papers and any written submissions or rebuttals.
8 Any such order shall be considered a final order and may be appealed
9 pursuant to sections 67-5270~~60~~⁶⁰ through 67-5279~~69~~⁶⁹, Idaho Code, and shall
10 be served upon the company by certified mail, together with a copy of the
11 adopted examination report. Within thirty (30) days of the issuance of
12 the adopted report, the company shall file affidavits executed by each
13 of its directors stating under oath that they have received a copy of the
14 adopted report and related orders.

15 (b) Any hearing conducted under subsection (5) (c) of this section by
16 the director or authorized representative, shall be conducted in accord-
17 dance with the provisions of chapter 52, title 67, Idaho Code, as a non-
18 adversarial confidential investigatory proceeding as necessary for the
19 resolution of any inconsistencies, discrepancies or disputed issues
20 apparent upon the face of the filed examination report or raised by, or
21 as a result of, the director's review of relevant work papers or by the
22 written submission or rebuttal of the company. Within twenty (20) days
23 of the conclusion of any such hearing, the director shall enter an order
24 pursuant to the provisions of subsection (5) (a) of this section.

25 (c) The director shall not appoint a contract examiner or an employee of
26 the department as an authorized representative to conduct the hearing.
27 Nothing contained in this section shall require the department to dis-
28 close any information or records which would indicate or show the con-
29 tent of any investigation or activity of a criminal justice agency, ex-
30 cept to the extent that the director relied upon information furnished
31 to the director by such criminal justice agency in making his decision.

32 (7) The report when so verified and filed shall be admissible in evi-
33 dence in any action or proceeding brought by the director against the person
34 examined, or against its officers, employees or agents, and shall be pre-
35 sumptive evidence of the material facts stated therein. The director or his
36 examiners may at any time testify and offer other proper evidence as to in-
37 formation secured or matters discovered during the course of an examination,
38 whether or not a written report of the examination has been either made, fur-
39 nished or filed in the department.

40 (8) After an order is entered under the provisions of subsection (5) (a)
41 of this section, the director may publish the report or the results of the
42 examination as contained therein which report or results are a public record
43 and shall be exempt from the exemptions from disclosure provided in chapter
44 1, title 74, Idaho Code.

45 (9) Nothing contained in this chapter shall prevent or be construed
46 as prohibiting the director from disclosing the content of an examination
47 report, preliminary examination report or results, or any matter relating
48 thereto, to the insurance department of this or any other state or country,
49 or to law enforcement officials of this or any other state or agency of the
50 federal government at any time, so long as the agency or office receiving the

1 report or matters relating thereto agrees in writing to hold it confidential
2 and in a manner consistent with this chapter.

3 (10) All working papers, recorded information, documents and copies
4 thereof produced by, obtained by or disclosed to the director or any other
5 person in the course of an examination made under the provisions of this
6 chapter shall be made available to the person or company which was the sub-
7 ject of the examination in proceedings pursuant to chapter 52, title 67,
8 Idaho Code, but shall otherwise be held by the director as a record not re-
9 quired to be made public pursuant to exemptions from disclosure provided in
10 chapter 1, title 74, Idaho Code.

11 SECTION 53. That Section 47-328, Idaho Code, be, and the same is hereby
12 amended to read as follows:

13 47-328. RULES FOR COMMISSION -- ADMINISTRATIVE PROCEDURES. (1) The
14 commission shall have authority to hear rulemaking proceedings, complaints
15 filed with it pursuant to this chapter and appeals from the oil and gas ad-
16 ministrators decision on an application filed pursuant to this chapter, and
17 any other matter the commission decides should be heard by the commission.
18 The commission may act on its own motion. The commission may prescribe rules
19 governing the procedure before it, subject to the provisions of the adminis-
20 trative procedure act, chapter 52, title 67, Idaho Code. Provided however,
21 that no rulemaking except for that done under section 67-5226, Idaho Code,
22 may be conducted for twelve (12) months beginning on July 1, 2017.

23 (2) In all cases where a complaint is made by the commission or any per-
24 son that any provision of this act or any rule or order of the commission
25 is being violated, the commission shall serve notice of any hearing to be
26 held on such application or complaint to the interested persons by certified
27 mail, return receipt requested, or in the same manner as is provided in the
28 rules of civil procedure for the service of summons in civil actions. Where
29 the interested person is unknown or cannot be located, the commission shall
30 serve notice by publishing at least one (1) notice of the hearing to such per-
31 son in a newspaper of general circulation in the county where the affected
32 tract is located. Such notice must be sent, delivered or published, as ap-
33 propriate, at least five (5) business days before the date of the hearing.

34 (3) Except as provided in section 47-316(1)(a), Idaho Code, and sub-
35 section (2) of this section, any request for an order related to oil and gas
36 activities within the commission's jurisdiction, other than a civil penalty
37 proceeding pursuant to section 47-329, Idaho Code, or other enforcement ac-
38 tion by the department of lands or the commission, shall be made by applica-
39 tion to the department of lands and processed as provided in this section.

40 (a) The department shall notify the applicant within five (5) business
41 days of receipt of an application if additional information is required
42 for the department to evaluate the application.

43 (b) For applications involving an order regarding unit operations or
44 integration of a drilling unit, the applicant shall send a copy of the
45 application and supporting documents to all known and located uncommit-
46 ted owners, to all working interest owners within the unit, and to the
47 respective city or county where the proposed unit is located. The mail-
48 ing shall be sent by certified mail within seven (7) calendar days of
49 filing the application and include notice of the hearing date on which

1 the oil and gas administrator will consider the application. For any
2 uncommitted owners and working interest owners who cannot be located,
3 an applicant shall publish notice of any application for an order, no-
4 tice of hearing and response deadline once in a newspaper of general
5 circulation in the county in which the affected property is located and
6 request the department publish notice on its website within seven (7)
7 calendar days of filing of the application. Only an uncommitted owner
8 in the affected unit may file an objection or other response to the ap-
9 plication, and the uncommitted owner shall file at least fourteen (14)
10 calendar days before the hearing date provided in the notice.

11 (c) For applications not involving paragraph (b) of this subsection,
12 the department and any uncommitted owner within the area defined in the
13 application may file objections or other responses to the application
14 and shall file at least fourteen (14) calendar days before the hearing
15 date provided in the notice.

16 (d) The oil and gas administrator shall hear the application and make
17 a decision on the application's merits. The oil and gas administrator
18 shall set regular hearing dates. Applications shall be filed at least
19 forty-five (45) calendar days before a desired hearing date. Untimely
20 applications shall be continued until the next hearing. The oil and gas
21 administrator may for good cause continue any hearing. The oil and gas
22 administrator may appoint a hearing officer, who shall have the power
23 and authority to conduct hearings. Discovery is not permitted. The de-
24 partment may appear and testify at the hearing. When applications are
25 uncontested, the applicant may request, and the oil and gas administra-
26 tor may allow, approval without a hearing based on review of the merits
27 of a verified application and the supporting exhibits.

28 (e) The oil and gas administrator shall issue a written decision on any
29 such application within thirty (30) calendar days of the hearing. The
30 oil and gas administrator's decision shall not be subject to any motion
31 for reconsideration or further review, except for appeal to the commis-
32 sion provided in subsection (4) of this section.

33 (4) The oil and gas administrator's decision on an application or a re-
34 quest for an order may be appealed to the commission by the applicant or any
35 owner who filed an objection or other response to the application within the
36 time required. An appeal must be filed with the oil and gas administrator
37 within fourteen (14) calendar days of the date of issuance of the oil and
38 gas administrator's written decision. The date of issuance shall be three
39 (3) calendar days after the oil and gas administrator deposits the decision
40 in the U.S. mail, or the date on which he remits a decision electronically.
41 Such appeal shall include the reasons and authority for the appeal and shall
42 identify any facts in the record supporting the appeal. Any person appeal-
43 ing shall serve a copy of the appeal materials on any other person who par-
44 ticipated in the proceedings, by certified mail, or by personal service. Any
45 person who participated in the proceeding may file a response to the appeal
46 within five (5) business days of service of a copy of the appeal materials.
47 The appellant shall provide the oil and gas administrator with proof of ser-
48 vice of the appeal materials on other persons as required in this section.
49 The commission shall make a decision based on the record as set forth in the
50 written submittals of only the appellant and any other participating quali-

1 fied person, the oil and gas administrator's decision, and any oral argument
2 taken by the commission at an appeal hearing.

3 (5) Appeals to the commission shall be heard at the next regularly
4 scheduled commission hearing, or at a special meeting of the commission if
5 determined by the commission. In no case will a hearing be later than thirty
6 (30) calendar days after the filing of an appeal. The commission may take
7 argument from, but not new testimony of, the appellant and other qualified
8 participating persons at the hearing. The commission shall make a deci-
9 sion on the appeal at the hearing and issue a written order within five (5)
10 business days of the hearing. The prevailing party shall draft a proposed
11 written order and submit it within two (2) business days. The final order of
12 the commission shall not be subject to any motion for reconsideration.

13 (6) If no appeal is filed with the commission within the required time,
14 the decision of the oil and gas administrator shall become the final order.

15 (7) Judicial review of actions taken by the commission shall be gov-
16 erned by the provisions of chapter 52, title 67, Idaho Code.

17 (8) For an application or request for an order submitted under subsec-
18 tion (3) of this section, only a person qualified under subsection (4) of
19 this section who has completed the appeal procedures set forth in this sec-
20 tion shall be considered to have exhausted administrative remedies as re-
21 quired in section 67-527165, Idaho Code.

22 (9) Each order shall include a reasoned statement in support of the
23 decision, including a concise statement of facts supporting any findings,
24 a statement of available procedures and time limits for appeals. Findings
25 must be based exclusively on materials in the record. The applicant and any
26 participating qualified person shall be served with a copy of the order. The
27 order shall include or be accompanied by a certificate of service.

28 (10) Every application shall be signed by the applicant or his represen-
29 tative, and his address shall be stated thereon. The signature of the ap-
30 plicant or his representative constitutes a certificate by him that he has
31 read the application and that to the best of his knowledge, information and
32 belief there is good ground to support the same. Each application shall be
33 of such form and content and accompanied by the number of copies required by
34 rule of the commission. Each application shall be accompanied by a fee as es-
35 tablished in statute or rule.

36 SECTION 54. That Section 50-222, Idaho Code, be, and the same is hereby
37 amended to read as follows:

38 50-222. ANNEXATION BY CITIES. (1) Legislative intent. The legisla-
39 ture hereby declares and determines that it is the policy of the state of
40 Idaho that cities of the state should be able to annex lands which are reason-
41 ably necessary to assure the orderly development of Idaho's cities in order
42 to allow efficient and economically viable provision of tax-supported and
43 fee-supported municipal services, to enable the orderly development of pri-
44 vate lands which benefit from the cost-effective availability of municipal
45 services in urbanizing areas and to equitably allocate the costs of public
46 services in management of development on the urban fringe.

47 (2) General authority. Cities have the authority to annex land into a
48 city upon compliance with the procedures required in this section. In any
49 annexation proceeding, all portions of highways lying wholly or partially

1 within an area to be annexed shall be included within the area annexed unless
 2 expressly agreed between the annexing city and the governing board of the
 3 highway agency providing road maintenance at the time of annexation. Pro-
 4 vided further, that said city council shall not have the power to declare
 5 such land, lots or blocks a part of said city if they will be connected to such
 6 city only by a shoestring or strip of land which comprises a railroad or high-
 7 way right-of-way.

8 (3) Annexation classifications. Annexations shall be classified and
 9 processed according to the standards for each respective category set forth
 10 herein. The three (3) categories of annexation are:

11 (a) Category A: Annexations wherein:

12 (i) All private landowners have consented to annexation. Annex-
 13 ation where all landowners have consented may extend beyond the
 14 city area of impact provided that the land is contiguous to the
 15 city and that the comprehensive plan includes the area of annexa-
 16 tion;

17 (ii) Any residential enclaved lands of less than one hundred (100)
 18 privately-owned parcels, irrespective of surface area, which are
 19 surrounded on all sides by land within a city or which are bounded
 20 on all sides by lands within a city and by the boundary of the
 21 city's area of impact; or

22 (iii) The lands are those for which owner approval must be given
 23 pursuant to subsection (5) (b) (v) of this section.

24 (b) Category B: Annexations wherein:

25 (i) The subject lands contain less than one hundred (100) sepa-
 26 rate private ownerships and platted lots of record and where not
 27 all such landowners have consented to annexation; or

28 (ii) The subject lands contain more than one hundred (100) sepa-
 29 rate private ownerships and platted lots of record and where
 30 landowners owning more than fifty percent (50%) of the area of the
 31 subject private lands have consented to annexation prior to the
 32 commencement of the annexation process; or

33 (iii) The lands are the subject of a development moratorium or a
 34 water or sewer connection restriction imposed by state or local
 35 health or environmental agencies; provided such lands shall not be
 36 counted for purposes of determining the number of separate private
 37 ownerships and platted lots of record aggregated to determine the
 38 appropriate category.

39 (c) Category C: Annexations wherein the subject lands contain more
 40 than one hundred (100) separate private ownerships and platted lots of
 41 record and where landowners owning more than fifty percent (50%) of the
 42 area of the subject private lands have not consented to annexation prior
 43 to commencement of the annexation process.

44 (4) (a) Evidence of consent to annexation. For purposes of this sec-
 45 tion, and unless excepted in paragraph (b) of this subsection (4),
 46 consent to annex shall be valid only when evidenced by written instru-
 47 ment consenting to annexation executed by the owner or the owner's
 48 authorized agent. Written consent to annex lands must be recorded in
 49 the county recorder's office to be binding upon subsequent purchasers,
 50 heirs, or assigns of lands addressed in the consent. Lands need not be

1 contiguous or adjacent to the city limits at the time the landowner con-
2 sents to annexation for the property to be subject to a valid consent to
3 annex; provided however, no annexation of lands shall occur, irrespec-
4 tive of consent, until such land becomes contiguous or adjacent to such
5 city.

6 (b) Exceptions to the requirement of written consent to annexation.
7 The following exceptions apply to the requirement of written consent to
8 annexation provided for in subsection (4) (a) of this section:

9 (i) Enclaved lands: In category A annexations, no consent is nec-
10 essary for enclaved lands meeting the requirements of subsection
11 (3) (a) (ii) of this section;

12 (ii) Implied consent: In category B and C annexations, valid con-
13 sent to annex is implied for the area of all lands connected to a
14 water or wastewater collection system operated by the city if the
15 connection was requested in writing by the owner, or the owner's
16 authorized agent, or completed before July 1, 2008.

17 (5) Annexation procedures. Annexation of lands into a city shall fol-
18 low the procedures applicable to the category of lands as established by this
19 section. The implementation of any annexation proposal wherein the city
20 council determines that annexation is appropriate shall be concluded with
21 the passage of an ordinance of annexation.

22 (a) Procedures for category A annexations: Lands lying contiguous or
23 adjacent to any city in the state of Idaho may be annexed by the city
24 if the proposed annexation meets the requirements of category A. Upon
25 determining that a proposed annexation meets such requirements, a city
26 may initiate the planning and zoning procedures set forth in chapter 65,
27 title 67, Idaho Code, to establish the comprehensive planning policies,
28 where necessary, and zoning classification of the lands to be annexed.

29 (b) Procedures for category B annexations: A city may annex lands that
30 would qualify under the requirements of category B annexation if the
31 following requirements are met:

32 (i) The lands are contiguous or adjacent to the city and lie
33 within the city's area of city impact;

34 (ii) The land is laid off into lots or blocks containing not more
35 than five (5) acres of land each, whether the same shall have been
36 or shall be laid off, subdivided or platted in accordance with any
37 statute of this state or otherwise, or whenever the owner or pro-
38 prietor or any person by or with his authority has sold or begun to
39 sell off such contiguous or adjacent lands by metes and bounds in
40 tracts not exceeding five (5) acres, or whenever the land is sur-
41 rounded by the city. Splits of ownership which occurred prior to
42 January 1, 1975, and which were the result of placement of public
43 utilities, public roads or highways, or railroad lines through the
44 property shall not be considered as evidence of an intent to de-
45 velop such land and shall not be sufficient evidence that the land
46 has been laid off or subdivided in lots or blocks. A single sale
47 after January 1, 1975, of five (5) acres or less to a family mem-
48 ber of the owner for the purpose of constructing a residence shall
49 not constitute a sale within the meaning of this section. For pur-
50 poses of this section, "family member" means a natural person or

1 the spouse of a natural person who is related to the owner by blood,
2 adoption or marriage within the first degree of consanguinity;

3 (iii) Preparation and publication of a written annexation plan,
4 appropriate to the scale of the annexation contemplated, which in-
5 cludes, at a minimum, the following elements:

6 (A) The manner of providing tax-supported municipal ser-
7 vices to the lands proposed to be annexed;

8 (B) The changes in taxation and other costs, using examples,
9 which would result if the subject lands were to be annexed;

10 (C) The means of providing fee-supported municipal ser-
11 vices, if any, to the lands proposed to be annexed;

12 (D) A brief analysis of the potential effects of annexation
13 upon other units of local government which currently provide
14 tax-supported or fee-supported services to the lands pro-
15 posed to be annexed; and

16 (E) The proposed future land use plan and zoning designation
17 or designations, subject to public hearing, for the lands
18 proposed to be annexed;

19 (iv) Compliance with the notice and hearing procedures governing
20 a zoning district boundary change as set forth in section 67-6511,
21 Idaho Code, on the question of whether the property should be
22 annexed and, if annexed, the zoning designation to be applied
23 thereto; provided however, the initial notice of public hearing
24 concerning the question of annexation and zoning shall be pub-
25 lished in the official newspaper of the city and mailed by first
26 class mail to every property owner with lands included in such
27 annexation proposal not less than twenty-eight (28) days prior
28 to the initial public hearing. All public hearing notices shall
29 establish a time and procedure by which comments concerning the
30 proposed annexation may be received in writing and heard and,
31 additionally, public hearing notices delivered by mail shall in-
32 clude a one (1) page summary of the contents of the city's proposed
33 annexation plan and shall provide information regarding where the
34 annexation plan may be obtained without charge by any property
35 owner whose property would be subject to the annexation proposal.

36 (v) In addition to the standards set forth elsewhere in this sec-
37 tion, annexation of the following lands must meet the following
38 requirements:

39 (A) Property, owned by a county or any entity within the
40 county, that is used as a fairgrounds area under the pro-
41 visions of chapter 8, title 31, Idaho Code, or chapter 2,
42 title 22, Idaho Code, must have the consent of a majority of
43 the board of county commissioners of the county in which the
44 property lies; and

45 (B) Property, owned by a nongovernmental entity, that is
46 used to provide outdoor recreational activities to the pub-
47 lic and that has been designated as a planned unit develop-
48 ment of fifty (50) acres or more and does not require or uti-
49 lize any city services must have the express written permis-
50 sion of the nongovernmental entity owner.

1 (vi) After considering the written and oral comments of property
2 owners whose land would be annexed and other affected persons,
3 the city council may proceed with the enactment of an ordinance
4 of annexation and zoning. In the course of the consideration of
5 any such ordinance, the city must make express findings, to be set
6 forth in the minutes of the city council meeting at which the an-
7 nexation is approved, as follows:

8 (A) The land to be annexed meets the applicable requirements
9 of this section and does not fall within the exceptions or
10 conditional exceptions contained in this section;

11 (B) The annexation would be consistent with the public pur-
12 poses addressed in the annexation plan prepared by the city;

13 (C) The annexation is reasonably necessary for the orderly
14 development of the city;

15 (vii) Notwithstanding any other provision of this section, rail-
16 road right-of-way property may be annexed pursuant to this sec-
17 tion only when property within the city adjoins or will adjoin both
18 sides of the right-of-way.

19 (c) Procedures for category C annexations: A city may annex lands that
20 would qualify under the requirements of category C annexation if the
21 following requirements are met:

22 (i) Compliance with the procedures governing category B annexa-
23 tions; and

24 (ii) Evidence of consent to annexation based upon the following
25 procedures:

26 (A) Following completion of all procedures required for
27 consideration of a category B annexation, but prior to en-
28 actment of an annexation ordinance and upon an affirmative
29 action by the city council, the city shall mail notice to
30 all private landowners owning lands within the area to be
31 annexed, exclusive of the owners of lands that are subject
32 to a consent to annex which complies with subsection (4) (a)
33 of this section defining consent. Such notice shall invite
34 property owners to give written consent to the annexation,
35 include a description of how that consent can be made and
36 where it can be filed, and inform the landowners where the
37 entire record of the subject annexation may be examined.
38 Such mailed notice shall also include a legal description of
39 the lands proposed for annexation and a simple map depicting
40 the location of the subject lands.

41 (B) Each landowner desiring to consent to the proposed an-
42 nexation must submit the consent in writing to the city clerk
43 by a date specified in the notice, which date shall not be
44 later than forty-five (45) days after the date of the mailing
45 of such notice.

46 (C) After the date specified in the notice for receipt of
47 written consent, the city clerk shall compile and present
48 to the city council a report setting forth: (i) the total
49 physical area sought to be annexed, and (ii) the total phys-
50 ical area of the lands, as expressed in acres or square feet,

1 whose owners have newly consented in writing to the annexa-
2 tion, plus the area of all lands subject to a prior consent to
3 annex which complies with subsection (4) (a) of this section
4 defining consent. The clerk shall immediately report the
5 results to the city council.

6 (D) Upon receiving such report, the city council shall re-
7 view the results and may thereafter confirm whether consent
8 was received from the owners of a majority of the land. The
9 results of the report shall be reflected in the minutes of
10 the city council. If the report as accepted by the city coun-
11 cil confirms that owners of a majority of the land area have
12 consented to annexation, the city council may enact an ordi-
13 nance of annexation, which thereafter shall be published and
14 become effective according to the terms of the ordinance.
15 If the report confirms that owners of a majority of the land
16 area have not consented to the annexation, the category C
17 annexation shall not be authorized.

18 (6) The decision of a city council to annex and zone lands as a category
19 B or category C annexation shall be subject to judicial review in accordance
20 with the procedures provided in chapter 52, title 67, Idaho Code, and pur-
21 suant to the standards set forth in section 67-5279~~67~~, Idaho Code. Any such
22 appeal shall be filed by an affected person in the appropriate district court
23 no later than twenty-eight (28) days after the date of publication of the an-
24 nexation ordinance. All cases in which there may arise a question of the va-
25 lidity of any annexation under this section shall be advanced as a matter of
26 immediate public interest and concern, and shall be heard by the district
27 court at the earliest practicable time.

28 (7) Annexation of noncontiguous municipal airfield. A city may annex
29 land that is not contiguous to the city and is occupied by a municipally owned
30 or operated airport or landing field. However, a city may not annex any other
31 land adjacent to such noncontiguous facilities which is not otherwise annex-
32 able pursuant to this section.

33 SECTION 55. That Section 54-2509, Idaho Code, be, and the same is hereby
34 amended to read as follows:

35 54-2509. PENALTY FOR VIOLATIONS OF LAW -- POWER OF COMMISSION. (1) Any
36 person holding a race meet, and any other person required by this act or the
37 rules of the commission to be licensed, participating, directly or indi-
38 rectly, in a race meet, without first being licensed by the commission, and
39 any person violating any of the terms or provisions of this act is guilty of a
40 misdemeanor.

41 (a) There shall be an absolute prohibition of the use of live lures in
42 the state of Idaho for the training of or racing of racing dogs. Any
43 violation of the provisions of this section shall be a felony punish-
44 able by a fine not exceeding twenty-five thousand dollars (\$25,000),
45 or by a prison term not to exceed seven (7) years, or by both such fine
46 and imprisonment. In addition the state racing commission shall not
47 license any breeder, trainer or kennel whose dogs have been trained or
48 raced with the use of live lures. The Idaho state racing commission

1 shall adopt rules that will provide for the humane treatment of the dogs
2 involved in any aspect of training for or engaging in dog racing.

3 (2) The commission shall have the power to exclude from any and all race
4 courses in this state any person who the commission deems detrimental to the
5 best interests of racing, or any person who violates any of the provisions of
6 this act or any rule or order of the commission.

7 (3) It shall be lawful to conduct race meets on or at a race track, or
8 otherwise, at any time during the week.

9 (4) Any person maintaining a license issued by the commission, who vio-
10 lates the provisions of this act or the rules of the commission, may have such
11 license suspended or revoked. In addition to such suspension or revocation
12 the commission may levy a monetary penalty commensurate with the gravity of
13 the offense, not to exceed two thousand five hundred dollars (\$2,500). The
14 commission, by rule shall provide a summary procedure for such determination
15 at the track, the penalty amount for specified violations, and shall provide
16 for an appeal of any summary decision to the commission. At-the-track sum-
17 mary proceedings shall not be subject to the provisions of chapter 52, ti-
18 tle 67, Idaho Code. Hearings and appeals before the commission as allowed by
19 this act or the rules of the commission shall be subject to chapter 52, ti-
20 tle 67, Idaho Code, except the provisions of section ~~67-5254(2)~~59(1), Idaho
21 Code, which is inconsistent with the unique requirements of racing.

22 (5) All law enforcement officers in this state shall assist in the en-
23 forcement of this act and the rules of the commission.

24 SECTION 56. That Section 56-133, Idaho Code, be, and the same is hereby
25 repealed.

26 SECTION 57. That Chapter 1, Title 56, Idaho Code, be, and the same is
27 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
28 ignated as Section 56-133, Idaho Code, and to read as follows:

29 56-133. ADMINISTRATIVE APPEALS. Administrative appeals shall be han-
30 dled in accordance with chapter 52, title 67, Idaho Code.

31 SECTION 58. That Section 56-202, Idaho Code, be, and the same is hereby
32 amended to read as follows:

33 56-202. DUTIES OF DIRECTOR OF STATE DEPARTMENT OF HEALTH AND WEL-
34 FARE. The director of the state department of health and welfare shall:

35 (a) Administer public assistance and social services to eligible peo-
36 ple;

37 (b) Promulgate, adopt and enforce such rules and such methods of admin-
38 istration as may be necessary or proper to carry out the provisions of title
39 56, Idaho Code, except as provided in section 56-203A, Idaho Code;

40 (c) Conduct research and compile statistics relating to public wel-
41 fare;

42 (d) Prepare for the governor and legislature an annual report of activ-
43 ities and expenditures; make such reports in such form and containing such
44 information as the federal government may from time to time require; and com-
45 ply with such provisions as the federal government may from time to time find
46 necessary to assure the correctness and verification of such reports;

1 (e) Cooperate with the federal government through its appropriate
2 agency or instrumentality in establishing, extending, and strengthening
3 services for the protection and care of homeless, dependent, and neglected
4 children, and for children in danger of becoming delinquent; and to under-
5 take other services for children authorized by law;

6 (f) Cooperate with the federal government through its appropriate
7 agency or instrumentality in establishing and maintaining a comprehensive
8 system of in-home services as defined in section 67-5006, Idaho Code, de-
9 signed to assist older persons, as defined in section 67-5006, Idaho Code,
10 of Idaho to continue living in an independent and dignified home environment
11 and to undertake other services for older persons as authorized by law;

12 (g) Exercise the opt-out provision in section 115 of the personal re-
13 sponsibility and work opportunity reconciliation act of 1996, P.L. 104-193.
14 Consistent with this, the department may provide food stamps and services
15 funded under title 4A (including cash assistance, TANF supportive services
16 and at-risk payments) to a person who has been convicted of a felony involv-
17 ing a controlled substance as defined in chapter 27, title 37, Idaho Code, if
18 ~~they comply~~ the person complies with the terms of a withheld judgment, proba-
19 tion or parole.

20 Nothing in this section shall exempt the department of health and welfare
21 from complying with the requirements of chapter 52, title 67, Idaho Code.

22 SECTION 59. That Section [56-216](#), Idaho Code, be, and the same is hereby
23 repealed.

24 SECTION 60. That Chapter 2, Title 56, Idaho Code, be, and the same is
25 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
26 ignated as Section 56-216, Idaho Code, and to read as follows:

27 56-216. ADMINISTRATIVE APPEALS. Administrative appeals shall be han-
28 dled in accordance with chapter 52, title 67, Idaho Code.

29 SECTION 61. That Section 56-1003, Idaho Code, be, and the same is hereby
30 amended to read as follows:

31 56-1003. POWERS AND DUTIES OF THE DIRECTOR. The director shall have
32 the following powers and duties:

33 (1) All of the powers and duties of the department of public health, the
34 department of health, the board of health and all nonenvironmental protec-
35 tion duties of the department of health and welfare are hereby vested to the
36 director of the department of health and welfare. Provided however, that
37 oversight of the department and rulemaking and hearing functions relating
38 to public health and licensure and certification standards shall be vested
39 in the board of health and welfare. Except when the authority is vested in
40 the board of health and welfare under law, the director shall have all such
41 powers and duties as may have been or could have been exercised by his pre-
42 decessors in law, including the authority to adopt, promulgate, and enforce
43 rules, and shall be the successor in law to all contractual obligations en-
44 tered into by predecessors in law. All rulemaking proceedings and hearings
45 of the director shall be governed by the provisions of chapter 52, title 67,
46 Idaho Code.

1 (2) The director shall, pursuant and subject to the provisions of the
2 Idaho Code, and the provisions of this chapter, formulate and recommend to
3 the board rules, codes and standards, as may be necessary to deal with prob-
4 lems related to personal health, and licensure and certification require-
5 ments pertinent thereto, which shall, upon adoption by the board, have the
6 force of law relating to any purpose which may be necessary and feasible for
7 enforcing the provisions of this chapter including, but not limited to, the
8 maintenance and protection of personal health. Any such rule or standard may
9 be of general application throughout the state or may be limited as to times,
10 places, circumstances or conditions in order to make due allowance for vari-
11 ations therein.

12 (3) The director, under the rules, codes or standards adopted by him,
13 shall have the general supervision of the promotion and protection of the
14 life, health and mental health of the people of this state. The powers and
15 duties of the director shall include, but not be limited to, the following:

16 (a) The issuance of licenses and permits as prescribed by law and by the
17 rules of the board;

18 (b) The supervision and administration of laboratories and the super-
19 vision and administration of standards of tests for environmental pol-
20 lution, chemical analyses and communicable diseases. The director may
21 require that laboratories operated by any city, county, institution,
22 person, firm or corporation for health or environmental purposes con-
23 form to standards set by the board of health and welfare and the board of
24 environmental quality;

25 (c) The supervision and administration of a mental health program,
26 which shall include services for the evaluation, screening, custody and
27 treatment of the mentally ill and those persons suffering from a mental
28 defect or mental defects, and services for the prevention of suicide;

29 (d) The enforcement of minimum standards of health, safety and sanita-
30 tion for all public swimming pools within the state;

31 (e) The supervision and administration of the various schools, hos-
32 pitals and institutions that were the responsibility of the board of
33 health;

34 (f) The supervision and administration of services dealing with the
35 problems of alcoholism including, but not limited to, the care and reha-
36 bilitation of persons suffering from alcoholism;

37 (g) The establishment of liaison with other governmental departments,
38 agencies and boards in order to effectively assist other governmental
39 entities with the planning for the control of or abatement of health
40 problems. All of the rules and standards adopted by the board shall
41 apply to state institutions;

42 (h) The supervision and administration of an emergency medical service
43 program including, but not limited to, assisting other governmental
44 agencies and local governmental units, in providing first aid emergency
45 medical services and for transportation of the sick and injured;

46 (i) The supervision and administration of administrative units whose
47 responsibility shall be to assist and encourage counties, cities, other
48 governmental units, and industries in the control of and/or abatement
49 of health problems; and

1 (j) The enforcement of all laws, rules, codes and standards relating to
2 health.

3 (4) The director, when so designated by the governor, shall have the
4 power to apply for, receive on behalf of the state, and utilize any federal
5 aid, grants, gifts, gratuities, or moneys made available through the federal
6 government.

7 (5) The director shall have the power to enter into and make contracts
8 and agreements with any public agencies or municipal corporations for fa-
9 cilities, land, and equipment when such use will have a beneficial, recre-
10 ational, or therapeutic effect or be in the best interest in carrying out the
11 duties imposed upon the department.

12 The director shall also have the power to enter into contracts for the
13 expenditure of state matching funds for local purposes. This subsection
14 will constitute the authority for public agencies or municipal corporations
15 to enter into such contracts and expend money for the purposes delineated in
16 such contracts.

17 (6) The director is authorized to adopt an official seal to be used on
18 appropriate occasions, in connection with the functions of the department or
19 the board, and such seal shall be judicially noticed. Copies of any books,
20 records, papers and other documents in the department shall be admitted in
21 evidence equally with the originals thereof when authenticated under such
22 seal.

23 (7) The director, under rules adopted by the board of health and wel-
24 fare, shall have the power to impose and enforce orders of isolation and
25 quarantine to protect the public from the spread of infectious or communi-
26 cable diseases or from contamination from chemical or biological agents,
27 whether naturally occurring or propagated by criminal or terrorist act.

28 (a) An order of isolation or quarantine issued pursuant to this section
29 shall be a final agency action for purposes of judicial review. How-
30 ever, this shall not prevent the director from reconsidering, amend-
31 ing or withdrawing the order. Judicial review of orders of isolation or
32 quarantine shall be de novo. The court may affirm, reverse or modify the
33 order and shall affirm the order if it appears by a preponderance of the
34 evidence that the order is reasonably necessary to protect the public
35 from a substantial and immediate danger of the spread of an infectious
36 or communicable disease or from contamination by a chemical or biologi-
37 cal agent.

38 (b) If the director has reasonable cause to believe a chemical or bi-
39 ological agent has been released in an identifiable place, including a
40 building or structure, an order of quarantine may be imposed to prevent
41 the movement of persons into or out of that place, for a limited period
42 of time, for the purpose of determining whether a person or persons at
43 that place have been contaminated with a chemical or biological agent
44 which may create a substantial and immediate danger to the public.

45 (c) Any person who violates an order of isolation or quarantine shall be
46 guilty of a misdemeanor.

47 (8) The director shall develop safeguards necessary to ensure the se-
48 curity of nonpublic personal information in the department's possession and
49 to prevent undue disclosure of such information. The director shall estab-
50 lish a process to authenticate requests made by a person, entity or jurisdic-

1 tion arising under the 2007 Hague Convention on the International Recovery of
 2 of Child Support and Other Forms of Family Maintenance. In the event the de-
 3 partment becomes aware of any improper disclosure, the director shall take
 4 all actions required under section 28-51-105, Idaho Code.

5 Nothing in this section shall exempt the department of health and wel-
 6 fare from complying with the requirements of chapter 52, title 67, Idaho
 7 Code.

8 SECTION 62. That Section 56-1005, Idaho Code, be, and the same is hereby
 9 amended to read as follows:

10 56-1005. BOARD -- COMPOSITION -- OFFICERS -- COMPENSATION -- POWERS --
 11 SUBPOENA -- DEPOSITIONS -- REVIEW -- RULES. (1) The board of health and wel-
 12 fare shall consist of eleven (11) members, seven (7) members ~~of which~~ who
 13 shall be appointed by the governor, with the advice and consent of the sen-
 14 ate. The members appointed by the governor may be removed by the governor for
 15 cause. Each member of the board appointed by the governor shall be a citizen
 16 of the United States, a resident of the state of Idaho, and a qualified elec-
 17 tor. Not more than four (4) members of the board appointed by the governor
 18 shall be from any one (1) political party. Of the members of the board ap-
 19 pointed by the governor, four (4) members shall be chosen with due regard to
 20 their knowledge and interest in health and social services, two (2) members
 21 shall be chosen based on their experience in business or finance, and one (1)
 22 member shall be selected as a representative of the public at large. The vot-
 23 ing members shall be appointed to assure appropriate geographic representa-
 24 tion of the state of Idaho. The other four (4) members of the board, who shall
 25 be nonvoting members, shall be:

26 (a) The chairperson of the senate health and welfare committee, or the
 27 chair's designee;

28 (b) The chairperson of the house of representatives health and welfare
 29 committee, or the chair's designee;

30 (c) The director of the department of health and welfare, who shall
 31 serve as the board's secretary; and

32 (d) A representative of the office of the governor, as designated by the
 33 governor.

34 (2) The members of the board of health and welfare appointed by the gov-
 35 ernor, serving on the effective date of this act shall continue in office
 36 as members of the board of health and welfare. All members of the board of
 37 health and welfare appointed by the governor shall serve four (4) year terms.

38 (3) The voting members of the board annually shall elect a chairman and
 39 a vice chairman, who shall be voting members of the board. The board shall
 40 hold meetings no less than once every quarter. Special meetings of the board
 41 may be called by the chairman of the board, by a majority of the voting mem-
 42 bers of the board or, on written request, by the director of the department
 43 of health and welfare. A majority of the voting members shall be necessary to
 44 constitute a quorum at any regular or special meeting, and the action of the
 45 majority of members present shall be the action of the board. The members of
 46 the board shall be compensated as provided in section 59-509(p), Idaho Code.

47 (4) The board, in furtherance of its duties under law and under its
 48 rules, shall have the power to administer oaths, certify to official acts,
 49 and ~~to~~ issue subpoenas for the attendance of witnesses and the production

1 of papers, books, accounts, documents and testimony. The board may, if a
2 witness refuses to attend or testify, or to produce any papers required by
3 such subpoenas, report to the district court in and for the county in which
4 the proceeding is pending, by petition, setting forth that due notice has
5 been given of the time and place of attendance of said witnesses, or the pro-
6 duction of said papers, that the witness has been properly summoned, and that
7 the witness has failed and refused to attend or produce the papers required
8 by ~~this~~ such subpoena before the board, or has refused to answer questions
9 propounded to him in the course of said proceedings, and ask an order of said
10 court compelling the witness to attend and testify and produce said papers
11 before the board. The court, upon the petition of the board, shall enter an
12 order directing the witness to appear before the court at a time and place to
13 be fixed by the court in such order, the time to be not more than ten (10) days
14 from the date of the order, and then and there shall show cause why he has not
15 attended and testified or produced said papers before the board. A copy of
16 said order shall be served upon said witness. If it shall appear to the court
17 that said subpoena was regularly issued by the board and regularly served,
18 the court shall thereupon order that said witness appear before the board at
19 the time and place fixed in said order, and testify or produce the required
20 papers. Upon failure to obey said order, said witness shall be dealt with for
21 contempt of court.

22 (5) The director, his designee, or any party to the action may, in an
23 investigation or hearing before the board, cause the deposition or inter-
24 rogatory of witnesses or parties residing within or without the state, to be
25 taken in the manner prescribed by law for like depositions and interrogato-
26 ries in civil actions in the district court of this state, and to that end may
27 compel the attendance of said witnesses and production of books, documents,
28 papers and accounts.

29 (6) Any person aggrieved by an action or inaction of the department of
30 health and welfare shall be afforded an opportunity for a fair hearing upon
31 request therefor in writing pursuant to chapter 52, title 67, Idaho Code, and
32 the rules promulgated thereunder. In those cases where the board has been
33 granted the authority to hold such a hearing pursuant to a provision of ~~the~~
34 Idaho Code, the hearing may be conducted by the board at a regular or spe-
35 cial meeting, or the board may designate hearing officers, who shall have the
36 power and authority to conduct hearings in the name of the board at any time
37 and place. In any hearing, a member of the board or hearing officer desig-
38 nated by it, shall have the power to administer oaths, examine witnesses, and
39 issue in the name of the board subpoenas requiring the testimony of witnesses
40 and the production of evidence relevant to any matter in the hearing.

41 (7) Any person adversely affected by a final determination of the
42 board, may secure judicial review by filing a petition for review as pre-
43 scribed under the provisions of chapter 52, title 67, Idaho Code. The peti-
44 tion for review shall be served upon the chairman of the board, the director
45 of the department, and upon the attorney general of the state of Idaho. Such
46 service shall be jurisdictional and ~~the provisions of this section shall be~~
47 ~~the exclusive procedure for appeal~~ procedures for appeal shall be governed
48 by chapter 52, title 67, Idaho Code.

49 (8) The board, by the affirmative vote of four (4) of its voting mem-
50 bers, may adopt, amend or repeal the rules, codes, and standards of the de-

1 department, that are necessary and feasible in order to carry out its duties
2 and responsibilities and to enforce the laws of this state.

3 The rules and orders so adopted and established shall have the force and
4 effect of law and may deal with any matters deemed necessary and feasible for
5 protecting the health of the state.

6 (9) All rulemaking proceedings and hearings of the board shall be gov-
7 erned by the provisions of chapter 52, title 67, Idaho Code.

8 (10) In addition to any other powers and duties granted to the board un-
9 der law, the board shall:

10 (a) Advise the director and the governor on department fiscal, policy
11 and administrative matters;

12 (b) Review and advise the director regarding the department's strate-
13 gic plan and performance measures;

14 (c) Develop goals and standards to measure department efficiency and
15 effectiveness; and

16 (d) Review and advise the director and the governor on department ini-
17 tiatives.

18 (11) The board shall provide an annual report to the governor and to the
19 legislature prior to the start of each legislative session, addressing:

20 (a) The key department fiscal and policy issues;

21 (b) The department's managerial and overall performance; and

22 (c) The major proposed and ongoing departmental initiatives.

23 (12) Nothing in this section shall exempt the department of health and
24 welfare from complying with the requirements of chapter 52, title 67, Idaho
25 Code.

26 SECTION 63. That Section 58-122, Idaho Code, be, and the same is hereby
27 amended to read as follows:

28 58-122. CONTESTED CASES -- PROCEDURE. It shall be the duty of the
29 director of the department of lands in any or all contested cases, at the
30 direction of the board, to appoint hearing officers, receive evidence, issue
31 subpoenas and to hold contested case hearings in accordance with sections
32 67-52402 through 67-527169, Idaho Code, when hearings are necessary and
33 witnesses may be required to be examined. Provided however, that when the
34 state board of land commissioners is exercising its duties and authorities
35 concerning the direction, control or disposition of the public lands of the
36 state pursuant to sections 7 and 8, article IX, of the constitution of the
37 state of Idaho, such actions shall not be considered to be contested cases
38 as defined in subsection (67) of section 67-5201, Idaho Code, and section
39 67-52403, Idaho Code, unless the board, in its discretion, determines that
40 a contested case hearing would be of assistance to the board in the exercise
41 of its duties and authorities.

42 SECTION 64. That Section 67-2317, Idaho Code, be, and the same is hereby
43 amended to read as follows:

44 67-2317. HEARING AND DECISION OF DISPUTED ISSUES. Upon the failure
45 or refusal of the official or agency in charge of any state public building
46 to comply with the recommendations of the administrator of the division
47 of building safety, the administrator may hold a hearing, pursuant to the

1 provisions for contested cases under the administrative procedure act, as
2 provided in sections 67-5240~~1~~ et seq., Idaho Code.

3 The administrator is empowered to conduct such hearing and render a de-
4 cision. The administrator shall transmit a copy of the decision to the offi-
5 cial or agency in direct control of the public building and to the governor.

6 SECTION 65. That Section 67-5206, Idaho Code, be, and the same is hereby
7 amended to read as follows:

8 67-5206. PROMULGATION OF RULES IMPLEMENTING ADMINISTRATIVE PROCEDURE
9 ACT. (1) In accordance with the rulemaking requirements of this chapter, the
10 administrative rules coordinator shall promulgate rules implementing the
11 provisions of sections 67-5203, 67-5204 and 67-5205, Idaho Code. The rules
12 shall:

13 (a) establish a uniform numbering system applicable to rules adopted by
14 all agencies;

15 (b) establish a uniform style and format applicable to rules adopted by
16 all agencies;

17 (c) establish a publication schedule for the bulletin and the adminis-
18 trative code, including deadlines for the submission of documents to be
19 included within each publication;

20 (d) establish a uniform indexing system for agency orders; and

21 (e) include such other rules as the coordinator deems necessary to im-

25 attorney general shall promulgate rules of procedure appropriate for use by
26 as many agencies as possible. The rules shall deal with all general func-
27 tions and duties performed in common by several agencies.

28 (3) In accordance with the rulemaking requirements of this chapter, the
29 attorney general shall promulgate rules implementing the provisions of sec-
30 tions 67-5220 through 67-5232, Idaho Code. The rules shall specify:

31 (a) the form and content for petitions requesting an opportunity for an
32 oral presentation in a substantive rulemaking;

33 (b) procedures for the creation of a record of comments received at any
34 oral presentation;

35 (c) the standards by which exemptions from regular rulemaking require-
36 ments will be authorized to correct typographical errors, transcrip-
37 tion errors, or clerical errors;

38 (d) the form and content for a petition for the adoption of rules and the
39 procedure for its submission, consideration and disposition;

40 (e) procedures to facilitate negotiated rulemaking;

41 (f) the form and content of a petition for a declaratory ruling on the
42 applicability of statutes or regulations; and

43 (g) such other provisions as may be necessary or useful.

44 (4) In accordance with the ~~rule-making~~ rulemaking requirements of this
45 chapter, the attorney general shall promulgate rules implementing the pro-
46 visions of sections 67-5240~~1~~ through 67-5255~~9~~, Idaho Code. The rules shall
47 specify:

48 (a) form and content to be employed in giving notice of a contested
49 case;

- 1 (b) procedures and standards required for intervention in a contested
2 case;
- 3 (c) procedures for prehearing conferences;
- 4 (d) format for pleadings, briefs, and motions;
- 5 (e) the method by which service shall be made;
- 6 (f) procedures for the issuance of subpoenas, discovery orders, and
7 protective orders if authorized by other provisions of law;
- 8 (g) qualifications for persons seeking to act as a hearing officer;
- 9 (h) qualifications for persons seeking to act as a representative for
10 parties to contested cases;
- 11 (i) procedures to facilitate informal settlement of matters;
- 12 (j) procedures for placing ex parte contacts on the record; and
- 13 (k) such other provisions as may be necessary or useful.
- 14 (5) (a) After July 1, 1993, the rules promulgated by the attorney gen-
15 eral under this section shall apply to all agencies that do not affirma-
16 tively promulgate alternative procedures after the promulgation of the
17 rules by the attorney general. The rules promulgated by the attorney
18 general shall supersede the procedural rules of any agency in effect on
19 June 30, 1993, unless that agency promulgates its own procedures as pro-
20 vided in paragraph (b) of this subsection.
- 21 (b) After July 1, 1993, an agency that promulgates its own procedures
22 shall include in the rule adopting its own procedures a finding that
23 states the reasons why the relevant portion of the attorney general's
24 rules were inapplicable to the agency under the circumstances.

25 SECTION 66. Sections 33 through 43 of this act shall be in full force and
26 effect on and after July 1, 2019. Section 38 of this act shall be null, void,
27 and of no force and effect on and after July 1, 2024. Sections 1 through 32
28 and sections 44 through 65 of this act shall be in full force and effect on and
29 after January 1, 2020.
