AN ACT

RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR FISCAL YEAR 2019; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE PUBLIC HEALTH SERVICES DIVISION FOR FISCAL YEAR 2019; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE FOSTER AND ASSISTANCE PAYMENTS PROGRAM FOR FISCAL YEAR 2019; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE MEDICAID ADMINISTRATION AND MEDICAL MANAGEMENT PROGRAM FOR FISCAL YEAR 2019; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE HEALTH CARE POLICY INITIATIVES PROGRAM FOR FISCAL YEAR 2019; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE SOUTHWEST IDAHO TREATMENT CENTER PROGRAM FOR FISCAL YEAR 2019; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE SELF-RELIANCE OPERATIONS PROGRAM FOR FISCAL YEAR 2019; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE PUBLIC HEALTH SERVICES DIVISION FOR FISCAL YEAR 2019; AND DECLARING AN EMERGENCY.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. In addition to the appropriation made in Section 1, Chapter 340, Laws of 2018, and any other appropriation provided by law, there is hereby appropriated to the Department of Health and Welfare for the Public Health Services Division the following amounts to be expended according to the designated programs and expense classes from the listed funds for the period July 1, 2018, through June 30, 2019:

9 ter and Assistance Payments Program \$1,000,000 from the Cooperative Welfare  
10 (Federal) Fund to be expended for trustee and benefit payments for the period  
11 July 1, 2018, through June 30, 2019.

12 SECTION 3. Notwithstanding any other provision of law to the contrary,  
13 the appropriation made to the Department of Health and Welfare for the Medic-  
14 aid Administration and Medical Management Program in Section 1, Chapter 339,  
15 Laws of 2018, from the Cooperative Welfare (Federal) Fund is hereby reduced  
16 by \$700,000 for operating expenditures for the period July 1, 2018, through  
17 June 30, 2019.

18 SECTION 4. Notwithstanding any other provision of law to the contrary,  
19 the appropriation made to the Department of Health and Welfare for the Health  
20 Care Policy Initiatives Program in Section 1, Chapter 353, Laws of 2018, is
