**CONVENED:** Chairman Bair called the Senate Finance Committee to order at 9:30 a.m. A

silent roll call was taken.

H 449 Budget Stabilization Fund Cap. Paul Headlee, Division Manager, Budget &

Policy, Legislative Services Office (LSO) explained that H 449 accomplishes three

actions:

1. It raises the cap on the Budget Stabilization Fund from 10 percent to 15 percent

and changes the timing of transfers into the fund;

2. It transfers the remaining moneys in the Economic Recovery Reserve Fund

(ERRF) into the Budget Stabilization Fund and repeals ERRF; and

3. It authorizes a \$40 million transfer from the General Fund into the Budget

Stabilization Fund in Fiscal Year 2020.

**MOTION:** Senator Grow moved to send **H 449** to the Senate floor with a **do pass** 

recommendation. Senator Burtenshaw seconded the motion.

ROLL CALL Chairman Bair called for a roll call vote. The motion carried by unanimous roll call

**VOTE:** vote. Senator Grow will carry the bill on the Senate Floor.

H 453 Budget Submission Deadline. Senator Johnson explained that H 453 amends

Idaho Code §67-3502 to move the submission date for the annual budget for the judicial branch, legislative branch, and Department of Administration, Division of Public Works, from November 1 to November 15. This change is needed to accommodate budget approvals by governing councils that are difficult to schedule before November 1 of each year. **Senator Johnson** provided examples. The

judicial branch has reviewed and approved this legislation.

MOTION:	<b>Senator Johnson</b> moved to send <b>H 453</b> to the Senate floor with a <b>do pass</b> recommendation. <b>Senator Nye</b> seconded the motion. The motion carried by <b>voi vote</b> . Senator Johnson will carry the bill on the Senate Floor.
