## STATEMENT OF PURPOSE

## RS28836 / S1186

This is the FY 2022 original appropriation bill for the Office of the State Treasurer. It appropriates a total of \$4,357,700 and caps the number of authorized full-time equivalent positions at 26.00. For benefit costs, the bill maintains the current appropriated amount for health insurance at \$11,650 per eligible FTP, extends the holiday for the employer's sick leave contribution rate for another year, and restores funding for the employer's unemployment insurance contribution rate. The bill also provides funding for the equivalent of a 2% change in employee compensation for permanent state employees.

The bill also removes the \$196,000 from the General Fund that was appropriated to the Office of the State Treasurer for FY 2021 in H114, and provides \$75,000 from the General Fund in FY 2021 for office relocation costs. Lastly, the bill provides requirements regarding the removal of office furniture from the State Capitol.
