1 RELATING TO APPROPRIATIONS; APPROPRIATING ADDITIONAL MONEYS TO THE EXECU-
2 TIVE OFFICE OF THE GOVERNOR FOR THE ADMINISTRATION - GOVERNOR'S OFFICE
3 PROGRAM FOR FISCAL YEAR 2023; APPROPRIATING ADDITIONAL MONEYS TO THE
4 OFFICE OF THE LIEUTENANT GOVERNOR FOR FISCAL YEAR 2023; APPROPRIATING
5 ADDITIONAL MONEYS TO THE OFFICE OF THE SECRETARY OF STATE FOR THE SEC-
6 RETARY OF STATE PROGRAM FOR FISCAL YEAR 2023; APPROPRIATING ADDITIONAL
7 MONEYS TO THE OFFICE OF THE STATE CONTROLLER FOR THE ADMINISTRATION
8 PROGRAM FOR FISCAL YEAR 2023; APPROPRIATING ADDITIONAL MONEYS TO THE
9 OFFICE OF THE STATE TREASURER FOR FISCAL YEAR 2023; APPROPRIATING AD-
10 DITIONAL MONEYS TO THE DEPARTMENT OF EDUCATION FOR THE ADMINISTRATION
11 PROGRAM FOR FISCAL YEAR 2023; APPROPRIATING ADDITIONAL MONEYS TO THE
12 OFFICE OF THE ATTORNEY GENERAL FOR THE STATE LEGAL SERVICES PROGRAM FOR
13 FISCAL YEAR 2023; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE
14 DATE.

16 Be It Enacted by the Legislature of the State of Idaho:

17 SECTION 1. In addition to any other appropriation provided by law,
18 there is hereby appropriated to the Executive Office of the Governor for the
19 Administration - Governor's Office Program \$7,900 from the General Fund to
20 be expended for personnel costs for the period July 1, 2022, through June 30,
21 2023, for the purpose of the Governor's salary.

22 SECTION 2. In addition to any other appropriation provided by law,
23 there is hereby appropriated to the Office of the Lieutenant Governor \$2,800
24 from the General Fund to be expended for personnel costs for the period July
25 1, 2022, through June 30, 2023, for the purpose of the Lieutenant Governor's
26 salary.

27 SECTION 3. In addition to any other appropriation provided by law,
28 there is hereby appropriated to the Office of the Secretary of State for the
29 Secretary of State Program \$6,700 from the General Fund to be expended for
30 personnel costs for the period July 1, 2022, through June 30, 2023, for the
31 purpose of the Secretary of State's salary.

32 SECTION 4. In addition to any other appropriation provided by law,
33 there is hereby appropriated to the Office of the State Controller for the
34 Administration Program \$6,700 from the General Fund to be expended for per-
35 sonnel costs for the period July 1, 2022, through June 30, 2023, for the
36 purpose of the State Controller's salary.

37 SECTION 5. In addition to any other appropriation provided by law,
38 there is hereby appropriated to the Office of the State Treasurer \$6,700 from

1 the General Fund to be expended for personnel costs for the period July 1,
2 2022, through June 30, 2023, for the purpose of the State Treasurer's salary.

3 SECTION 6. In addition to any other appropriation provided by law,
4 there is hereby appropriated to the State Department of Education for the
5 Administration Program \$6,700 from the General Fund to be expended for per-
6 sonnel costs for the period July 1, 2022, through June 30, 2023, for the
7 purpose of the Superintendent of Public Instruction's salary.

8 SECTION 7. In addition to any other appropriation provided by law,
9 there is hereby appropriated to the Office of the Attorney General for the
10 State Legal Services Program \$7,700 from the General Fund to be expended for
11 personnel costs for the period July 1, 2022, through June 30, 2023, for the
12 purpose of the Attorney General's salary.

13 SECTION 8. An emergency existing therefor, which emergency is hereby
14 declared to exist, this act shall be in full force and effect on and after
15 July 1, 2022.
