AN ACT

1 REGARDING EDUCATION EFFORTS RELATED TO LITERACY INTERVENTIONS, LOCAL SCHOOL  
2 INNOVATION, AND REVIEW OF CAREER LADDER EVALUATIONS; APPROPRIATING  
3 AND TRANSFERRING ADDITIONAL FUNDS TO THE PUBLIC SCHOOL INCOME FUND;  
4 APPROPRIATING ADDITIONAL FUNDS TO THE PUBLIC SCHOOLS SUPPORT PRO-  
5 GRAM/DIVISION OF CHILDREN'S PROGRAMS FOR FISCAL YEAR 2017 FOR LITERACY  
6 INTERVENTIONS; APPROPRIATING AND TRANSFERRING ADDITIONAL FUNDS TO THE  
7 PUBLIC SCHOOL INCOME FUND; APPROPRIATING ADDITIONAL MONEYS TO THE PUB-  
8 LIC SCHOOLS SUPPORT PROGRAM/DIVISION OF OPERATIONS PROGRAMS FOR FISCAL  
9 YEAR 2017 FOR THE LOCAL SCHOOL INNOVATION ACT; REDUCING THE APPROPRI-  
10 ATION AND TRANSFER OF FUNDS TO THE PUBLIC SCHOOL INCOME FUND; REDUCING  
11 THE APPROPRIATION TO THE PUBLIC SCHOOL SUPPORT PROGRAM/DIVISION OF CEN-  
12 TRAL SERVICES FOR FISCAL YEAR 2017; AND APPROPRIATING ADDITIONAL MONEYS  
13 TO THE OFFICE OF THE STATE BOARD OF EDUCATION FOR FISCAL YEAR 2017 FOR  
14 REVIEW OF CAREER LADDER EVALUATIONS.

16 Be It Enacted by the Legislature of the State of Idaho:

17 SECTION 1. In addition to the appropriation and transfer made in Sec-  
18 tion 2 of House Bill No. 620, as enacted by the Second Regular Session of the  
19 Sixty-third Idaho Legislature, there is hereby appropriated and transferred  
20 \$9,100,000 from the General Fund to the Public School Income Fund for the pe-  
21 riod July 1, 2016, through June 30, 2017.

22 SECTION 2. In addition to the appropriation made in Section 3 of House  
23 Bill No. 620, as enacted by the Second Regular Session of the Sixty-third  
24 Idaho Legislature, there is hereby appropriated to the Public School Support  
25 Program/Division of Children's Programs \$9,100,000 from the Public School  
26 Income Fund for the period July 1, 2016, through June 30, 2017, to be used for  
27 literacy interventions.

28 SECTION 3. In addition to the appropriation and transfer made in Sec-  
29 tion 2 of House Bill No. 619, as enacted by the Second Regular Session of the  
30 Sixty-third Idaho Legislature, there is hereby appropriated and transferred  
31 \$100,000 from the General Fund to the Public School Income Fund for the pe-  
32 riod July 1, 2016, through June 30, 2017.

33 SECTION 4. In addition to the appropriation made in Section 3 of House  
34 Bill No. 619, as enacted by the Second Regular Session of the Sixty-third  
35 Idaho Legislature, there is hereby appropriated to the Public School Support  
36 Program/Division of Operations \$100,000 from the Public School Income Fund  
37 for the period July 1, 2016, through June 30, 2017, to be used for the Local  
38 School Innovation Act.

1 SECTION 5. Notwithstanding any other provision of law to the contrary,  
 2 the appropriation and transfer from the General Fund to the Public School In-  
 3 come Fund in Section 2 of House Bill No. 623, as enacted by the Second Regular  
 4 Session of the Sixty-third Idaho Legislature, is hereby reduced by \$600,000  
 5 for the period July 1, 2016, through June 30, 2017.

6 SECTION 6. That Section 3 of House Bill No. 623, as enacted by the Sec-  
 7 ond Regular Session of the Sixty-third Idaho Legislature, be, and the same is  
 8 hereby amended to read as follows:

9 SECTION 3. There is hereby appropriated to the Public Schools Educational  
 10 Support Program/Division of Central Services, the following amounts to be  
 11 expended for the designated expense classes, from the listed funds for the  
 12 period July 1, 2016, through June 30, 2017:

21 SECTION 7. In addition to the appropriation made in Section 1 of Senate  
 22 Bill No. 1412, as enacted by the Second Regular Session of the Sixty-third  
 23 Idaho Legislature, there is hereby appropriated \$600,000 from the General  
 24 Fund to the Office of the State Board of Education for the OSBE Administra-  
 25 tion Program for trustee and benefit payments for the period July 1, 2016,  
 26 through June 30, 2017, to be used for review of career ladder evaluations.
