AN ACT

1 APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF JUVENILE CORRECTIONS  
2 FOR THE COMMUNITY, OPERATIONS, AND PROGRAM SERVICES PROGRAM FOR FISCAL  
3 YEAR 2016; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF JUVE-  
4 NILE CORRECTIONS FOR THE INSTITUTIONS PROGRAM FOR FISCAL YEAR 2016;  
5 APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF JUVENILE COR-  
6 RECTIONS FOR THE COMMUNITY-BASED SUBSTANCE ABUSE TREATMENT SERVICES  
7 PROGRAM FOR FISCAL YEAR 2016; REDUCING THE APPROPRIATION TO THE DEPART-  
8 MENT OF JUVENILE CORRECTIONS FOR THE INSTITUTIONS PROGRAM FOR FISCAL  
9 YEAR 2016; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF JUVENILE  
10 CORRECTIONS FOR THE COMMUNITY-BASED SUBSTANCE ABUSE TREATMENT SERVICES  
11 PROGRAM FOR FISCAL YEAR 2016; AND DECLARING AN EMERGENCY.

13 Be It Enacted by the Legislature of the State of Idaho:

14 SECTION 1. In addition to the appropriation made in Section 1, Chapter  
15 160, Laws of 2015, and any other appropriation provided for by law, there is  
16 hereby appropriated \$100,000 from the General Fund to the Department of Ju-  
17 venile Corrections for the Community, Operations, and Program Services Pro-  
18 gram, to be expended for trustee and benefit payments, for the period July 1,  
19 2015, through June 30, 2016, to be used for the Community Incentive Program.

20 SECTION 2. In addition to the appropriation made in Section 1, Chapter  
21 160, Laws of 2015, and any other appropriation provided for by law, there is  
22 hereby appropriated \$49,200 from the General Fund to the Department of Juve-  
23 nile Corrections for the Institutions Program, to be expended for operating  
24 expenditures, for the period July 1, 2015, through June 30, 2016, to be used  
25 for administrative-wide area network and broadband costs.

26 SECTION 3. In addition to the appropriation made in Section 1, Chapter  
27 160, Laws of 2015, and any other appropriation provided for by law, there  
28 is hereby appropriated to the Department of Juvenile Corrections for the  
29 Community-Based Substance Abuse Treatment Services Program from the Gen-  
30 eral Fund, the following amounts to be expended for the designated expense  
31 classes, to be used for electronic health records and claims processing, for  
32 the period July 1, 2015, through June 30, 2016:

37 SECTION 4. Notwithstanding any other provision of law to the contrary,  
38 the appropriation made to the Department of Juvenile Corrections for the In-

1     stitutions Program in Section 1, Chapter 160, Laws of 2015, from the General  
2     Fund, is hereby reduced by \$100,000 for trustee and benefit payments, for the  
3     period July 1, 2015, through June 30, 2016.

4             SECTION 5. Notwithstanding any other provision of law to the contrary,  
5     the appropriation made to the Department of Juvenile Corrections for the  
6     Community-Based Substance Abuse Treatment Services Program in Section  
7     1, Chapter 160, Laws of 2015, from the General Fund, is hereby reduced by  
8     \$147,000 for trustee and benefit payments, for the period July 1, 2015,  
9     through June 30, 2016.

10            SECTION 6. An emergency existing therefor, which emergency is hereby  
11     declared to exist, this act shall be in full force and effect on and after its  
12     passage and approval.
