HOUSE BILL NO. 77

AN ACT

1 RELATING TO DISCLOSURE OF INFORMATION; AMENDING SECTION 39-270, IDAHO CODE,  
2 TO PROVIDE A CORRECT CODE REFERENCE AND TO MAKE A TECHNICAL CORRECTION;  
3 AND DECLARING AN EMERGENCY.

5 Be It Enacted by the Legislature of the State of Idaho:

6 SECTION 1. That Section 39-270, Idaho Code, be, and the same is hereby  
7 amended to read as follows:

8 39-270. DISCLOSURE OF INFORMATION. (a) Certificates and records in  
9 the custody of the state registrar shall be open to inspection subject to the  
10 provisions of this chapter and the rules of the board, the provisions of sec-  
11 tion ~~9-302~~ 74-102, Idaho Code, to the contrary notwithstanding; and it shall  
12 be unlawful for any state or local official or employee under this chapter  
13 to disclose any data contained in the records, except as authorized by this  
14 chapter and the rules of the board.

15 (b) A complete copy, or any part of a certificate, may be issued to any  
16 applicant who can show direct and tangible interest in the record for which  
17 he applies. A complete copy, or any part of a certificate, shall be issued  
18 upon request to a state, federal or local public agency for child support en-  
19 forcement purposes pursuant to chapters 10, 11 and 12, title 7, Idaho Code,  
20 and sections 16-1628, 20-524, 32-710A, and 56-203, Idaho Code, or for the  
21 purpose of investigation of fraud related to benefit payments. Subject to  
22 such provisions as the board may prescribe, data contained on records may be  
23 used by federal, state or municipal agencies for the purpose of verification  
24 of data.

25 (c) As provided in chapter 1, title 74, Idaho Code, data contained on  
26 records may be used for research, public health or statistical purposes. No  
27 lists of registration shall be compiled for public use.

28 (d) The manner of keeping local records and the use thereof shall be  
29 prescribed by the board, in keeping with the provisions of this section.

30 (e) When one hundred (100) years have elapsed after the date of birth,  
31 or fifty (50) years have elapsed after the date of death, stillbirth, mar-  
32 riage or divorce, the records of these events in the custody of the state reg-  
33 istrar shall become public records and information shall be made available  
34 in accordance with chapter 1, title 74, Idaho Code.

35 SECTION 2. An emergency existing therefor, which emergency is hereby  
36 declared to exist, this act shall be in full force and effect on and after its  
37 passage and approval.
