AN ACT

1 RELATING TO COMMERCIAL DRIVER'S LICENSES; AMENDING SECTION 49-306, IDAHO
2 CODE, TO REVISE PROVISIONS REGARDING SKILLS TEST FEES FOR COMMERCIAL
3 DRIVER'S LICENSES; AMENDING SECTION 49-306, IDAHO CODE, AS AMENDED BY
4 SECTION 6, CHAPTER 54, LAWS OF 2015, TO REVISE PROVISIONS REGARDING
5 SKILLS TEST FEES FOR COMMERCIAL DRIVER'S LICENSES; AND PROVIDING AN
6 EFFECTIVE DATE.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. That Section 49-306, Idaho Code, be, and the same is hereby
10 amended to read as follows:

11 49-306. APPLICATION FOR DRIVER'S LICENSE, INSTRUCTION PERMIT,
12 COMMERCIAL LEARNER'S PERMIT OR RESTRICTED SCHOOL ATTENDANCE DRIVING PER-
13 MIT. (1) Every application for any instruction permit, restricted school
14 attendance driving permit, or for a driver's license shall be made upon a
15 form furnished by the department and shall be verified by the applicant be-
16 fore a person authorized to administer oaths. Officers and employees of the
17 department and sheriffs and their deputies are authorized to administer the
18 oaths without charge. Every application for a permit, extension or driver's
19 license shall be accompanied by the following fee, none of which is refund-
20 able:

- 21 (a) Class A, B, C (4-year) license with endorsements --
- 22 age 21 years and older\$40.00
- 23 (b) Class A, B, C (3-year) license with endorsements --
- 24 age 18 to 21 years\$30.00
- 25 (c) Class A, B, C (1-year) license with endorsements --
- 26 age 20 years\$15.00
- 27 (d) Class D (3-year) license -- under age 18 years \$25.00
- 28 (e) Class D (3-year) license -- age 18 to 21 years \$25.00
- 29 (f) Class D (1-year) license -- age 17 years or age 20 years\$15.00
- 30 (g) Four-year Class D license -- age 21 years and older\$30.00
- 31 (h) Eight-year Class D license -- age 21 to 63 years\$55.00
- 32 (i) Commercial learner's permit\$29.00
- 33 (j) Class D instruction permit or supervised instruction permit
- 34\$15.00
- 35 (k) Duplicate driver's license or permit issued under
- 36 section 49-318, Idaho Code \$15.00
- 37 (l) Driver's license extension issued under section
- 38 49-319, Idaho Code \$10.00
- 39 (m) License classification change (upgrade)\$25.00
- 40 (n) Endorsement addition\$15.00
- 41 (o) Class A, B, C skills tests not more than\$70190.00
- 42 (p) Class D skills test\$24.00

- 1 (q) Motorcycle endorsement skills test\$10.00
- 2 (r) Knowledge test\$ 3.00
- 3 (s) Seasonal driver's license\$39.00
- 4 (t) One time motorcycle "M" endorsement\$15.00
- 5 (u) Motorcycle endorsement instruction permit\$15.00
- 6 (v) Restricted driving permit or restricted school attendance
- 7 driving permit\$60.00

8 (2) Every application shall state the true and full name, date of birth,
 9 sex, declaration of Idaho residency, Idaho residence address and mailing ad-
 10 dress, if different, of the applicant, height, weight, hair color, and eye
 11 color, and the applicant's social security number as verified by the social
 12 security administration. If an applicant has submitted an application pur-
 13 suant to the provisions of chapter 58, title 19, Idaho Code, then the appli-
 14 cant may state, in his or her application pursuant to this section, the ap-
 15 plicant's alternative Idaho mailing address in place of his or her Idaho res-
 16 idence address and mailing address. Notwithstanding the provisions of sec-
 17 tion 49-303(13), Idaho Code, an applicant for a nondomiciled class A, B or
 18 C driver's license or nondomiciled commercial learner's permit having res-
 19 idency in a state that is prohibited from issuing class A, B or C driver's
 20 licenses or commercial learner's permits, as provided in 49 CFR 384, is ex-
 21 cepted from providing proof of Idaho residency and an Idaho mailing address.

22 (a) The requirement that an applicant provide a social security number
 23 as verified by the social security administration shall apply only to
 24 applicants who have been assigned a social security number.

25 (b) An applicant who has not been assigned a social security number
 26 shall:

- 27 (i) Present written verification from the social security admin-
 28 istration that the applicant has not been assigned a social secu-
 29 rity number; and
- 30 (ii) Submit a birth certificate, passport or other documentary
 31 evidence issued by an entity other than a state or the United
 32 States; and
- 33 (iii) Submit such proof as the department may require that the ap-
 34 plicant is lawfully present in the United States.

35 A driver's license, commercial learner's permit or any instruction
 36 permit issued on and after January 1, 1993, shall not contain an appli-
 37 cant's social security number. Applications on file shall be exempt
 38 from disclosure except as provided in sections 49-202, 49-203, 49-203A
 39 and 49-204, Idaho Code.

40 (c) Every application for a class A, B or C license shall state where the
 41 applicant has been licensed for the preceding ten (10) years and under
 42 which of the following driving categories the applicant will operate:

- 43 (i) Non-excepted Interstate. The applicant operates or expects
 44 to operate in interstate commerce, and is required to provide a
 45 medical examiner's certificate;
- 46 (ii) Excepted Interstate. The applicant operates or expects to
 47 operate in interstate commerce, but engages exclusively in trans-
 48 portation or operations excepted by the federal motor carrier
 49 safety administration from all or parts of the qualification re-
 50 quirements of federal motor carrier safety regulation 49, part

1 391, and is therefore not required to provide a medical examiner's
2 certificate;

3 (iii) Non-excepted Intrastate. The applicant operates only in
4 intrastate commerce and is subject to and meets all Idaho driver
5 qualification requirements and the applicable parts of federal
6 motor carrier safety regulation 49, part 391, and is required to
7 provide a medical examiner's certificate; or

8 (iv) Excepted Intrastate. The applicant operates in intrastate
9 commerce, but engages exclusively in exempted transportation or
10 operations as listed in section 67-2901B(2), Idaho Code, and the
11 applicable parts of federal motor carrier safety regulation 49,
12 part 391, and is therefore not required to provide a medical exam-
13 iner's certificate.

14 All applications shall also state whether the applicant has previ-
15 ously been licensed as a driver, and if so, when and by what state or
16 country, and whether a driver's license or privileges have ever been
17 suspended, revoked, denied, disqualified, canceled or whether an ap-
18 plication has ever been refused, and if so, the date of and reason for
19 the suspension, revocation, denial, disqualification, cancellation
20 or refusal and the applicant's oath that all information is correct as
21 signified by the applicant's signature.

22 (d) The applicant must submit proof of identity acceptable to the exam-
23 iner or the department and date of birth as set forth in a certified copy
24 of his birth certificate. When a certified copy of his birth certifi-
25 cate or a delayed birth certificate is impossible to obtain from a vital
26 statistics agency, another government issued document may be submitted
27 that provides satisfactory evidence of a person's full legal name and
28 date of birth acceptable to the examiner or the department.

29 (e) Every applicant for a class A, B or C driver's license or commer-
30 cial learner's permit shall provide proof of United States citizenship
31 or lawful permanent residency in the United States upon application for
32 issuance, transfer, upgrade or renewal, unless the applicant's driving
33 record already contains documentation confirming United States citi-
34 zenship or lawful permanent residency. Every applicant for a nondomi-
35 ciled class A, B or C driver's license or commercial learner's permit
36 domiciled in a foreign country must provide an unexpired employment au-
37 thorization document issued by the department of homeland security or
38 an unexpired foreign passport accompanied by an approved I-94 form doc-
39 umenting the applicant's most recent admittance into the United States.

40 (f) Individuals required to register in compliance with section 3 of
41 the federal military selective service act, 50 U.S.C. App. 451 et seq.,
42 as amended, shall be provided an opportunity to fulfill such registra-
43 tion requirements in conjunction with an application for a driver's li-
44 cense, commercial learner's permit or instruction permit. Any regis-
45 tration information so supplied shall be transmitted by the department
46 to the selective service system.

47 (3) Whenever an application is received from a person previously li-
48 censed in another jurisdiction, the department shall request a copy of the
49 driver's record from the other jurisdiction and shall contact the national
50 driver register. When received, the driver's record from the previous ju-

1 jurisdiction shall become a part of the driver's record in this state with the
2 same force and effect as though entered on the driver's record in this state
3 in the original instance.

4 (4) Whenever the department receives a request for a driver's record
5 from another licensing jurisdiction, the record shall be forwarded without
6 charge.

7 (5) The department shall contact and notify the commercial driver li-
8 cense information system of the proposed application for a class A, B or C
9 driver's license or commercial learner's permit to ensure identification of
10 the person and to obtain clearance to issue the license.

11 (6) When the fees required under this section are collected by a county
12 officer, they shall be paid over to the county treasurer not less often than
13 monthly, who shall immediately:

14 (a) Deposit an amount equal to five dollars (\$5.00) from each driver's
15 license except an eight-year class D license, or any class D instruction
16 permit application fees, application for a duplicate driver's license
17 or permit, classification change, seasonal driver's license and addi-
18 tional endorsement, and ten dollars (\$10.00) from each eight-year class
19 D driver's license, in the current expense fund; and

20 (b) Deposit two dollars and fifty cents (\$2.50) from each motorcycle
21 endorsement and motorcycle endorsement instruction permit fee in the
22 current expense fund; and

23 (c) Deposit an amount equal to three dollars (\$3.00) from each fee for a
24 knowledge test in the current expense fund; and

25 (d) Deposit an amount equal to ten dollars (\$10.00) from each fee for
26 a motorcycle endorsement skills test in the current expense fund; pro-
27 vided however, if a contractor administers the skills test he shall be
28 entitled to the ten dollar (\$10.00) fee; and

29 (e) Remit the remainder to the state treasurer; and

30 (f) Deposit seventeen dollars and fifty cents (\$17.50) from each fee
31 for a class D skills test into the county current expense fund, unless
32 the test is administered by a department-approved contractor, in which
33 case the contractor shall be entitled to seventeen dollars and fifty
34 cents (\$17.50) of each fee.

35 (7) When the fees required under this section are collected by a state
36 officer or agency, they shall be paid over to the state treasurer.

37 (8) The state treasurer shall distribute the moneys received from fees
38 imposed by the provisions of this section, whether collected by a county of-
39 ficer or by a state officer or agency as follows:

40 (a) Two dollars (\$2.00) of each fee for a four-year driver's license
41 or seasonal driver's license, and four dollars (\$4.00) of each fee for
42 an eight-year class D driver's license, and one dollar and fifty cents
43 (\$1.50) of each fee charged for driver's licenses pursuant to subsec-
44 tions (1) (b), (d) and (e) of this section, and fifty cents (50¢) of each
45 fee charged for driver's licenses pursuant to subsections (1) (c) and
46 (f) of this section, shall be deposited in the emergency medical ser-
47 vices fund II created in section 56-1018A, Idaho Code, and four dollars
48 (\$4.00) of each fee charged pursuant to subsections (1) (a), (g) and (s)
49 of this section and eight dollars (\$8.00) of each fee charged pursuant
50 to subsection (1) (h) of this section and three dollars (\$3.00) of each

1 fee for driver's licenses pursuant to subsections (1) (b), (d) and (e)
2 of this section, and one dollar (\$1.00) of each fee charged for driver's
3 licenses pursuant to subsections (1) (c) and (f) of this section shall be
4 deposited in the emergency medical services fund III created in section
5 56-1018B, Idaho Code; and

6 (b) Twenty-eight dollars (\$28.00) of each fee for a seasonal or class A,
7 B or C driver's license, and nineteen dollars and fifty cents (\$19.50)
8 of each fee charged for a license pursuant to subsection (1) (b) of this
9 section, and eight dollars and sixteen cents (\$8.16) of each fee charged
10 for a license pursuant to subsection (1) (c) of this section shall be de-
11 posited in the state highway account; and

12 (c) Twenty dollars (\$20.00) of each fee for a commercial learner's per-
13 mit or driver's license classification change shall be deposited in the
14 state highway account; and

15 (d) Four dollars (\$4.00) of each fee for a commercial learner's permit
16 shall be deposited in the emergency medical services fund III created in
17 section 56-1018B, Idaho Code; and

18 (e) Ten dollars (\$10.00) of each fee for a duplicate seasonal or class
19 A, B or C driver's license, class A, B or C driver's license extension,
20 or additional endorsement shall be deposited in the state highway ac-
21 count; and

22 (f) Seven dollars and fifty cents (\$7.50) of each fee for a motorcycle
23 endorsement and motorcycle endorsement instruction permit shall be de-
24 posited in the state highway account; and

25 (g) Five dollars and thirty cents (\$5.30) of each fee for a four-year
26 class D driver's license, and ten dollars and sixty cents (\$10.60) of
27 each fee for an eight-year class D driver's license, and four dollars
28 (\$4.00) of each fee charged for a license pursuant to subsections (1) (d)
29 and (e) of this section, and one dollar and thirty-three cents (\$1.33)
30 of each fee charged for a license pursuant to subsection (1) (f) of this
31 section shall be deposited in the driver training fund; and

32 (h) Twelve dollars and seventy cents (\$12.70) of each fee for a
33 four-year class D driver's license, and twenty dollars and forty cents
34 (\$20.40) of each fee for an eight-year class D driver's license, and ten
35 dollars and fifty cents (\$10.50) of each fee charged for a license pur-
36 suant to subsections (1)(d) and (e) of this section, and six dollars and
37 eighty-three cents (\$6.83) of each fee charged for a license pursuant
38 to subsection (1) (f) of this section shall be deposited in the highway
39 distribution fund; and

40 (i) Two dollars and sixty cents (\$2.60) of each fee for a class D in-
41 struction permit, duplicate class D license or permit, and class D li-
42 cense extension shall be deposited in the driver training fund; and

43 (j) Seven dollars and forty cents (\$7.40) of each fee for a class D
44 instruction permit, duplicate class D license or permit, and class D
45 license extension shall be deposited in the highway distribution fund;
46 and

47 (k) Ten dollars (\$10.00) of each fee for a class A, B or C skills test
48 shall be deposited in the state highway account; and

49 (l) One dollar (\$1.00) of each fee for a class A, B, C or four-year D
50 driver's license, and two dollars (\$2.00) of each fee for an eight-year

1 class D driver's license, and one dollar (\$1.00) of each fee charged for
 2 a license pursuant to subsections (1) (b), (d) and (e) of this section,
 3 and thirty-four cents (34¢) of each fee charged for a license pursuant
 4 to subsections (1) (c) and (f) of this section shall be deposited in the
 5 motorcycle safety program fund established in section 33-4904, Idaho
 6 Code; and

7 (m) Six dollars and fifty cents (\$6.50) of each fee for a class D skills
 8 test shall be deposited into the state highway account.

9 (9) The contractor administering a class A, B or C skills test shall be
 10 entitled to not more than ~~sixty two hundred~~ dollars (~~\$60.00~~200) of the skills
 11 test fee. A contractor administering a class A, B or C skills test may col-
 12 lect an additional fee for the use of the contractor's vehicle for the skills
 13 test.

14 (10) Sixty dollars (\$60.00) of each restricted driving permit and each
 15 restricted school attendance driving permit shall be deposited in the state
 16 highway account.

17 (11) The department may issue seasonal class B or C driver's licenses to
 18 drivers who are employees of agri-chemical businesses, custom harvesters,
 19 farm retail outlets and suppliers, and livestock feeders that:

20 (a) Will only be valid for driving commercial vehicles that normally
 21 require class B or C commercial driver's licenses;

22 (b) Will be valid for seasonal periods that begin on the date of is-
 23 suance and that are not to exceed one hundred eighty (180) days in a
 24 twelve (12) month period;

25 (c) May only be obtained twice in a driver's lifetime;

26 (d) Are valid only within a one hundred fifty (150) mile radius of the
 27 place of business or farm being serviced; and

28 (e) Will be valid only in conjunction with valid Idaho class D driver's
 29 licenses.

30 (12) The department may issue seasonal class B or C driver's licenses to
 31 drivers who:

32 (a) Have not violated the single license provisions of applicable fed-
 33 eral regulations;

34 (b) Have not had any license suspensions, revocations or cancella-
 35 tions;

36 (c) Have not had any convictions in any vehicle for any offense listed
 37 in section 49-335(1) or (2), Idaho Code, or any one (1) serious traffic
 38 offense;

39 (d) Have at least one (1) year of driving experience with a class D or
 40 equivalent license in any type motor vehicle; and

41 (e) Are at least sixteen (16) years old.

42 SECTION 2. That Section 49-306, Idaho Code, as amended by Section 6,
 43 Chapter 54, Laws of 2015, be, and the same is hereby amended to read as fol-
 44 lows:

45 49-306. APPLICATION FOR DRIVER'S LICENSE, INSTRUCTION PERMIT,
 46 COMMERCIAL LEARNER'S PERMIT OR RESTRICTED SCHOOL ATTENDANCE DRIVING PER-
 47 MIT. (1) Every application for any instruction permit, restricted school
 48 attendance driving permit, or for a driver's license shall be made upon a
 49 form furnished by the department and shall be verified by the applicant be-

fore a person authorized to administer oaths. Officers and employees of the department and sheriffs and their deputies are authorized to administer the oaths without charge. Every application for a permit, extension or driver's license shall be accompanied by the following fee, none of which is refundable:

(a) Class A, B, C (4-year) license with endorsements -- age 21 years and older	\$40.00
(b) Class A, B, C (3-year) license with endorsements -- age 18 to 21 years	\$30.00
(c) Class A, B, C (1-year) license with endorsements -- age 20 years	\$15.00
(d) Class D (3-year) license -- under age 18 years	\$25.00
(e) Class D (3-year) license -- age 18 to 21 years	\$25.00
(f) Class D (1-year) license -- age 17 years or age 20 years	\$15.00
(g) Four-year Class D license -- age 21 years and older	\$30.00
(h) Eight-year Class D license -- age 21 to 63 years	\$55.00
(i) Commercial learner's permit	\$29.00
(j) Class D instruction permit or supervised instruction permit	\$15.00

(2) A person who applies for a driver's license or a driver's license renewal may designate a voluntary contribution of two dollars (\$2.00) for the purpose of promoting and supporting organ donation. Such a contribution shall be treated as a voluntary contribution to the organ donation contribution fund created in section 49-2447, Idaho Code, and not as a driver's license fee.

(3) Every application shall state the true and full name, date of birth, sex, declaration of Idaho residency, Idaho residence address and mailing address, if different, of the applicant, height, weight, hair color, and eye color, and the applicant's social security number as verified by the social security administration. If an applicant has submitted an application pursuant to the provisions of chapter 58, title 19, Idaho Code, then the applicant may state, in his or her application pursuant to this section, the applicant's alternative Idaho mailing address in place of his or her Idaho residence address and mailing address. Notwithstanding the provisions of section 49-303(13), Idaho Code, an applicant for a nondomiciled class A, B or

1 C driver's license or nondomiciled commercial learner's permit having res-
 2 idency in a state that is prohibited from issuing class A, B or C driver's
 3 licenses or commercial learner's permits, as provided in 49 CFR 384, is ex-
 4 cepted from providing proof of Idaho residency and an Idaho mailing address.

5 (a) The requirement that an applicant provide a social security number
 6 as verified by the social security administration shall apply only to
 7 applicants who have been assigned a social security number.

8 (b) An applicant who has not been assigned a social security number
 9 shall:

10 (i) Present written verification from the social security admin-
 11 istration that the applicant has not been assigned a social secu-
 12 rity number; and

13 (ii) Submit a birth certificate, passport or other documentary
 14 evidence issued by an entity other than a state or the United
 15 States; and

16 (iii) Submit such proof as the department may require that the ap-
 17 plicant is lawfully present in the United States.

18 A driver's license, commercial learner's permit or any instruction
 19 permit issued on and after January 1, 1993, shall not contain an appli-
 20 cant's social security number. Applications on file shall be exempt
 21 from disclosure except as provided in sections 49-202, 49-203, 49-203A
 22 and 49-204, Idaho Code.

23 (c) Every application for a class A, B or C license shall state where the
 24 applicant has been licensed for the preceding ten (10) years and under
 25 which of the following driving categories the applicant will operate:

26 (i) Non-excepted interstate. The applicant operates or expects
 27 to operate in interstate commerce, and is required to provide a
 28 medical examiner's certificate;

29 (ii) Excepted interstate. The applicant operates or expects to
 30 operate in interstate commerce, but engages exclusively in trans-
 31 portation or operations excepted by the federal motor carrier
 32 safety administration from all or parts of the qualification re-
 33 quirements of federal motor carrier safety regulation 49, part
 34 391, and is therefore not required to provide a medical examiner's
 35 certificate;

36 (iii) Non-excepted intrastate. The applicant operates only in
 37 intrastate commerce and is subject to and meets all Idaho driver
 38 qualification requirements and the applicable parts of federal
 39 motor carrier safety regulation 49, part 391, and is required to
 40 provide a medical examiner's certificate; or

41 (iv) Excepted intrastate. The applicant operates in intrastate
 42 commerce, but engages exclusively in exempted transportation or
 43 operations as listed in section 67-2901B(2), Idaho Code, and the
 44 applicable parts of federal motor carrier safety regulation 49,
 45 part 391, and is therefore not required to provide a medical exam-
 46 iner's certificate.

47 All applications shall also state whether the applicant has previ-
 48 ously been licensed as a driver, and if so, when and by what state or
 49 country, and whether a driver's license or privileges have ever been
 50 suspended, revoked, denied, disqualified, canceled or whether an ap-

1 plication has ever been refused, and if so, the date of and reason for
2 the suspension, revocation, denial, disqualification, cancellation

37 (5) Whenever the department receives a request for a driver's record
38 from another licensing jurisdiction, the record shall be forwarded without
39 charge.

40 (6) The department shall contact and notify the commercial driver li-
41 cense information system of the proposed application for a class A, B or C
42 driver's license or commercial learner's permit to ensure identification of
43 the person and to obtain clearance to issue the license.

44 (7) When the fees required under this section are collected by a county
45 officer, they shall be paid over to the county treasurer not less often than
46 monthly, who shall immediately:

47 (a) Deposit an amount equal to five dollars (\$5.00) from each driver's
48 license except an eight-year class D license, or any class D instruction
49 permit application fees, application for a duplicate driver's license
50 or permit, classification change, seasonal driver's license and addi-

1 tional endorsement, and ten dollars (\$10.00) from each eight-year class
2 D driver's license, in the current expense fund;

3 (b) Deposit two dollars and fifty cents (\$2.50) from each motorcycle
4 endorsement and motorcycle endorsement instruction permit fee in the
5 current expense fund;

6 (c) Deposit an amount equal to three dollars (\$3.00) from each fee for a
7 knowledge test in the current expense fund;

8 (d) Deposit an amount equal to ten dollars (\$10.00) from each fee for
9 a motorcycle endorsement skills test in the current expense fund; pro-
10 vided however, if a contractor administers the skills test he shall be
11 entitled to the ten dollar (\$10.00) fee;

12 (e) Remit the remainder to the state treasurer; and

13 (f) Deposit seventeen dollars and fifty cents (\$17.50) from each fee
14 for a class D skills test into the county current expense fund, unless
15 the test is administered by a department-approved contractor, in which
16 case the contractor shall be entitled to seventeen dollars and fifty
17 cents (\$17.50) of each fee.

18 (8) When the fees required under this section are collected by a state
19 officer or agency, they shall be paid over to the state treasurer.

20 (9) The state treasurer shall distribute the moneys received from fees
21 imposed by the provisions of this section, whether collected by a county of-
22 ficer or by a state officer or agency as follows:

23 (a) Two dollars (\$2.00) of each fee for a four-year driver's license
24 or seasonal driver's license, and four dollars (\$4.00) of each fee for
25 an eight-year class D driver's license, and one dollar and fifty cents
26 (\$1.50) of each fee charged for driver's licenses pursuant to subsec-
27 tion (1) (b), (d) and (e) of this section, and fifty cents (50¢) of each

31 (\$4.00) of each fee charged pursuant to subsection (1) (a), (g) and (s)
32 of this section and eight dollars (\$8.00) of each fee charged pursuant
33 to subsection (1) (h) of this section and three dollars (\$3.00) of each
34 fee for driver's licenses pursuant to subsection (1) (b), (d) and (e) of
35 this section, and one dollar (\$1.00) of each fee charged for driver's
36 licenses pursuant to subsection (1) (c) and (f) of this section shall be
37 deposited in the emergency medical services fund III created in section
38 56-1018B, Idaho Code;

39 (b) Twenty-eight dollars (\$28.00) of each fee for a seasonal or class A,
40 B or C driver's license, and nineteen dollars and fifty cents (\$19.50)
41 of each fee charged for a license pursuant to subsection (1) (b) of this
42 section, and eight dollars and sixteen cents (\$8.16) of each fee charged
43 for a license pursuant to subsection (1) (c) of this section shall be de-
44 posited in the state highway account;

45 (c) Twenty dollars (\$20.00) of each fee for a commercial learner's per-
46 mit or driver's license classification change shall be deposited in the
47 state highway account;

48 (d) Four dollars (\$4.00) of each fee for a commercial learner's permit
49 shall be deposited in the emergency medical services fund III created in
50 section 56-1018B, Idaho Code;

1 (e) Ten dollars (\$10.00) of each fee for a duplicate seasonal or class
2 A, B or C driver's license, class A, B or C driver's license extension,
3 or additional endorsement shall be deposited in the state highway ac-
4 count;

5 (f) Seven dollars and fifty cents (\$7.50) of each fee for a motorcycle
6 endorsement and motorcycle endorsement instruction permit shall be de-
7 posited in the state highway account;

8 (g) Five dollars and thirty cents (\$5.30) of each fee for a four-year
9 class D driver's license, and ten dollars and sixty cents (\$10.60) of
10 each fee for an eight-year class D driver's license, and four dollars
11 (\$4.00) of each fee charged for a license pursuant to subsection (1) (d)
12 and (e) of this section, and one dollar and thirty-three cents (\$1.33)
13 of each fee charged for a license pursuant to subsection (1) (f) of this
14 section shall be deposited in the driver training fund;

15 (h) Twelve dollars and seventy cents (\$12.70) of each fee for a
16 four-year class D driver's license, and twenty dollars and forty cents
17 (\$20.40) of each fee for an eight-year class D driver's license, and ten
18 dollars and fifty cents (\$10.50) of each fee charged for a license pur-
19 suant to subsection (1) (d) and (e) of this section, and six dollars and
20 eighty-three cents (\$6.83) of each fee charged for a license pursuant
21 to subsection (1) (f) of this section shall be deposited in the highway
22 distribution fund;

23 (i) Two dollars and sixty cents (\$2.60) of each fee for a class D in-
24 struction permit, duplicate class D license or permit, and class D li-
25 cense extension shall be deposited in the driver training fund;

26 (j) Seven dollars and forty cents (\$7.40) of each fee for a class D in-
27 struction permit, duplicate class D license or permit, and class D li-
28 cense extension shall be deposited in the highway distribution fund;

29 (k) Ten dollars (\$10.00) of each fee for a class A, B or C skills test
30 shall be deposited in the state highway account;

31 (l) One dollar (\$1.00) of each fee for a class A, B, C or four-year D
32 driver's license, and two dollars (\$2.00) of each fee for an eight-year
33 class D driver's license, and one dollar (\$1.00) of each fee charged for
34 a license pursuant to subsection (1) (b), (d) and (e) of this section,
35 and thirty-four cents (34¢) of each fee charged for a license pursuant
36 to subsection (1) (c) and (f) of this section shall be deposited in the
37 motorcycle safety program fund established in section 33-4904, Idaho
38 Code;

39 (m) Six dollars and fifty cents (\$6.50) of each fee for a class D skills
40 test shall be deposited into the state highway account; and

41 (n) Each voluntary contribution of two dollars (\$2.00) as described in
42 subsection (2) of this section, less actual administrative costs asso-
43 ciated with collecting and transferring such contributions, shall be
44 deposited into the organ donation contribution fund created in section
45 49-2447, Idaho Code.

46 (10) The contractor administering a class A, B or C skills test shall be
47 entitled to not more than ~~sixty two hundred~~ two hundred dollars (~~\$60.00~~200) of the skills
48 test fee. A contractor administering a class A, B or C skills test may col-
49 lect an additional fee for the use of the contractor's vehicle for the skills
50 test.

1 (11) Sixty dollars (\$60.00) of each restricted driving permit and each
2 restricted school attendance driving permit shall be deposited in the state
3 highway account.

4 (12) The department may issue seasonal class B or C driver's licenses to
5 drivers who are employees of agri-chemical businesses, custom harvesters,
6 farm retail outlets and suppliers, and livestock feeders that:

7 (a) Will only be valid for driving commercial vehicles that normally
8 require class B or C commercial driver's licenses;

9 (b) Will be valid for seasonal periods that begin on the date of is-
10 suance and that are not to exceed one hundred eighty (180) days in a
11 twelve (12) month period;

12 (c) May only be obtained twice in a driver's lifetime;

13 (d) Are valid only within a one hundred fifty (150) mile radius of the
14 place of business or farm being serviced; and

15 (e) Will be valid only in conjunction with valid Idaho class D driver's
16 licenses.

17 (13) The department may issue seasonal class B or C driver's licenses to
18 drivers who:

19 (a) Have not violated the single license provisions of applicable fed-
20 eral regulations;

21 (b) Have not had any license suspensions, revocations or cancella-
22 tions;

23 (c) Have not had any convictions in any vehicle for any offense listed
24 in section 49-335(1) or (2), Idaho Code, or any one (1) serious traffic
25 offense;

26 (d) Have at least one (1) year of driving experience with a class D or
27 equivalent license in any type motor vehicle; and

28 (e) Are at least sixteen (16) years old.

29 SECTION 3. Section 2 of this act shall be in full force and effect when
30 the Idaho Transportation Department submits to the Secretary of State in
31 writing that the Idaho Transportation Department's information technology
32 system has been updated to support the Organ Donation Contribution Fund.
