Since 2010, the IDHW has used their rulemaking authority to create an exemption form required by licensed daycares and schools for children whose parents have decided for one reason or another not to follow Idaho's immunization mandates. I have personally contacted multiple legislators on the illegality of their form since it is not in harmony with state statute and, furthermore, compels the parent to sign a form with statements that they do not agree with. At first, we recommended that parents simply put an X across the entire document and affix it to their notarized affidavit, submitting this to the school/daycare. Unfortunately, the governor's office told us that this was not acceptable, that the form could be adjusted with add ons and cross outs but that parents HAD to use this form to be allowed into a licensed daycare or school in Idaho. Furthermore, the Idaho AG told us that the only thing we could do was have the situation corrected by the legislature -- that is YOU. So while it is generally understood that state statutes trump agency's admin. rules, certainly, this is not what is being practised in the state of Idaho. Please remember that RS 25031 has NOTHING to do with being pro-vaccine or anti-vaccine. This proposed bill is about forcing IDHW to follow state law. I have heard countless stories from around the state. Many health departments told parents they were not allowed to alter the document in any way. Why? The reason they were told is that it was a LEGAL document. Precisely my point. You cannot force someone to affix their signature to a form that has statements that are not true and violate a parents rights. Any time you affix your signature to ANYTHING, you are agreeing to the information above your signature.
