SENATE BILL NO. 1352

AN ACT

RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR FISCAL YEAR 2020; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE CHILD WELFARE AND FOSTER AND ASSISTANCE PAYMENTS PROGRAMS FOR FISCAL YEAR 2020; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE CHILD WELFARE PROGRAM FOR FISCAL YEAR 2020; AND DECLARING AN EMERGENCY.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. In addition to the appropriation made in Section 1, Chapter 237, Laws of 2019, and any other appropriation provided by law, there is hereby appropriated to the Department of Health and Welfare the following amounts to be expended according to the designated programs and expense classes from the listed funds for the period July 1, 2019, through June 30, 2020:

1 SECTION 2. Notwithstanding any other provision of law to the contrary,
2 the appropriation made to the Department of Health and Welfare for the Child
3 Welfare Program in Section 1, Chapter 237, Laws of 2019, from the Cooperative
4 Welfare (Dedicated) Fund is hereby reduced by \$555,600 for trustee and bene-
5 fit payments for the period July 1, 2019, through June 30, 2020.

6 SECTION 3. An emergency existing therefor, which emergency is hereby
7 declared to exist, this act shall be in full force and effect on and after its
8 passage and approval.
