A HOUSE RESOLUTION

2 STATING FINDINGS OF THE HOUSE OF REPRESENTATIVES AND APPROVING THE RECESS
3 OF THE HOUSE OF REPRESENTATIVES OF THE FIRST REGULAR SESSION OF THE
4 SIXTY-SIXTH IDAHO LEGISLATURE SUBJECT TO THE CALL OF THE SPEAKER OF THE
5 HOUSE OF REPRESENTATIVES NO LATER THAN DECEMBER 31, 2021, PROVIDING
6 THAT NO UNVOUCHERED OR VOUCHERED EXPENSE ALLOWANCE SHALL BE PAYABLE TO
7 ANY MEMBER OF THE HOUSE OF REPRESENTATIVES FOR THE TIME PERIOD DURING
8 SUCH TEMPORARY ADJOURNMENT WITHOUT THE APPROVAL OF THE SPEAKER OF THE
9 HOUSE OF REPRESENTATIVES, AND PROVIDING THAT INTERIM COMMITTEES AND
10 WORKING GROUPS ESTABLISHED BY THE IDAHO LEGISLATURE MAY CONTINUE THEIR
11 WORK DURING THE HOUSE OF REPRESENTATIVES' RECESS.

12 Be It Resolved by the House of Representatives of the State of Idaho:

13 WHEREAS, the House of Representatives of the First Regular Session of
14 the Sixty-sixth Idaho Legislature convened on January 11, 2021, and contin-
15 ues in session as of the date of introduction of this resolution; and

16 WHEREAS, Section 9, Article III of the Constitution of the State of
17 Idaho states "neither house shall, without the concurrence of the other,
18 adjourn for more than three days"; and

19 WHEREAS, the members of the House of Representatives of the First Regu-
20 lar Session of the Sixty-sixth Idaho Legislature desire to recess subject to
21 the call of the Speaker of the House of Representatives no later than Decem-
22 ber 31, 2021; and

23 WHEREAS, the approved motion by the Citizens' Committee on Legislative
24 Compensation determined that, if the House of Representatives, by passage
25 of a resolution, adjourns to a day certain for more than three days, no un-
26 vouchered or vouchered expense allowance shall be payable to any member of
27 the House of Representatives for the time period during such temporary ad-
28 journment without the approval from the Speaker of the House of Representa-
29 tives; and

30 WHEREAS, interim committees and working groups established by the Idaho
31 Legislature may continue their work during the House of Representatives' re-
32 cess.

33 NOW, THEREFORE, BE IT RESOLVED by the members of the House of Represent-
34 atives of the First Regular Session of the Sixty-sixth Idaho Legislature,
35 that the House of Representatives of the First Regular Session of the Sixty-
36 sixth Idaho Legislature shall recess subject to the call of the Speaker of
37 the House of Representatives no later than December 31, 2021.

38 BE IT FURTHER RESOLVED that no unvouchered or vouchered expense al-
39 lowance shall be payable to any member of the House of Representatives for
40 the time period during such temporary adjournment without the approval of
41 the Speaker of the House of Representatives.

1 BE IT FURTHER RESOLVED that interim committees and working groups es-
2 tablished by the Idaho Legislature may continue their work during the recess
3 of the House of Representatives.
