IDAPA 16.01.06 - Emergency Medical Services (EMS) -- Data Collection and Submission Requirements (Chapter Repeal) - Proposed Rule (Docket No. 16-0106-2201)

Summary and Stated Reasons for the Rule

Docket No. 16-0103-2201: This proposed rule, regarding emergency medical services, incorporates language from another rule that is being repealed under the docket described below. The language concerns the incorporation by reference of the EMS Data Collection Standards Manual as well as language regarding certain records.

Docket No. 16-0106-2201: This proposed rule repeals an existing chapter of rules that is no longer necessary, except for the language being retained in the docket described above.

Negotiated Rulemaking / Fiscal Impact

Negotiated rulemaking was not conducted for either rule, as no new language is being added. These dockets are merely repealing unnecessary language and incorporating existing language in another rule.

Neither rule is anticipated to have a negative fiscal impact on the state general fund.

Statutory Authority

This rulemaking appears to be authorized pursuant to Sections 56-1003 and 56-1023, Idaho Code.

AUTHORITY: In compliance with Section 67-5221(1), Idaho Code, notice is hereby given that this agency has initiated proposed rulemaking procedures. The action is authorized pursuant to Sections 56-1003 and 56-1023, Idaho Code.

PUBLIC HEARING SCHEDULE: Public hearing(s) concerning this rulemaking will be scheduled if requested in writing by twenty-five (25) persons, a political subdivision, or an agency, not later than July 20, 2022.

The hearing site(s) will be accessible to persons with disabilities. Requests for accommodation must be made not later than five (5) days prior to the hearing, to the agency address below.

DESCRIPTIVE SUMMARY: The following is a nontechnical explanation of the substance and purpose of the proposed rulemaking:

This rulemaking adds rule language to IDAPA 16.01.03 that is being relocated from IDAPA 16.01.06, a rule chapter being repealed under a separate rulemaking, Docket No. 16-0106-2201. The Department determined that several small sections in IDAPA 16.01.06 needed to remain in rule, so suitable places were found for them to reside in IDAPA 16.01.03.

FEE SUMMARY: The following is a specific description of the fee or charge imposed or increased: N/A

FISCAL IMPACT: The following is a specific description, if applicable, of any negative fiscal impact on the state general fund greater than ten thousand dollars (\$10,000) during the fiscal year resulting from this rulemaking:

This rulemaking is not anticipated to have any fiscal impact on the State General Fund, or any other known funds.

NEGOTIATED RULEMAKING: Pursuant to Section 67-5220(2), Idaho Code, negotiated rulemaking was not conducted because no new rules are being added to this chapter. This rulemaking simply preserves several sections of rule deemed necessary from IDAPA 16.01.06 by moving them into this chapter.

INCORPORATION BY REFERENCE: Pursuant to Section 67-5229(2)(a), Idaho Code, the following is a brief synopsis of why the materials cited are being incorporated by reference into this rule:

The EMS Data Collection Standards Manual, Edition 2023-1, is being incorporated by reference in this docket. It provides the standard for data collection by licensed EMS agencies. This document was previously incorporated into IDAPA 16.01.06 which is being repealed; however, since this document is necessary for the administration of the Idaho EMS program, it being incorporated into this chapter of rule.

03. **Time Frame for Submitting Records.** Submit each month’s data to the Department by the 15th of the following month in a format determined by the Department. ()

SUMMARY of Changes -- Incorporation by Reference
Data Collection Standards Manual, Edition 2023-1
IDAPA 16.01.03, "EMS Agency Licensing Requirements"

The Bureau of EMS and Preparedness reports to the National Emergency Medical Services Information System (NEMSIS). NEMSIS is a universal standard for how patient care information resulting from prehospital EMS activations is collected. This practice was enacted in Idaho in 2011 after recommendations from numerous internal and external stakeholders.

The NEMSIS data system undergoes regular updates. The previous Data Collection Standards Manual 2017-1 was written with NEMSIS v3.4 data reporting requirements, which have now been upgraded to NEMSIS v3.5. NEMSIS v3.4 data will no longer be accepted after 12/31/2023. Beginning 1/1/2024, NEMSIS will only accept data using the v.3.5 format. The changes in the new Data Collection Standards Manual 2023-1 specifies this change and lists the new data elements required by NEMSIS v3.5.

The only additional changes reflected in the **Data Collection Standards Manual 2023-1** is the elimination of extraneous language that is no longer necessary.

I. Definitions

ePCR

Electronic prehospital patient care report.

Idaho ePCR Data Repository

Idaho prehospital patient care reporting and data collection system.

NEMSIS

National EMS Information System (NEMSIS) is the national repository used to store national EMS data. NEMSIS sets the uniform data conventions and structure for the Data Dictionary. NEMSIS collects and provides aggregate data available for analysis and research through its technical assistance center accessed at <http://www.nemsis.org>.

II. Data Standard

EMS agencies holding an EMS agency license in the State of Idaho are required to submit ePCR data to the Idaho ePCR Data Repository. EMS agencies can submit ePCR data using either an Idaho state-sponsored ePCR system or NEMSIS compliant ePCR software for “Collection” of NEMSIS data elements. See the NEMSIS website for a list of approved software:

<http://www.nemsis.org/v3/compliantSoftware.html>. The information submitted must conform to this data standard and the data element list in the appendices of this document.

III. Data Reporting

Current NEMSIS Version: NEMSIS v3.4 is the current Idaho EMS data standard. NEMSIS v3.4 data elements are listed in Appendix A. NEMSIS v3.4 will remain the reporting standard until December 31, 2023, at which time NEMSIS v3.4 submissions will no longer be accepted.

Future NEMSIS Version: Beginning no later than January 1, 2024, each Idaho EMS agency will be required to submit data that is compliant with NEMSIS v3.5. The data elements compliant with NEMSIS v3.5 are listed in **Appendix B**.

Transition to V3.5: NEMSIS v3.5 is scheduled to be available by July 1, 2023. It is recommended that agencies begin the transition process prior to the sunset date of the v3.4 standard.
