1 AN ACT
2 RELATING TO FISH AND GAME; AMENDING SECTION 36-416, IDAHO CODE, TO PROVIDE
3 FOR A CERTAIN FUR BUYER LICENSE; AMENDING SECTION 36-602, IDAHO CODE, TO
4 REVISE PROVISIONS REGARDING TAXIDERMIST AND FUR BUYER'S LICENSES; AND
5 DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. That Section 36-416, Idaho Code, be, and the same is hereby
8 amended to read as follows:

9 36-416. SCHEDULE OF LICENSE FEES. As used in this section, "N/A" means
10 "not available."

15 SECTION 2. That Section 36-602, Idaho Code, be, and the same is hereby
16 amended to read as follows:

17 36-602. LICENSE FEES -- EXPIRATION. (a) Resident Taxidermist and Fur
18 Buyer's License. A fee as specified in section 36-416, Idaho Code, shall be
19 charged for a resident taxidermist and fur buyer's license.

20 (b) Nonresident Taxidermist and Fur Buyer's License. ~~Nonresidents~~
21 ~~shall pay an amount equal to that charged Idaho residents in the state of~~
22 ~~the applicant for the license. In cases where the state of the applicant~~
23 ~~requires more than one (1) license, the cost shall be the total of all li-~~
24 ~~enses required of an Idaho resident to engage in similar activities in the~~
25 ~~state of the applicant. In no case shall this amount be less than the A fee as~~
26 ~~specified in section 36-416, Idaho Code, shall be charged for a nonresident~~
27 ~~taxidermist and fur buyer annual license.~~

28 (c) A fee as specified in section 36-416, Idaho Code, shall be charged
29 for a nonresident 3-day fur buyer license, available only to nonresidents
30 who are temporarily in the state to engage in the business of buying raw
31 hides, skins, pelts, or parts as set forth in section 36-601, Idaho Code.

32 (d) The department shall promulgate rules implementing the provisions
33 of this section.

34 ~~(e)~~ (e) The expiration date for taxidermist and fur buyer's licenses
35 shall be June 30 of the fifth year next following the date of issuance for
36 five (5) year licenses and June 30 next following the date of issuance for one
37 (1) year licenses.

38 SECTION 3. An emergency existing therefor, which emergency is hereby
39 declared to exist, this act shall be in full force and effect on and after
40 July 1, 2023.
