Medicaid remains laser focused on three priorities:

Provider sustainability:

- 2022 rate increases for Home & Community Based Services (HCBS) providers.
- New supplemental payment for ground emergency medical transportation.

System transformation:

- Soon to be awarded new Idaho Behavioral Health Plan (IBHP) contract.
- Modernization of the Medicaid Management Information System (MMIS).



Cost containment:

- Second year of value-based payments agreements with 11 value care organizations.
- Year 2 now includes Medicaid Expansion.
