Chairman Holtzclaw called the meeting to order at 1:29 p.m.

MOTION: Rep. Wheeler made a motion to approve the minutes from January 17, 2023.

Motion carried by voice vote.

MOTION: Rep. Weber made a motion to introduce RS 29947C1, RS 29920C1, RS 29955C1,

RS 29949C1, RS 29957C1.

RS 29947C1: Rep. Bundy presented RS 29947C1, proposed legislation updating Title 67

Chapter 53 and Title 59 Chapter 16, relating to the personnel system, by removing outdated language and practices. He stated the changes would ensure best standard practices are applied to development of statewide enterprise resource

planning.

Rep. Bundy introduced **Michelle Peugh**, HR Policy and Program Officer for the Division of Human Resources, who provided an introduction to **RS 29947C1**. She advised **RS 29947C1** provides clarification for how state law is applied to state employees, ensuring employee best practice standards are applied to all state

agencies.

RS 29920C1: Rep. Bundy presented RS 29920C1, legislation providing clarification within

established compensation practices by adding language to 67-5309B and 59-1603 to require a current evaluation to be on file for salary increases based on performance. He stated **RS 29920C1** also enabled salary increases based

on internal equity or market changes.

Michelle Peugh explained **RS 29920C1** creates flexibility within established compensation practices. She stated the changes would address challenges agencies face in recruitment and retention. She said current statutes relating to

employee compensation are restrictive and do not allow for effective pay strategies.

RS 29955C1: Rep. Bundy presented RS 29955C1, legislation updating the agency name the to

"Division of Human Resources" from the previous agency name of the "Personnel Commission" outlined in 67-3519. Rep. Bundy noted **RS 29955C1** adds the

statement "pay or" before "pay grade" in order to match current practice.

Michelle Peugh explained **RS 29955C1** updates three sections of code as they relate to the name and responsibility of the Division of Human Resources and the

organization and purpose of the Idaho Personnel Commission.

RS 29949C1:

Rep. Bundy presented **RS 29949C1**, legislation adding language to Idaho Code 67-5302 to waive the 1,385 hour limit for employees hired specifically as apprentices under an approved apprenticeship program. Rep. Bundy noted that hiring youth apprentices will be another tool agency heads can utilize to recruit and retain employees more effectively.

Michelle Peugh explained the purpose of **RS 29949C1** was to add an additional option under temporary employment for the State of Idaho to hire apprentices. She noted that last year the Work Force Development Council worked with the legislature to pass legislation that allows individuals under public apprenticeship programs to be state employees.

She advised **RS 29949C1** will support agencies if apprenticeships are implemented within the agency. She testified that **RS 29949C1** would permit **Lori Wolff**, administrator of the Division of Human Resources, to approve an employee to be a temporary employee, with no hour limit restriction, as long as they had an approved apprenticeship program at their agency.

RS 29957C1:

Rep. Bundy presented **RS 29957C1**, legislation to allow for flexibility and clarification related to overtime calculation for certain employees. Rep. Bundy stated that typically time worked in excess of 40 hours per workweek constitutes overtime. He added the proposed language adds another option for overtime calculation within established wage and hour laws. Rep. Bundy testified that certain employees who meet federal exemption requirements will have overtime calculated for time worked in excess of 80 hours in a period of 14 consecutive days. Rep. Bundy noted that **RS 29957C1** meets a specific request from the Department of Veterans Affairs for nurses that tend to work 12 hours shifts.

Michelle Peugh explained **RS 29957C1** allows agencies flexibility in scheduling employees with irregular shifts to align with industry standards. She noted the current standard is 8 hours in a 40 hour work week, which has become inflexible. She noted the inability of the agency to schedule nurses over an 80 hour pay period was the number one complaint or employees or applicants when Veterans Services and Health and Welfare try to hire nurses.

VOTE ON MOTION:

Chairman Holtzclaw called for a vote on the motion to introduce RS 29947C1, RS 29920C1, RS 29955C1, RS 29949C1, RS 29957C1. Motion carried by voice vote.

RS 30035:

Rep. Rubel presented **RS 30035**, legislation which removes the sunset clause of Idaho Code 72-451; making this statute permanent. She stated **RS 30035** provides permanent coverage under workers compensation for post traumatic stress injuries suffered by first responders. Rep. Rubel introduced **Rob Shoplock**, President of the Professional Firefighters of Idaho.

Rob Shoplock noted that as of 2023 first responder work compensation rates are lower than what they were prior to 2019.

MOTION:

Rep. Horman made a motion to introduce RS 30035 Motion carried by voice vote.

RS 30041:

Rep. Blanksma presented **RS 30041**, legislation to expand the Idaho Launch Program to eligible High School Graduates starting in 2024. She stated that eligible graduates can receive a grant of \$8,500, noting the Workforce Development Council would determine grants based upon job necessity and the job market. She noted **RS 30041** includes sunsets.

In response to questions from Committee members, **Rep. Blanksma** explained that means-testing would be secondary to the market demand for jobs. She explained the Workforce Development Council would develop the grants process means testing. She added this would be based upon how many requests would be made for grants, as the funds for the program are capped.

MOTION:

Rep. Wheeler made a motion to introduce RS 30041. Motion carried by voice vote.

DOCKET NO. 15-0401-2201:

Michelle Peugh presented **Docket No. 15-0401-2201**, a pending rule regarding the Rules of the Division of Human Resources and Idaho Personnel Commission. She stated the changes clarified and streamlined rules to align with the Red Tape Reduction Act, HR consolidation and best employee practices. She advised for these rule changes comments were accepted until October 26th, 2022. She noted no comments were submitted in opposition to the rule changes, and no changes were made based on the comments. In response to questions from Committee members, she advised that the opportunity to comment on the rules changes was advertised in the Administrative Rules Bulletin.

Chairman Holtzclaw put the committee at ease 1.51 p.m.

Chairman Holtzclaw resumed the meeting at 1.54 p.m.

Michelle Peugh reviewed the rule changes in Docket No. 15-0401-2201.

In response to questioning from Committee members, she noted that in the current job market a list of fewer than five qualified candidates is considered adequate. She advised it was difficult to meet the threshold of five qualified candidates for classified positions, making the recruitment process harder. She explained that classified employees have due process and property rights to their positions whereas nonclassified positions are considered at will employment.

Chairman Holtzclaw advised the Committee members that if one body rejects the rule, the rule may still go into effect if the other body decides to approve of the rule.

Michelle Peugh continued to explain the Docket No. 15-0401-2201 changes.

Due to time constraints, **Docket No. 15-0401-2201** will be carried over to a future meeting to be determined by **Chairman Holtzclaw**.

Chairman Holtzclaw called the meeting to order at 1:29 p.m.

RS 30090C1: Rep. Blanksma presented RS 30090C1, legislation to expand the Idaho Launch

Program to eligible High School Graduates. She noted the Idaho Launch Program is a Workforce Development Program. Rep. Blanksma advised the grants will be available for four years after the student graduates. Rep. Blanksma stated **RS 30090C1** enables the Workforce Development Council to determine grants based

upon market demand, with financial need being a secondary concern.

MOTION: Rep. Bundy made a motion to introduce RS 30090C1. Motion carried by voice

vote.

Josh Scholer, Bureau Chief for Regulatory and Legislative Affairs, presented the Division of Financial Management Idaho Administrative Rules and Rules Process Overview to the Committee. He explained the rules hierarchy to the Committee, noting the Idaho Constitution is the highest law in the state, above legislative statutes which are above state agency rules. He stated a Board, Commission, or Agency Administrator/Director must have statutory authority to adopt rules, noting the Administrative Procedures Act Title 67, Chapter 52, Idaho Code. Mr. Scholer explained there are three types of rules: temporary, proposed and pending. There are two subtypes of rules: fee rules and non-fee rules. He explained any rule imposing a fee is considered a fee rule and these rules must be approved by the legislature.

Mr. Scholer explained the Rule Making Process to the Committee, stating that first an agency files and Initial Notice for Negotiated Rule making. He advised negotiated rule making is conducted both formally and informally. The agency then files the notice for the proposed rule, which requires not less than 21 days for public comment. Once a pending rule is adopted it is printed in the bulletin. Once this happens, the legislative review process begins.

In response to questions from Committee members, **Mr. Scholer** advised that notices for rule changes are filed in the monthly public bulletin. He noted the public bulletin is published online at adminrules.idaho.gov and proposed and pending rules must be added to the bulletin.

Mr. Scholer continued to explain the Rules Process to the Committee, explaining the Zero-Based Regulation Executive Order in 2021-2026. Mr. Scholer noted the Zero-Based Regulation process is based on the Red Tape Reduction Act of 2019 which required 75% of all rules to be cut or simplified within one year. It eliminated 250 chapters of regulations. He advised the ongoing review schedule of agency rule chapters required 20% of rule chapters to be reviewed each year. He explained several considerations that guided the review process, and noted that once agencies identify rules for review the agency must conform to the requirements of the Administrative Procedures Act.

Mr. Scholer continued, explaining the legislative review process. He stated this process allows for participation from the public and stakeholders. He noted the Legislature's authority to review Administrative Rules is found in the Idaho Constitution and in Idaho Code Article III Section 29, which states the legislature 'may review any administrative rule'.

In response to questions from Committee members, **Mr. Scholer** noted there was no requirement for the Committee to approve or reject a rule the same day they hear it. Mr. Scholer advised in order to reject a pending non fee rule a concurrent resolution must pass the House and Senate rejecting the rule.

There being no further business to come before the Committee, the meeting adjourned at 2:10 p.m.

H 18: Rep. Rubel presented H 18, legislation repealing the sunset provision of Idaho

> Code 72-451 on the coverage of post traumatic stress injuries for first responders; making this statute permanent. Rep. Rubel introduce Rob Shoplock, President of

the Professional Firefighters of Idaho.

Rob Shoplock noted 31 claims were accepted and 36 were denied. He noted that

all 67 individuals were helped.

In response to questions from Committee members. Mr. Shoplock stated volunteer firefighters will be included by **H 18** if their employer is required to pay compensation.

MOTION: Rep. Bundy made a motion to send H 18 to the floor with a DO PASS

recommendation.

Roll call vote was requested. Motion carried by a vote of 14 AYE, 0 NAY, and 1 Absent/excused. Voting in favor of the motion: Reps. Holtzclaw, Bundy, VOTE:

Kingsley, Wisniewski, Weber, McCann, Cheatum, Hawkins, Healey, Miller, Price, Wheeler, Chew, Roberts. Voting in opposition to the motion: None. Rep.

Horman was absent/excused. Rep. Rubel will sponsor the bill on the floor.

H 13: Rep. Bundy presented H 13, legislation updating Title 67 Chapter 53 and Title

59 Chapter 16, relating to the personnel system, by removing outdated language

and practices.

In response to questions from the Committee, Rep. Bundy advised that some

changes were made to work with the programming of the current software.

MOTION: Rep. McCann made a motion to send H 13 to the floor with a DO PASS

recommendation. Motion carried by voice vote. Rep. Bundy will sponsor the

bill on the floor.

H 14: Rep. Bundy presented H 14, legislation providing clarification and flexibility within

established compensation practices by adding language to 67-5309B and 59-1603. He advised the legislation will have no impact on the general fund as agencies must

use existing appropriations to cover the cost.

Fred Birnbaum, representing the Idaho Freedom Foundation, testified **in opposition** to **H 14.** Mr. Birnbaum expressed concern about the fiscal impact of **H 14.** He noted that expenditures in Fiscal Year 2022 were lower than appropriations with \$121,493,900 of the total appropriation not expended in personnel costs with \$79,973,800 reverted. He stated money that is not reverted could be used to make adjustments according to internal equity. Mr. Birnbaum also stated language referring to 'internal equity' was too vague.

Lori Wolff, Administrator for the Division of Human Resources, was called upon to answer questions from the Committee regarding **H 14**. She advised the term 'internal equity' referred to comparisons between staff who work within the same organization. Ms. Wolff noted **H 14** permits internal equity adjustments within the six month probationary period. She stated if an agency has not appropriated funds they cannot implement wage increases.

MOTION:

Rep. Weber made a motion to send **H 14** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote. Rep. Bundy will sponsor the bill on the floor.**

H 15:

Rep. Bundy presented **H 15**, legislation updating the agency name to the "Division of Human Resources" from the previous agency name of the "Personnel Commission" outlined in 67-3519. Rep. Bundy noted **H 15** adds the statement "pay or" before "pay grade" in order to match current practice.

Janelle White, Bureau Chief for the Division of Human Resources, was called upon to answer questions from the Committee regarding **H 15**. She stated the strikeout on page 3, section 4 is a result of the establishment of the Office of Administrative Hearings. Ms. White advised the Personnel Commission exists to hear appeals that employees make to their organizations, noting this is not changed by **H 15**.

MOTION:

Rep. McCann made a motion to send **H 15** to the floor with a DO PASS recommendation.

ROLL CALL VOTE: Roll call vote was requested. Motion carried by a vote of 14 AYE, 0 NAY, and 0 Absent/excused. Voting in favor of the motion: Reps. Holtzclaw, Bundy, Kingsley, Wisniewski, Weber, McCann, Cheatum, Hawkins, Healey, Miller, Price, Wheeler, Chew, Roberts. Voting in opposition to the motion: None. Rep. Horman was absent/excused. Rep. Bundy will sponsor the bill on the floor.

H 16:

Rep. Bundy presented **H 16**, legislation adding language to Idaho Code 67-5302 to waive the 1,385 hour limit for employees hired specifically as apprentice under an approved apprenticeship program.

Janelle White was called upon to answer questions from the Committee regarding **H 16.** Ms. White advised the language specifying an 'approved apprenticeship program' was included in the legislation in order to prevent agencies from hiring an employee for a part time position but expecting them to work full time. She advised she did not feel this was a risk.

MOTION:

Rep. Wheeler made a motion to send **H 16** to the floor with a **DO PASS** recommendation.

ROLL CALL VOTE:

Roll call vote was requested. Motion carried by a vote of 14 AYE, 0 NAY, and 1 Absent/excused. Voting in favor of the motion: Reps. Holtzclaw, Bundy, Kingsley, Wisniewski, Weber, McCann, Cheatum, Hawkins, Healey, Miller, Price, Wheeler, Chew, Roberts. Voting in opposition to the motion: None. Rep. Horman was absent/excused. Rep. Bundy will sponsor the bill on the floor.

H 17:

Rep. Bundy presented **H 17**, legislation to allow for flexibility and clarification related to overtime calculation for certain employees. Rep. Bundy stated typically time worked in excess of 40 hours per workweek is considered overtime. He noted the proposed language adds another option for overtime calculation within established wage and hour laws. Rep. Bundy explained certain employees will have overtime calculator for time worked in excess of 80 hours in a period of 14 consecutive days.

Mark Tschampl, Chief Administrator for the Idaho Division of Veterans Services, testified **in support** of **H 17**. He explained that 80% of vacant positions within the Division of Veterans Services were for skilled nurses. He stated the lack of shift flexibility has meant the Division of Veterans Services has lost nurses and struggled to recruit new ones. He mentioned employees who chose not to work for the Division of Veterans Services indicated that the number one reason for choosing not to work there was shift inflexibility.

Janelle White was called upon to answer questions from the Committee regarding **H 17.** Ms. White advised that **H 17** would not include employees covered by the Fair Labor Standards Act, she noted those employees not exempted were the ones the flexibility was intended for.

In response to questions from the Committee, **Mr. Tschampl** advised the hours worked over the weekend would be considered regular time hours. He explained 12 hours is the national standard for skilled nursing care with no data indicating a 12 hour shift creates more safety incidents in the workplace compared to an 8 hour shift.

MOTION: Rep. Healey made a motion to send H 17 to the floor with a DO PASS

recommendation.

ROLL CALL VOTE:

Roll call vote was requested. Motion carried by a vote of 14 AYE, 0 NAY, and 1 Absent/excused. Voting in favor of the motion: Reps. Holtzclaw, Bundy, Kingsley, Wisniewski, Weber, McCann, Cheatum, Hawkins, Healey, Miller, Price, Wheeler, Chew, Roberts. Voting in opposition to the motion: None. Rep. Horman was absent/excused. Rep. Bundy will sponsor the bill on the floor.

the Public Employee Retirement System of Idaho [PERSI].

Richard Allen, Idaho Chiefs of Police Association, and **John Evans**, Association of Idaho Cities and City of Garden City Mayor, testified **in support** of **S 1054**. They noted **S 1054** enhanced legislation currently in effect by removing restrictions

regarding retirement dates, giving employers the chance to hire the most

experienced officers.

MOTION: Rep. Cheatum made a motion to send S 1054 to the floor with a DO PASS

recommendation. Motion carried by voice vote. Rep. Bundy will sponsor the bill

on the floor.

S 1019: Rep. Bundy presented S 1019, legislation allowing unemployment insurance

benefits to individuals who are leaving work due to being a victim of domestic

violence or due to their military spouse being transferred.

Jani Revier, Director of the Idaho Department of Labor, she noted the

unemployment program pays benefits to people who find themselves unemployed

through no fault of their own.

Director Revier explained unemployment insurance benefits were warranted for

claimants leaving employment due to domestic violence or transferring with a military spouse. She noted the fiscal impact of **S 1019** is \$200,000, and is expected

to increase by three percent per year.

Tammie Perreault, Department of Defense, Heather Cunningham, Idaho Council on Domestic Violence and Victim Assistance, and Jennifer Beazer, citizen, testified

in support of **S 1019**. They stated **S 1019** provides financial security to military spouses and their family members, and helps protect victims of domestic violence

by providing people with financial security.

MOTION: Rep. Roberts made a motion to send S 1019 to the House with a DO PASS

recommendation. Motion carried by voice vote. Rep. Bundy will sponsor the bill

on the floor.

S 1020: Rep. Furniss presented S 1020, legislation repealing the requirement for the

Insurance Advisory Committee.
