STATEMENT OF PURPOSE

RS24668

This bill appropriates \$24,282,700 to the Attorney General for FY 2017 and caps the number of authorized full-time equivalent positions at 205.60. It includes funding for the employer's share of increased benefit costs, replacement items, and statewide cost allocation. It provides an ongoing 3% merit-based increase in employee compensation for permanent employees to be distributed at the discretion of agency heads and funds the 27th payroll. Seven line items provide: \$61,500 for a paralegal; \$53,400 for a legal assistant; 2.00 FTP and the net-zero transfer of \$192,700 for two investigators; 1.00 FTP and \$51,100 for a paralegal; \$15,200 for Medicaid fraud control equipment; \$28,900 for network management equipment; and \$8,700 for polygraph equipment. The Attorney General is also provided lump sum authority under budget law exceptions.
