

- Last 15 years Regional Service Agency serving 29 districts and 6 private schools across a four country area 12,000 square mile area districts from 8-8,000 students in size




### AESA ESAs, known by many names:

### ESAs National Reach:

- Over 550 Agencies-now 45 states
- Members reach over 80% of of public school districts, teachers, non-certified staff
- Serve public, private, homeschool and charter school students
- Annual budgets exceeding \$15 Billion

#### The ESD Mission:

Nine Regional Service Agencies in WA

Chartered in 1967 as the next evolution of the County Supt's Office...version 2.0

Original mission... Oversight of the local district's finances and manage the filmstrip library

Today's Simple Mission...to work alongside our State Dept and Legislature to create EQUITY and EFFICIENCIES for local school districts...

#### **Statutory Authorization**

Revised Code of Washington • 28A.310.010

It shall be the intent and purpose of this regulation to establish educational service districts as regional agencies which are intended to:

- Provide <u>cooperative and informational services</u> to local school districts;
- Assist the superintendent of public instruction and the state board of education in the performance of their respective statutory or constitutional duties;
- Provide <u>services to school districts</u> and to the school for the deaf and the school for the blind to <u>assure equal educational opportunities</u>.

#### **Statutory Authorization**

Revised Code of Washington • 28A.310.200(7)

Powers Bill— ". . . upon written request of the board of directors of a local school district or districts served by the educational service district, the educational service district board of directors may provide cooperative and informational service not in conflict with other law that provide for the development and implementation of programs, activities, services, or practices that support the education of preschool through twelfth grade students in the public/private schools or that support the effective, efficient, or safe management and operation of the school district or districts served by the educational service district."

#### In a nutshell...

- Help districts leverage/share resources to maximize education dollars
  - Provide equity and opportunity to all children in Washington
  - Provide significant cost savings-efficiencies
  - Adapt to specific needs of member districts

#### Flexible and Adaptable

...know the needs of local neighborhoods, school districts, counties and regions ...able to respond to needs in a flexible, adaptable, efficient, costeffective and direct manner ...must be accountable to customers, react to the marketplace, act as entrepreneurs and respond to local, state and federal requirements

#### Governance:

We are not governed by the State
Superintendent, but by a seven member board
elected by the Board members on our local
school boards that we serve (ultimate
performance audit)

Board members serve staggered 4 year terms

Cannot be serving on a local board currently, nor is having served on a local school board required

ESD Board members are not compensated for service

# Funding:

Each of the nine ESDs receive a Core Funding Allocation as part of the State budget

For most of us, that comprises about 4% of our total funding

**Core Funding--\$500,000** 

Funds Superintendent, clerical support, fiscal director, space rental/lease, some travel, overhead.

Grants through Private Foundations and Public Corporations-Gates Foundation

Balance of our funding:

Federal Grants where appropriate

Entrepreneurial partnerships, both in state and out of state

Direct Fee for Service to an individual district

Indirects...a flat 9% charge (admin fee)

### Services:

From Filmstrips to iPads...

District Coops and services offered now number 140...all at the request of districts

Some Coops have every district as a member some as few as 2

Some examples....Fiscal, Nursing Corps, HR, Technology, Admin Services of all kinds, Supts/Special Ed/Fed programs directors

### Support:

Key question...

Why would a district purchase a service or staffing through the regional service agency when they could just hire their own staff member?

- --Flexibility, purchase only days you need
- --Non union shop—can adjust days/personnel w ease
- --Availability, recruitment especially in more rural areas
