STATEMENT OF PURPOSE

RS25515

This is the FY 2018 appropriation to the Legislative Branch which includes the Legislative Services Office (LSO) which reports to the Legislative Council, and the Office of Performance Evaluations (OPE) which reports to the Joint Legislative Oversight Committee. Both offices received funding for the increased cost of benefits, adjustments for statewide cost allocation, increases for a 3% change in employee compensation, and increases for cybersecurity insurance. In addition, LSO was provided funding to replace computer equipment, and funding in line item 1 to add a budget and policy analyst position.

The Legislative Services Office received a total appropriation of \$7,808,500 and the Office of Performance Evaluations received a total appropriation of \$886,200, for a total of \$8,694,700 or 1.3% increase.
