STATEMENT OF PURPOSE

RS25495

This is the FY 2018 appropriation to the Public Schools Support Program Division of Educational Services for the Deaf and the Blind in the amount of \$10,884,300. This is a 5.8% increase from the General Fund and 5.5% overall. This appropriation provides for increased cost of benefits, one-time replacement items to replace six vehicles, assistive hearing equipment, and eight Braille embossers, and the equivalent of a 3% change in employee compensation. This appropriation includes two line items. Line item 1 provides \$378,300 for instructors in an amount equivalent to school district certificated employees on the career ladder compensation system. Line item 2 provides \$203,800 for two administrative positions to address an increasing campus enrollment and outreach cases.
