1 RELATING TO APPROPRIATIONS, DISTRIBUTIONS AND TRANSFERS OF IDAHO MILLENNIUM
2 FUNDS; APPROPRIATING MONEYS TO THE IDAHO DEPARTMENT OF HEALTH AND WEL-
3 FARE FOR THE PHYSICAL HEALTH SERVICES PROGRAM FOR FISCAL YEAR 2018; AP-
4 PROPRIATING MONEYS TO THE IDAHO DEPARTMENT OF JUVENILE CORRECTIONS FOR
5 FISCAL YEAR 2018; APPROPRIATING MONEYS TO THE OFFICE OF DRUG POLICY FOR
6 FISCAL YEAR 2018; APPROPRIATING MONEYS TO THE PUBLIC HEALTH DISTRICTS

26 APPROPRIATING MONEYS TO THE STATE TREASURER FOR DISTRIBUTION TO THE
27 NEZ PERCE TRIBE OF IDAHO FOR FISCAL YEAR 2018; APPROPRIATING MONEYS TO
28 THE STATE TREASURER FOR DISTRIBUTION TO THE SHOSHONE-BANNOCK TRIBES OF
29 IDAHO FOR FISCAL YEAR 2018; REQUIRING A SIGNED AGREEMENT WITH THE STATE;
30 PROVIDING THAT CERTAIN UNEXPENDED AND UNENCUMBERED BALANCE OF MONEYS
31 SHALL REVERT TO THE IDAHO MILLENNIUM INCOME FUND AT THE END OF FISCAL
32 YEAR 2018; AND TRANSFERRING ANY REMAINING UNEXPENDED AND UNENCUMBERED
33 BALANCE OF MONEYS IN THE IDAHO MILLENNIUM INCOME FUND TO THE IDAHO MIL-
34 LENNIUM PERMANENT ENDOWMENT FUND AT THE END OF FISCAL YEAR 2018.

36 Be It Enacted by the Legislature of the State of Idaho:

37 SECTION 1. There is hereby appropriated to the Department of Health and
38 Welfare for the Physical Health Services Program, \$2,706,700 from the Idaho
39 Millennium Income Fund, to be expended for operating expenditures, for the
40 period July 1, 2017, through June 30, 2018. The purpose of this grant is to
41 provide free nicotine replacement therapy medication (nicotine patches, gum
42 and lozenges), web-based cessation services and telephonic cessation coun-
43 seling services to assist people in quitting tobacco use. These funds will

1 help residents who are attempting to quit tobacco use and who cannot afford
2 to pay for these services and medications on their own. This funding will
3 also be used to promote the services through television, radio and print.
4 It will help reduce the burden tobacco use places on taxpayers and reduce
5 tobacco-related illnesses and deaths. The grant will also be used for a
6 counter-marketing program that includes social media, grassroots marketing
7 and other activities such as sponsorships and community outreach.

8 SECTION 2. There is hereby appropriated to the Idaho Department of Ju-
9 venile Corrections, \$747,000 from the Idaho Millennium Income Fund, to be
10 expended for the period July 1, 2017, through June 30, 2018. The purpose of
11 this grant is to support programs that prevent and reduce the use of tobacco
12 and other substances by youth.

13 SECTION 3. There is hereby appropriated to the Office of Drug Policy,
14 \$194,700 from the Idaho Millennium Income Fund, to be expended for the pe-
15 riod July 1, 2017, through June 30, 2018. Funding for this grant is to be used
16 solely to award mini-grants to different pharmacies to place prescription
17 disposal drop-boxes for unused and unwanted medications and to cover opera-
18 tional costs of the grant within the Office of Drug Policy. Further, these
19 funds are not to be used for marketing or advertising purposes as requested
20 in the application.

21 SECTION 4. There is hereby appropriated to the Public Health Districts,
22 \$750,000 from the Idaho Millennium Income Fund, to be expended for the pe-
23 riod July 1, 2017, through June 30, 2018. The purpose of this grant is to
24 provide no-cost cessation services to Idahoans who want to quit tobacco use,
25 with a primary emphasis on youth and pregnant women. No later than November
26 1, 2017, the Public Health Districts are to submit to the Joint Legislative
27 Millennium Fund Committee and to the Joint Finance-Appropriations Committee
28 a report that provides a detailed plan on the Millennium Income Fund tobacco
29 cessation funding formula. This report shall include information on how the
30 formula has changed over time, and how the formula provides equity among the
31 districts. Further, it is the intent of the Legislature that the appropria-
32 tion and use of Millennium Income funds are not to be considered as state gen-
33 eral aid, as outlined in Section 39-425, Idaho Code.

34 SECTION 5. There is hereby appropriated to the Idaho State Police,
35 \$187,100 from the Idaho Millennium Income Fund, to be expended for the period
36 July 1, 2017, through June 30, 2018. The purpose of this grant is to assist
37 the Idaho State Police and the Department of Health and Welfare with the cost
38 of tobacco permittee compliance inspections as required by law.

39 SECTION 6. There is hereby appropriated to the Idaho Department of Cor-
40 rection, \$1,859,200 from the Idaho Millennium Income Fund, to be expended
41 for the period July 1, 2017, through June 30, 2018. The purpose of this grant
42 is to continue coordination, assessment and community-based substance abuse
43 treatment and recovery support services for felony offenders in lieu of in-
44 carceration in a state facility.

1 SECTION 7. There is hereby appropriated \$300,000 from the Idaho Mil-
2 lennium Income Fund to the State Treasurer for distribution to the Idaho As-
3 sociation of Counties, to be expended for the period July 1, 2017, through
4 June 30, 2018. The purpose of this grant is to continue providing support to
5 the eight Community Recovery Centers in the following counties: Ada, Ban-
6 nock, Bonneville, Canyon, Gem, Kootenai, Latah and Nez Perce. These centers
7 are intended to provide a safe place for individuals to find peer support for
8 Idahoans with behavioral health needs.

9 SECTION 8. There is hereby appropriated \$194,200 from the Idaho Mil-
10 lennium Income Fund to the State Treasurer for distribution to the American
11 Cancer Society, to be expended for the period July 1, 2017, through June 30,
12 2018. The purpose of this grant is to perform outreach to underserved women
13 and to educate them about the connection between tobacco use and cancer, the
14 need for cancer screenings, and cessation tools available.

15 SECTION 9. There is hereby appropriated \$159,000 from the Idaho Mil-
16 lennium Income Fund to the State Treasurer for distribution to the Boys and
17 Girls Clubs of Idaho, to be expended for the period July 1, 2017, through June
18 30, 2018. The focus of the grant is on building self-esteem, instilling good
19 character and citizenship, improving academic skills, and developing posi-
20 tive relationships for youth ages 11-18. The project offers a holistic youth
21 development service delivery system, versus a single-strategy approach to
22 prevention of at-risk behaviors.

23 SECTION 10. There is hereby appropriated \$24,000 from the Idaho Mil-
24 lennium Income Fund to the State Treasurer for distribution to the Community
25 Coalitions of Idaho, to be expended for the period July 1, 2017, through June
26 30, 2018. The purpose of this grant is to assist Idaho communities with the
27 establishment of community-supported coalitions that aim to prevent and re-
28 duce substance abuse in the community.

29 SECTION 11. There is hereby appropriated \$205,100 from the Idaho Mil-
30 lennium Income Fund to the State Treasurer for distribution to the Idaho Drug
31 Free Youth, to be expended for the period July 1, 2017, through June 30, 2018.
32 The purpose of the grant is to continue and expand the iDFY Project, which
33 supports activities that include i2i student assemblies, school-based iDFY
34 chapters, and the Youth Summit.

35 SECTION 12. There is hereby appropriated \$83,000 from the Idaho Millen-
36 nium Income Fund to the State Treasurer for distribution to the Idaho Acad-
37 emy of Family Physicians, to be expended for the period July 1, 2017, through
38 June 30, 2018. The purpose of this grant is for the Tar Wars Program, which
39 is designed to teach children how to make positive decisions regarding their
40 health. Tar Wars is a tobacco-free education program for students in grades
41 4 and 5.

42 SECTION 13. There is hereby appropriated \$100,000 from the Idaho Mil-
43 lennium Income Fund to the State Treasurer for distribution to the Idaho
44 Youth Ranch, to be expended for the period July 1, 2017, through June 30,

1 2018. The purpose of this grant is to support programs at Anchor House, which
2 is a family therapy and support center in Coeur d'Alene that serves children,
3 teens and families throughout northern Idaho. The grant would provide per-
4 sonnel funding for staff to provide an array of services that can be bundled
5 for an overall impact, to provide services to children and families in need
6 of behavioral and/or psychological therapy, and to provide substance abuse
7 prevention for children who are at a greater risk of abusing drugs and alco-
8 hol.

9 SECTION 14. There is hereby appropriated \$229,000 from the Idaho Mil-
10 lennium Income Fund to the State Treasurer for distribution to the American
11 Lung Association in Idaho, to be expended for the period July 1, 2017,
12 through June 30, 2018. The purpose of this grant is to provide youth tobacco
13 prevention services to Idaho youth through participation in three (3) Ameri-
14 can Lung Association programs statewide: Teens Against Tobacco Use (TATU),
15 to train teens in grades 8 through 12 to provide tobacco prevention presen-
16 tations in grades 4 through 7; Support Teens Against Nicotine Dependency
17 (STAND), which provides mini-grants, training and technical support to
18 Idaho youth groups to engage in community awareness and policy improvement
19 projects regarding tobacco; and adult facilitator training for Not-On-To-
20 bacco (N-O-T), a smoking cessation program designed specifically for youth
21 under the age of 18 years.

22 SECTION 15. There is hereby appropriated \$649,900 from the Idaho Mil-
23 lennium Income Fund to the State Treasurer for distribution to the Idaho Meth
24 Project, to be expended for the period July 1, 2017, through June 30, 2018.
25 The purpose of this grant is to continue the "Not Even Once" campaign to dis-
26 courage the use of methamphetamine. Implementation of this grant will be
27 through outreach using social and digital media, school presentations and
28 community engagement activities.

29 SECTION 16. There is hereby appropriated \$495,300 from the Idaho Mil-
30 lennium Income Fund to the State Treasurer for distribution to Truth208, to
31 be expended for the period July 1, 2017, through June 30, 2018. The pur-
32 pose of this grant is to continue with a prescription drug abuse awareness
33 campaign. Implementation of this grant will be through outreach using so-
34 cial and digital media, school presentations and community engagement ac-
35 tivities.

36 SECTION 17. There is hereby appropriated \$90,600 from the Idaho Mil-
37 lennium Income Fund to the State Treasurer for distribution to the Nez Perce
38 Tribe of Idaho, to be expended for the period July 1, 2017, through June 30,
39 2018. The purpose of this grant is to provide assistance with its Support-
40 ing Fathers, Supporting Children Program, which is designed to enhance the
41 father and child relationship. Specifically, this funding would be for a
42 community outreach specialist who would travel the state and provide classes
43 for tribal members. The program's goals are to decrease substance abuse by
44 fathers within the tribe, prevent substance abuse by children in their com-
45 munity, and increase child support payments of noncustodial fathers.

1 SECTION 18. There is hereby appropriated \$161,400 from the Idaho Mil-
2 lennium Income Fund to the State Treasurer for distribution to the Shoshone-
3 Bannock Tribes of Idaho, to be expended for the period July 1, 2017, through
4 June 30, 2018. The purpose of the grant is to establish peer recovery ser-
5 vices at the Four Directions Treatment Center and surrounding areas. The
6 center provides certified clinical treatment for drug and alcohol abuse on
7 the Fort Hall Reservation. The center has limited resources for prevention
8 and recovery support services, and the grant will provide funding to hire a
9 recovery services coordinator and will provide training and certification
10 of recovery coaches for the center. Prevention outreach topics will include
11 tobacco, vaping, inhalants, other drugs, and alcohol.

12 SECTION 19. SIGNED AGREEMENT. Per grant submission requirements, in
13 order to receive Idaho Millennium Income funds, nonstate entities receiving
14 a grant award as provided for in Sections 7, 8, 9, 10, 11, 12, 13, 14, 15, 16,
15 17 and 18 of this act, are required to complete the signed agreement set forth
16 by the state.

17 SECTION 20. Notwithstanding any other provision of law to the contrary,
18 on June 30, 2018, or as soon thereafter as practicable, any remaining unex-
19 pended and unencumbered balance of moneys appropriated in Sections 1, 2, 3,
20 4, 5 and 6 of this act, shall be reverted to the Idaho Millennium Income Fund.

21 SECTION 21. Notwithstanding any other provision of law to the contrary,
22 on June 30, 2018, or as soon thereafter as practicable, the State Controller,
23 at the request of the State Treasurer, shall transfer any remaining unex-
24 pended and unencumbered balance of moneys in the Idaho Millennium Income
25 Fund to the Idaho Millennium Permanent Endowment Fund.
