SENATE BILL NO. 1116

AN ACT

1 RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF CORRECTION FOR FISCAL  
2 YEAR 2017; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF CORREC-  
3 TION FOR THE MANAGEMENT SERVICES PROGRAM FOR FISCAL YEAR 2017 TO PROVIDE  
4 FOR AN EVALUATION AND ATTORNEY'S FEES; APPROPRIATING ADDITIONAL MONEYS  
5 TO THE DEPARTMENT OF CORRECTION FOR THE MANAGEMENT SERVICES PROGRAM  
6 FOR FISCAL YEAR 2017 TO PROVIDE FOR AN EVALUATION; APPROPRIATING ADDI-  
7 TIONAL MONEYS TO THE DEPARTMENT OF CORRECTION FOR THE MEDICAL SERVICES  
8 PROGRAM FOR FISCAL YEAR 2017 TO PROVIDE FOR CONTRACT COSTS; REDUCING  
9 THE APPROPRIATION TO THE DEPARTMENT OF CORRECTION FOR THE COUNTY AND  
10 OUT-OF-STATE PLACEMENT PROGRAM FOR FISCAL YEAR 2017 DUE TO CONTRACT  
11 SAVINGS; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF CORRECTION FOR  
12 THE CORRECTIONAL ALTERNATIVE PLACEMENT PROGRAM FOR FISCAL YEAR 2017 DUE  
13 TO CONTRACT SAVINGS; AND DECLARING AN EMERGENCY.

15 Be It Enacted by the Legislature of the State of Idaho:

16 SECTION 1. In addition to the appropriation made in Section 1, Chapter  
17 335, Laws of 2016, and any other appropriation provided for by law, there is  
18 hereby appropriated to the Department of Correction for the Management Ser-  
19 vices Program \$370,500 from the General Fund to be expended for operating ex-  
20 penditures, for the period July 1, 2016, through June 30, 2017, for the pur-  
21 pose of paying for an evaluation and attorney's fees.

22 SECTION 2. In addition to the appropriation made in Section 1, Chapter  
23 335, Laws of 2016, and any other appropriation provided for by law, there is  
24 hereby appropriated to the Department of Correction for the Management Ser-  
25 vices Program \$185,000 from the Inmate Labor Fund to be expended for operat-  
26 ing expenditures, for the period July 1, 2016, through June 30, 2017, for the  
27 purpose of paying for an evaluation.

28 SECTION 3. In addition to the appropriation made in Section 1, Chapter  
29 335, Laws of 2016, and any other appropriation provided for by law, there is  
30 hereby appropriated to the Department of Correction for the Medical Services  
31 Program \$134,900 from the General Fund to be expended for operating expendi-  
32 tures, for the period July 1, 2016, through June 30, 2017, for the purpose of  
33 paying for contracted medical services.

34 SECTION 4. Notwithstanding any other provision of law to the contrary,  
35 the appropriation made to the Department of Correction for the County and  
36 Out-of-State Placement Program in Section 1, Chapter 335, Laws of 2016, from  
37 the General Fund, is hereby reduced by \$907,300 for operating expenditures,  
38 for the period July 1, 2016, through June 30, 2017, due to contract savings.

1           SECTION 5. Notwithstanding any other provision of law to the contrary,  
2 the appropriation made to the Department of Correction for the Correctional  
3 Alternative Placement Program in Section 1, Chapter 335, Laws of 2016, from  
4 the General Fund, is hereby reduced by \$164,400 for operating expenditures,  
5 for the period July 1, 2016, through June 30, 2017, due to contract savings.

6           SECTION 6. An emergency existing therefor, which emergency is hereby  
7 declared to exist, this act shall be in full force and effect on and after its  
8 passage and approval.
