### SENATE BILL NO. 1146

#### BY FINANCE COMMITTEE

AN ACT

RELATING TO APPROPRIATIONS TO THE DIVISION OF BUILDING SAFETY; APPROPRIAT
ING ADDITIONAL MONEYS TO THE DIVISION OF BUILDING SAFETY FOR FISCAL YEAR

2017; APPROPRIATING MONEYS TO THE DIVISION OF BUILDING SAFETY FOR FISCAL YEAR 2018; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS; AND DECLARING AN EMERGENCY.

# Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. In addition to the appropriation made in Section 1, Chapter 149, Laws of 2016, and any other appropriation provided for by law, there is hereby appropriated \$50,000 from the State Regulatory Fund to the Division of Building Safety, to be expended for operating expenditures, for the period July 1, 2016, through June 30, 2017.

SECTION 2. There is hereby appropriated to the Division of Building Safety, the following amounts to be expended for the designated expense classes, from the listed funds for the period July 1, 2017, through June 30, 2018:

SECTION 3. FTP AUTHORIZATION. In accordance with Section 67-3519, Idaho Code, the Division of Building Safety is authorized no more than one hundred forty-one (141) full-time equivalent positions at any point during

- the period July 1, 2017, through June 30, 2018, unless specifically authorized by the Governor. The Joint Finance-Appropriations Committee will be notified promptly of any increased positions so authorized.
- SECTION 4. An emergency existing therefor, which emergency is hereby declared to exist, the provisions of Section 1 of this act shall be in full force and effect on and after passage and approval.
