## STATEMENT OF PURPOSE

## RS25481

This is the fiscal year 2018 appropriation bill for the Division of Vocational Rehabilitation. It appropriates \$8,589,000 from the General Fund, \$2,050,700 from dedicated funds, and \$17,536,200 in federal funds, for a total of \$28,175,900 and 152.50 FTP.

It includes appropriation adjustments for employee benefit costs, contract inflation, statewide cost allocation, \$162,000 for replacement items, cybersercurity insurance, and an ongoing 3% merit-based increase in employee compensation for permanent employees to be distributed at the discretion of the agency head. This appropriation includes one line item of \$214,300 for the Extended Employment Services program.
