General Fund Transfer

Language in the appropriation bill shall read as follows: *There is hereby appropriated and the State Controller shall transfer* \$45,296,200 from the General Fund to the Permanent Building Fund, on July 1,2017, or as soon thereafter as practicable.

TIMING OF THE USE OF PERMANENT BUILDING FUNDS FOR SPECIFIC PROJECTS. The appropriation of \$20,000,000 in the Permanent Building Fund shall be expended only after institution presidents have secured pledges for their portion of the project costs for the Lewis-Clark State College Career-Technical Education Building and the University of Idaho Center for Agriculture, Food, and the Environment. Verification of such pledges shall be confirmed by a signed attestation letter from the presidents of the University of Idaho and Lewis-Clark State College to the Division of Public Works in the Department of Administration.

UNANIMOUS CONSENT:

On request by **Martin**, granted by unanimous consent, the following legislative intent language was accepted:

ALLOCATION OF FUNDS FOR SPECIFIC PROJECTS. Moneys appropriated in Section ____ of this act, or so much thereof as in each case may be necessary, shall be used for the purpose of paying the cost of any land, building, equipment, or the rebuilding, renovation or repair of buildings, installations, facilities or structures at the places, institutions and agencies, or their successors, including those listed in this section. The Permanent Building Fund Advisory Council is hereby authorized and directed to anticipate revenues accruing to the Permanent Building Fund for the purpose of undertaking the construction, renovation, repair and acquisitions therein authorized, without delay, and to determine the priority of construction pursuant to which the work hereunder will be undertaken.

UTILIZATION OF MATCHING FUNDS. It is legislative intent that the moneys appropriated in this act may be made available for matching any allocation of moneys now in existence or hereafter made available by agencies of the United States and/or private donations; and it is further the express intention of the Legislature to authorize the Division of Public Works to expend, for the purpose of paying the cost of any land, building, equipment or the rebuilding, renovation or repair of buildings, moneys appropriated for public works to various agencies as part of the respective agency operating budgets; provided the express approval by the Permanent Building Fund Advisory Council is granted to make application for such moneys in each instance.

REALLOCATION OF PROJECT SAVINGS. It is the intent of the Legislature that the Division of Public Works have the flexibility to allocate any savings or unused appropriation from any project to any other requested and funded project. The reallocation of such appropriation must be approved by the Permanent Building Fund Advisory Council prior to the funds being spent.
