**SCR 117** **Stating Findings of the Legislature and Rejecting a Certain Rule of the State Board of and State Department of Education Relating to Rules Governing Administration. Vice Chairman Thayn** explained **SCR 117** is result of the subsections that were rejected by the Committee in regards to **Docket No. 08.0201.1602**. He stated the House Education Committee rejected different parts of **Docket No. 08.0201.1602** and if the Committee passed **SCR 117** there would not be consensus to the rule and the whole rule would fail.
