HOUSE BILL NO. 361

AN ACT

RELATING TO FILING FEES FOR THE SECRETARY OF STATE; AMENDING SECTION 30-21-214, IDAHO CODE, TO REMOVE THE FEE CHARGED FOR FILING A STATEMENT OF TERMINATION AND TO REVISE THE FILING FORMAT FOR WHICH A SURCHARGE MAY BE CHARGED; AND PROVIDING AN EFFECTIVE DATE.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. That Section 30-21-214, Idaho Code, be, and the same is hereby amended to read as follows:

30-21-214. FEES. (a) The secretary of state shall collect the following fees for copying and certifying the copy of any filed record:

- (1) Twenty-five cents (25¢) per page for copying; and
- (2) Ten dollars (\$10.00) for the certification.

(b) The secretary of state shall collect the following fees when an entity filing is delivered for filing:

- (1) Statement of merger\$30.00
- (2) Statement of withdrawal\$30.00
- (3) Statement of interest exchange\$30.00
- (4) Statement of abandonment\$30.00
- (5) Statement of conversion\$30.00
- (6) Statement of domestication\$30.00
- (7) Annual report No fee
- (8) Articles of incorporation of a business corporation\$100.00
- (9) Articles of incorporation of a nonprofit corporation\$30.00
- (10) Statement of qualification of a limited liability partnership ...
.....\$100.00
- (11) Certificate of amendment to certificate of assumed business name

- (12) Certificate of amendment to certificate of assumed business name

30	(\$20.00) for providing evidence of filing an entity filing within eight (8)	
31	working hours after the entity filing is delivered for filing.	
32	(e) The secretary of state shall collect a surcharge of twenty dollars	
33	(\$20.00) for filing any non-typed record or any record that is not on a stan-	
34	dard form prescribed by the secretary of state, except no surcharge will be	
35	collected for a non-typed certificate of assumed business name or a certifi-	
36	cate of amendment to certificate of assumed business name <u>form that is not</u>	
37	<u>generated by the secretary of state's electronic filing system and that re-</u>	
38	<u>quires manual data entry.</u>	

39 SECTION 2. This act shall be in full force and effect on and after Octo-
40 ber 31, 2018.
