#### STATEMENT OF PURPOSE

## RS26319

This is the FY 2019 original appropriation bill for the Division of Teachers for the Public Schools Educational Support Program. It appropriates \$955,079,600 from the General Fund and \$15,000,000 in federal funds. The division provides funding for instructional and pupil service staff salaries and benefits, and other programs specific to certificated instructors in Idaho's 115 school districts and 52 charter schools, grades K-12. Nondiscretionary adjustments in this appropriation include year four of the five-year phase-in of the career ladder compensation system for Idaho's educators in the amount of \$41,667,200. There is also a statutory increase of \$372,000 for leadership awards and premiums due to increased full-time equivalent instructional and pupil service positions (FTP). The increase is a result of 368.00 additional FTP working in the public school system, going from 17,208.00 FTP to 17,576.00 FTP. These premiums are set in statute (Section 33-1004J, Idaho Code), which requires \$850, plus employer benefit costs, to be distributed to school districts and charter schools for each FTP. Lastly, there is an increase of \$451,900 for additional high school math and science requirements. All of these nondiscretionary adjustments net to \$42,491,100. The bill funds two line items, which provide \$2 million for college/career advisors and mentors and \$600,000 for professional development. All funds are ongoing and result in a 4.9% increase over the previous year.
