STATEMENT OF PURPOSE

This is the FY 2019 original appropriation bill for the Division of Central Services of the Public Schools Educational Support Program. It appropriates \$14,475,300 from the General Fund. This division includes those moneys included in the public schools support budget that are expended at the state level for the benefit of school districts. This bill funds two line items, which provide \$1,300,000 for content and curriculum and \$1,341,500 for student achievement assessments. The total increase in this appropriation is 3.6%.
