RS 26302:	<b>Rep. Moyle</b> presented <b>RS 26302</b> . This legislation raises the child tax credit from \$130 to \$205. Rep. Moyle reiterated the \$205 helps most of large families, but it may not help the very wealthy families. He stated \$205 is a fair compromise based on other's input.
