AN ACT

RELATING TO THE APPROPRIATION TO THE MEDICAL BOARDS FOR FISCAL YEAR 2020; AP-  
PROPRIATING MONEYS TO THE MEDICAL BOARDS FOR FISCAL YEAR 2020; AND LIM-  
ITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. There is hereby appropriated to the Medical Boards the fol-  
lowing amounts to be expended according to the designated programs and ex-  
penditure classes from the listed fund for the period July 1, 2019, through June  
30, 2020:
