STATEMENT OF PURPOSE

RS26973

This is the FY 2020 original appropriation bill for the Office of the State Board of Education, Agricultural Research and Extension Service. It appropriates a total of \$32,530,700.

For benefit costs, the bill maintains the current appropriated amount for health insurance at \$11,650 per eligible FTP; provides a 5.5% increase for the employer's share of PERSI contributions; and temporarily reduces the rate agencies pay the Division of Human Resources for its services. Funding for replacement items includes \$140,000 for the replacement of equipment at various research stations. The bill also provides funding for the equivalent of a 3% change in employee compensation for permanent employees, with a minimum increase of \$550 for each employee and the remaining amount to be distributed based on merit. Funding for a 3% upward shift in the compensation schedule is also included. The bill funds three line items, which provide 1.00 FTP and \$118,300 for an additional 4-H Extension Educator; 2.00 FTP and \$217,600 for staff support at the Rock Creek Ranch; and 0.57 FTP and \$122,600 for occupancy costs.
