RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF AGRICULTURE; APPROPRIAT-ING ADDITIONAL MONEYS TO THE DEPARTMENT OF AGRICULTURE FOR FISCAL YEAR 2019; AUTHORIZING ADDITIONAL FULL-TIME EQUIVALENT POSITIONS FOR FISCAL YEAR 2019; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF AGRI-CULTURE FOR FISCAL YEAR 2020; AUTHORIZING ADDITIONAL FULL-TIME EQUIVA-LENT POSITIONS FOR FISCAL YEAR 2020; AND DECLARING AN EMERGENCY.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. In addition to the appropriation made in Section 1, Chap-10 ter 310, Laws of 2018, and any other appropriation provided by law, there is hereby appropriated to the Department of Agriculture for the Plant In-11 dustries Program the following amounts to be expended according to the des-12 ignated expense classes from the General Fund for the period July 1, 2018, 13 through June 30, 2019, for the purpose of creating and implementing a hemp 14 development plan: 15

SECTION 2. FTP AUTHORIZATION. In addition to the authorization provided in Section 2, Chapter 310, Laws of 2018, the full-time equivalent position authorization provided to the Department of Agriculture is hereby increased by one (1.00) for the period July 1, 2018, through June 30, 2019.

SECTION 3. In addition to any other appropriation provided by law, there is hereby appropriated to the Department of Agriculture for the Plant Industries Program the following amounts to be expended according to the designated expense classes from the General Fund for the period July 1, 2019, through June 30, 2020, for the purpose of creating and implementing a hemp development plan:

34 SECTION 4. FTP AUTHORIZATION. In addition to any other authorization provided by law, the full-time equivalent position authorization provided 35 to the Department of Agriculture is hereby increased by five-tenths (0.50) 36 for the period July 1, 2019, through June 30, 2020. 37

SECTION 5. An emergency existing therefor, which emergency is hereby declared to exist, Sections 1 and 2 of this act shall be in full force and effect on and after passage and approval.
