AN ACT

1 RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF CORRECTION FOR FISCAL
2 YEAR 2020; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF CORREC-
3 TION FOR THE COUNTY AND OUT-OF-STATE PLACEMENT PROGRAM FOR FISCAL YEAR
4 2020; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF CORRECTION
5 FOR THE CORRECTIONAL ALTERNATIVE PLACEMENT PROGRAM FOR FISCAL YEAR
6 2020; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF CORRECTION
7 FOR THE MEDICAL SERVICES PROGRAM FOR FISCAL YEAR 2020; APPROPRIATING
8 ADDITIONAL MONEYS TO THE DEPARTMENT OF CORRECTION FOR THE PRISONS AD-
9 MINISTRATION PROGRAM FOR FISCAL YEAR 2020; AND DECLARING AN EMERGENCY.

11 Be It Enacted by the Legislature of the State of Idaho:

12 SECTION 1. In addition to the appropriation made in Section 1, Chap-
13 ter 173, Laws of 2019, and any other appropriation provided by law, there
14 is hereby appropriated to the Department of Correction for the County and
15 Out-of-State Placement Program \$15,251,500 from the General Fund to be ex-
16 pended for operating expenditures for the period July 1, 2019, through June
17 30, 2020, for the purpose of population-driven costs.

18 SECTION 2. In addition to the appropriation made in Section 1, Chapter
19 173, Laws of 2019, and any other appropriation provided by law, there is
20 hereby appropriated to the Department of Correction for the Correctional
21 Alternative Placement Program \$302,400 from the General Fund to be expended
22 for operating expenditures for the period July 1, 2019, through June 30,
23 2020, for the purpose of population-driven costs and no-touch kosher meals.

24 SECTION 3. In addition to the appropriation made in Section 1, Chap-
25 ter 173, Laws of 2019, and any other appropriation provided by law, there is
26 hereby appropriated to the Department of Correction for the Medical Services
27 Program \$7,845,600 from the General Fund to be expended for operating expen-
28 ditures for the period July 1, 2019, through June 30, 2020, for the purpose of
29 population-driven costs and an audit compliance plan.

30 SECTION 4. In addition to the appropriation made in Section 1, Chap-
31 ter 173, Laws of 2019, and any other appropriation provided by law, there is
32 hereby appropriated to the Department of Correction for the Prisons Adminis-
33 tration Program \$245,100 from the Federal Grant Fund to be expended for op-
34 erating expenditures for the period July 1, 2019, through June 30, 2020, for
35 the purpose of the State Criminal Alien Assistance Program grant.

36 SECTION 5. An emergency existing therefor, which emergency is hereby
37 declared to exist, this act shall be in full force and effect on and after its
38 passage and approval.
