AGENCY LEGISLATIVE SERVICES OFFICE (LSO); Eric Milstead, Director PRESENTATION: Paul Headlee, Division Manager, Budget and Policy Analysis

The Legislative Services Office provides efficient, non-partisan support services to Idaho's citizen legislators, carries out legislative policies so as to strengthen the Legislature's management as a separate branch of government, and assists the Legislature in its constitutional responsibilities. It contains four principal divisions: Legislative Audits, the largest division; Budget and Policy Analysis; Research and Legislation and Information Technology. LSO is funded by both General and dedicated funds.

Performance Measures: The legislative branch is not required to submit annual performance reports, however, LSO surveys the legislature every other year and uses that information to adjust as necessary.

FY 2019 Actual Expenditures: **Division Manager Headlee** detailed net object transfers and reversions.

Comparative Summary: The outline illustrates a side-by-side analysis of the agency's request and the governor's recommendation. It shows LSO's request for a supplemental appropriation for closed captioning proceedings, and one line item, mentioned below.

FY 2020: The Legislature funded one line item that provided for audit workpaper software maintenance. Director Milstead reported that audit workpaper software has become the nationwide approach to auditing, and it is working very well. LSO is requesting an FY 2020 supplemental appropriation for closed captioning technology to the Senate and House floor proceedings. Current year standard statewide adjustments recommended by governor included the sick leave rate reduction and 1 percent onetime General Fund reduction.

FY 2021: LSO requested replacement items for laptop computers in the Audits Division. It also requested one line item to hire a revenue analyst. Statewide adjustments recommended by the governor include only OITS operating costs.

FY 2021 Total Appropriation: LSO recommends a total appropriation of \$8,469,500, a 4.3 percent increase. The governor recommended \$8,354,000, a 2.8 percent increase. See Audio and Presentation.

## REDISTRICTING COMMISSION, (Commission), Eric Milstead, Director, PRESENTATION: Legislative Services Office (LSO)

#### Paul Headlee, Division Manager, Budget & Policy Analysis, LSO

The Redistricting Commission acts once every 10 years, after each census. to redraw new legislative and congressional boundaries. The Commission is comprised of six bipartisan commissioners. The Commission is funded soley from General Funds. It has no organizational chart and no required performance measures.

FY 2019: The legislature funded a supplemental appropriation to kick-start operations and distribute information to the General Services Administration. No appropriation was made in FY 2020.

FY 2021: The Commission requested \$444,900 for personnel costs, operating expenses and capital outlay. Director Milstead elaborated on this request and reported that LSO augments the redistricting effort by providing staffing service in addition to this request. Director Milstead and Division Manager Headlee answered questions from the Committee. See Link above.

## OFFICE OF PERFORMANCE EVALUATIONS, Rakesh Mohan, Director PRESENTATION: Paul Headlee, Division Manager, Budget and Policy Analysis

The Office of Performance Evaluations (OPE) is a nonpartisan legislative office that promotes accountability and confidence in state government. OPE Staff works under the general direction of the Joint Legislative Oversight Committee (JLOC), which consists of an equal number of legislators from both political parties and both houses. OPE prides itself for independence, objectivity. nonpartisanship and thoroughness.

Performance Measures: The Legislative Branch is exempt from performance review measures; however, OPE chose to participate in the process. **Director Mohan** reviewed specific measures and projects accomplished in 2019.

FY 2019 Actual Expenditures: Division Manager Headlee detailed net object transfers and reversions.

FY 2020: The Legislature funded three line items: (1) \$17,800 for ongoing personnel costs for employee retention; (2) \$5,600 ongoing for a subscription to LexisNexis for research resources; and (3) \$2,600 for software maintenance costs. **Director Mohan** reported that all projects were completed. The 1 percent general fund rescission was taken from personnel costs.

FY 2021: Statewide adjustments recommended by governor included benefit costs, statewide cost allocation, CEC, and OITS operating costs...

FY 2021 Total Appropriation: OPE requested a total appropriation of \$973,700, a 2.3 percent increase. The governor recommended 959,700 a 0.8 percent increase. See Audio and Presentation.

### STATEWIDE BUDGET DECISIONS, Paul Headlee, Division Manager, PRESENTATION: Budget and Policy Analysis

Division Manager Headlee introduced the Statewide Budget Decision Packet for review. These statewide decisions must be in place before the budget-setting process begins for FY 2021. The decisions are:

- (1) Salary structure adjustments;
- (2) Specific occupational inequities;
- (3) FY 2020 General Fund Revenue projections for FY 2020 budget-setting;
- (4) FY 2021 General Fund Revenue projections for FY 2021 budget-setting;
- (5) Sick Leave Rate Reduction for FY 2020 (11 pay periods):
- (6) FY 2020 onetime one percent rescission;
- (7) Employee benefits;
- (8) Statewide Cost Allocation (SWCAP);
- (9) Change in Employee Compensation (CEC);
- (10) Two percent salary increase for classified staff and administrators in public schools; and
- (11) Nondiscretionary adjustments.

**Division Manager Headlee** explained the need to move the budget submission deadline from November 1 to November 15 each year, which would accommodate the time needs of governing councils to obtain budget approvals.

### RAISE CAP ON BUDGET STABILIZATION FUND AND TRANSFER **FUNDS**;

Keith Bybee, Deputy Division Manager, Budget & Policy Analysis, LSO RS 27632 corrects inadvertent errors in H 374 which were discovered in the House of Representatives. RS 27632 would ensure that if a majority of the members of each House of Legislature adopted a concurrent resolution requesting the amount of the transfer to be reduced, then the State Comptroller shall reduce the amount of the transfer. Section 57-814(2) Idaho Code.

The Department of Administration has informed the Governor and the Legislature that the relocations

could begin now if funded as FY 2020 supplemental appropriations.
