Wintrow made a motion for the Department of Correction, in the Management Services Division, beginning with the FY 2021 Base, a decrease of \$73,800 for benefit costs, an increase of \$56,300 for inflationary adjustments, an increase of \$972,500 for replacement items, an increase of \$129,800 for statewide cost allocation, and an increase of \$213,600 for change in employee compensation. Also included are the following line items: line item 3, which provides \$4,500,000 for Phase 3 of the Offender Management System replacement; \$28,200 for OITS operating costs; \$553,400 for OITS servers and licensing; a decrease of 19.00 FTP and an increase of \$919,800 for OITS consolidation; \$121,500 for OITS billings; and a 2 percent General Fund

Also included are the following line items: line item 4, which provides \$24,700 for instructor pay; line item 5, which provides 4.00 FTP and \$227,300 for correctional officers at the St. Anthony Work Camp; line item 10, which provides \$48,600 for the State Criminal Alien Assistance Grant; and a 2 percent General Fund reduction of \$2,242,300 from operating expenditures. Also included are the following line items: line item 1, which provides \$5,939,000 for community interventions; line item 2, which provides 23.00 FTP and \$2,744,300 for operational costs at the Twin Falls Community Reentry Center; line item 7, which provides 17.00 FTP and \$1,164,100 for probation and parole staff; and a 2 percent General Fund reduction of \$482,100 from operating expenditures. INTENT LANGUAGE: EXEMPTIONS FROM PROGRAM TRANSFER LIMITATIONS. The Department of Correction is hereby exempted from the provisions of **Section** 67-3511(2), Idaho Code, allowing unlimited transfers between programs for all moneys appropriated to it for the period July 1, 2020, through June 30, 2021; provided, however, moneys appropriated to the County and Out-of-State Placement Program, Correctional Alternative Placement Program, and Medical Services Program may only be transferred between said programs. Legislative appropriations shall not be transferred from one fund to another fund unless expressly approved by the Legislature. Audio and Motion and Ballot.
