IDAPA 13.00.00 - Establishing Seasons and Limits for Hunting, Fishing, and Trapping in Idaho - Notice of Adopted / Amended Proclamation (P6) (Docket No. 13-0000-2100P)

The Department of Fish and Game submits notice of adopted/amended proclamation establishing seasons and limits for hunting, fishing, and trapping in Idaho. The department notes that the commission specifically took the following proclamation actions on July 14, 2021:

- Adopted a proclamation setting 2021 sage-grouse hunting season and tag limits, and amended its 2021 falconry season for sage grouse to adopt tag limits, with game tags now required with a change in law effective July 1, 2021.
- Amended its 2021 upland game bird seasons and limits by (1) adding sites to the list of areas where pheasants are stocked and an Upland Game Bird Permit is required and approving shooting hours for upland game birds on areas where an Upland Game Bird Permit is required, and (2) adopting a 5-day delayed pheasant season opener for nonresident participation in the general 2021 pheasant seasons.
- Amended its 2021 2022 Idaho migratory game bird seasons and limits by implementing a controlled hunt framework to distribute swan tags for the 2021 season.
- Adopted a proclamation setting the 2021 fall Chinook salmon season and limits in the Snake, Salmon, and Clearwater Rivers.
- Adopted a proclamation setting the 2021 Coho salmon season and limits in the Clearwater River.

Section 36-105(3), Idaho Code, provides that the Department of Fish and Game shall be excepted from the requirements of rulemaking when adopting, repealing, or amending any proclamations relating to the setting of various seasons and limits, provided it publishes notice of such proposed proclamations in the Idaho Administrative Bulletin and provides notice to Legislative Services for review by the germane joint subcommittees as soon as possible after adoption by the commission.
