HOUSE BILL NO. 161

BY TRANSPORTATION AND DEFENSE COMMITTEE

AN ACT

RELATING TO MOTOR VEHICLES; AMENDING SECTION 49-306, IDAHO CODE, TO RE-
VISE PROVISIONS REGARDING CERTAIN LICENSING AND INSTRUCTION FEES; AND
AMENDING SECTION 49-2444, IDAHO CODE, TO REVISE PROVISIONS REGARDING
CERTAIN IDENTIFICATION CARD FEES AND AMOUNTS TO BE RETAINED BY COUNTIES
AND TO MAKE TECHNICAL CORRECTIONS.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. That Section 49-306, Idaho Code, be, and the same is hereby
amended to read as follows:

49-306. APPLICATION FOR DRIVER'S LICENSE, INSTRUCTION PERMIT,
COMMERCIAL LEARNER'S PERMIT OR RESTRICTED SCHOOL ATTENDANCE DRIVING PER-
MIT. (1) Every application for any instruction permit, restricted school
attendance driving permit, or for a driver's license shall be made upon
a form furnished by the department and shall be verified by the applicant
before a person authorized to administer oaths. Officers and employees of
the department, agents authorized by the department, and sheriffs and their
deputies are authorized to administer the oaths without charge. Every ap-
plication for a permit, extension or driver's license shall be accompanied
by the following fee, none of which is refundable:

- (a) Class A, B, C (4-year) license with endorsements --
age 21 years and older\$40.00
- (b) Class A, B, C (3-year) license with endorsements --
age 18 to 21 years\$30.00
- (c) Class A, B, C (1-year) license with endorsements --
age 20 years\$15.00
- (d) Class D (3-year) license -- under age 18 years\$2530.00
- (e) Class D (3-year) license -- age 18 to 21 years\$2530.00
- (f) Class D (1-year) license -- age 17 years or age 20 years ...\$1520.00
- (g) Four-year Class D license -- age 21 years and older\$305.00
- (h) Eight-year Class D license -- age 21 to 63 years\$5560.00
- (i) Commercial learner's permit\$29.00
- (j) Class D instruction permit or supervised instruction permit
.....\$1520.00
- (k) Duplicate driver's license or permit issued under
section 49-318, Idaho Code\$1520.00
- (l) Driver's license extension issued under section
49-319, Idaho Code\$10.00
- (m) License classification change (upgrade)\$25.00
- (n) Endorsement addition\$15.00
- (o) Class A, B, C skills tests not more than\$200.00
- (p) Class D skills test not more than\$35.00
- (q) Motorcycle endorsement skills test not more than\$25.00

- 1 (r) Knowledge test\$ 35.00
- 2 (s) Seasonal driver's license\$39.00
- 3 (t) Onetime motorcycle "M" endorsement\$15.00
- 4 (u) Motorcycle endorsement instruction permit\$15.00
- 5 (v) Restricted driving permit or restricted school attendance
- 6 driving permit\$60.00

7 (2) A person who applies for a driver's license or a driver's license
 8 renewal may designate a voluntary contribution of two dollars (\$2.00) for
 9 the purpose of promoting and supporting organ donation. Such a contribution
 10 shall be treated as a voluntary contribution to the organ donation contribu-
 11 tion fund created in section 49-2447, Idaho Code, and not as a driver's li-
 12 cense fee.

13 (3) Every application shall state the true and full name, date of birth,
 14 sex, declaration of Idaho residency, Idaho residence address and mailing ad-
 15 dress, if different, of the applicant, height, weight, hair color, and eye
 16 color, and the applicant's social security number as verified by the social
 17 security administration. If an applicant has submitted an application pur-
 18 suant to the provisions of chapter 58, title 19, Idaho Code, then the appli-
 19 cant may state, in his or her application pursuant to this section, the ap-
 20 plicant's alternative Idaho mailing address in place of his or her Idaho res-
 21 idence address and mailing address. Notwithstanding the provisions of sec-
 22 tion 49-303(13), Idaho Code, an applicant for a nondomiciled class A, B or
 23 C driver's license or nondomiciled commercial learner's permit having res-
 24 idency in a state that is prohibited from issuing class A, B or C driver's
 25 licenses or commercial learner's permits, as provided in 49 CFR 384, is ex-
 26 cepted from providing proof of Idaho residency and an Idaho mailing address.

27 (a) The requirement that an applicant provide a social security number
 28 as verified by the social security administration shall apply only to
 29 applicants who have been assigned a social security number.

30 (b) An applicant who has not been assigned a social security number
 31 shall:

- 32 (i) Present written verification from the social security admin-
 33 istration that the applicant has not been assigned a social secu-
 34 rity number; and
- 35 (ii) Submit a birth certificate, passport or other documentary
 36 evidence issued by an entity other than a state or the United
 37 States; and
- 38 (iii) Submit such proof as the department may require that the ap-
 39 plicant is lawfully present in the United States.

40 A driver's license, commercial learner's permit or any instruction
 41 permit issued on and after January 1, 1993, shall not contain an appli-
 42 cant's social security number. Applications on file shall be exempt
 43 from disclosure except as provided in sections 49-202, 49-203, 49-203A
 44 and 49-204, Idaho Code.

45 (c) Every application for a class A, B or C license shall state where the
 46 applicant has been licensed for the preceding ten (10) years and under
 47 which of the following driving categories the applicant will operate:

- 48 (i) Non-excepted interstate. The applicant operates or expects
 49 to operate in interstate commerce, and is required to provide a
 50 medical examiner's certificate;

1 (ii) Excepted interstate. The applicant operates or expects to
2 operate in interstate commerce, but engages exclusively in trans-
3 portation or operations excepted by the federal motor carrier
4 safety administration from all or parts of the qualification re-
5 quirements of federal motor carrier safety regulation 49, part
6 391, and is therefore not required to provide a medical examiner's
7 certificate;

8 (iii) Non-excepted intrastate. The applicant operates only in
9 intrastate commerce and is subject to and meets all Idaho driver
10 qualification requirements and the applicable parts of federal
11 motor carrier safety regulation 49, part 391, and is required to
12 provide a medical examiner's certificate; or

13 (iv) Excepted intrastate. The applicant operates in intrastate
14 commerce, but engages exclusively in exempted transportation or
15 operations as listed in section 67-2901B(2), Idaho Code, and the
16 applicable parts of federal motor carrier safety regulation 49,
17 part 391, and is therefore not required to provide a medical exam-
18 iner's certificate.

19 All applications shall also state whether the applicant has previ-
20 ously been licensed as a driver, and if so, when and by what state or
21 country, and whether a driver's license or privileges have ever been
22 suspended, revoked, denied, disqualified, canceled or whether an ap-
23 plication has ever been refused, and if so, the date of and reason for
24 the suspension, revocation, denial, disqualification, cancellation
25 or refusal and the applicant's oath that all information is correct as
26 signified by the applicant's signature.

27 (d) The applicant must submit proof of identity acceptable to the exam-
28 iner or the department and date of birth as set forth in a certified copy
29 of his birth certificate. When a certified copy of his birth certifi-
30 cate or a delayed birth certificate is impossible to obtain from a vital
31 statistics agency, another government-issued document may be submitted
32 that provides satisfactory evidence of a person's full legal name and
33 date of birth acceptable to the examiner or the department.

34 (e) Every applicant for a class A, B or C driver's license or commer-
35 cial learner's permit shall provide proof of United States citizenship
36 or lawful permanent residency in the United States upon application for
37 issuance, transfer, upgrade or renewal, unless the applicant's driving
38 record already contains documentation confirming United States citi-
39 zenship or lawful permanent residency. Every applicant for a nondomi-
40 ciled class A, B or C driver's license or commercial learner's permit
41 domiciled in a foreign country must provide an unexpired employment au-
42 thorization document issued by the department of homeland security or
43 an unexpired foreign passport accompanied by an approved I-94 form doc-
44 umenting the applicant's most recent admittance into the United States.

45 (f) Individuals required to register in compliance with section 3 of
46 the federal military selective service act, 50 U.S.C. App. 451 et seq.,
47 as amended, shall be provided an opportunity to fulfill such registra-
48 tion requirements in conjunction with an application for a driver's li-
49 cense, commercial learner's permit or instruction permit. Any regis-

1 tration information so supplied shall be transmitted by the department
2 to the selective service system.

3 (4) Whenever an application is received from a person previously li-
4 censed in another jurisdiction, the department shall request a copy of the
5 driver's record from the other jurisdiction and shall contact the national
6 driver register. When received, the driver's record from the previous ju-
7 risdiction shall become a part of the driver's record in this state with the
8 same force and effect as though entered on the driver's record in this state
9 in the original instance.

10 (5) Whenever the department receives a request for a driver's record
11 from another licensing jurisdiction, the record shall be forwarded without
12 charge.

13 (6) The department shall contact and notify the commercial driver li-
14 cense information system of the proposed application for a class A, B or C
15 driver's license or commercial learner's permit to ensure identification of
16 the person and to obtain clearance to issue the license.

17 (7) When the fees required under this section are collected by a county
18 officer, they shall, except as provided in subsection (8) of this section,
19 be paid over to the county treasurer not less often than monthly, who shall
20 immediately:

21 (a) Deposit an amount equal to ~~five~~ ten dollars (\$~~5~~10.00) from each
22 driver's license except an eight-year class D license, or any class
23 D instruction permit application fees, application for a duplicate
24 driver's license or permit, classification change, seasonal driver's
25 license and additional endorsement, and ~~ten~~ fifteen dollars (\$~~10~~15.00)
26 from each eight-year class D driver's license, in the current expense
27 fund;

28 (b) Deposit two dollars and fifty cents (\$2.50) from each motorcycle
29 endorsement and motorcycle endorsement instruction permit fee in the
30 current expense fund;

31 (c) Deposit an amount equal to ~~three~~ five dollars (\$~~3~~5.00) from each fee
32 for a knowledge test in the current expense fund;

33 (d) Deposit an amount up to twenty-five dollars (\$25.00) from each fee
34 for a motorcycle endorsement skills test in the current expense fund;
35 provided however, if a contractor administers the skills test he shall
36 be entitled to the entire fee;

37 (e) Remit the remainder to the state treasurer; and

38 (f) Deposit up to twenty-eight dollars and fifty cents (\$28.50) from
39 each fee for a class D skills test into the county current expense fund,
40 unless the test is administered by a department-approved contractor, in
41 which case the contractor shall be entitled to up to twenty-eight dol-
42 lars and fifty cents (\$28.50) of each fee.

43 (8) When the fees required under this section are collected by the de-
44 partment or an agent authorized by the department, they shall be paid over
45 to the state treasurer. When the department or an agent authorized by the
46 department collects the fees required under this section, the portion of
47 fees to be retained by the county shall be retained by the issuing authorized
48 agent.

1 (9) The state treasurer shall distribute the moneys received from fees
2 imposed by the provisions of this section, whether collected by a county of-
3 ficer or by a state officer or agency as follows:

4 (a) Two dollars (\$2.00) of each fee for a four-year driver's license
5 or seasonal driver's license, and four dollars (\$4.00) of each fee for
6 an eight-year class D driver's license, and one dollar and fifty cents
7 (\$1.50) of each fee charged for driver's licenses pursuant to subsec-
8 tion (1) (b), (d) and (e) of this section, and fifty cents (50¢) of each
9 fee charged for driver's licenses pursuant to subsection (1) (c) and
10 (f) of this section shall be deposited in the emergency medical ser-
11 vices fund II created in section 56-1018A, Idaho Code, and four dollars
12 (\$4.00) of each fee charged pursuant to subsection (1) (a), (g) and (s)
13 of this section and eight dollars (\$8.00) of each fee charged pursuant
14 to subsection (1) (h) of this section and three dollars (\$3.00) of each
15 fee for driver's licenses pursuant to subsection (1) (b), (d) and (e) of
16 this section, and one dollar (\$1.00) of each fee charged for driver's
17 licenses pursuant to subsection (1) (c) and (f) of this section shall be
18 deposited in the emergency medical services fund III created in section
19 56-1018B, Idaho Code;

20 (b) Twenty-eight dollars (\$28.00) of each fee for a seasonal or class A,
21 B or C driver's license, and nineteen dollars and fifty cents (\$19.50)
22 of each fee charged for a license pursuant to subsection (1) (b) of this
23 section, and eight dollars and sixteen cents (\$8.16) of each fee charged
24 for a license pursuant to subsection (1) (c) of this section shall be de-
25 posited in the state highway account;

26 (c) Twenty dollars (\$20.00) of each fee for a commercial learner's per-
27 mit or driver's license classification change shall be deposited in the
28 state highway account;

29 (d) Four dollars (\$4.00) of each fee for a commercial learner's permit
30 shall be deposited in the emergency medical services fund III created in
31 section 56-1018B, Idaho Code;

32 (e) Ten dollars (\$10.00) of each fee for a duplicate seasonal or class
33 A, B or C driver's license, class A, B or C driver's license extension,
34 or additional endorsement shall be deposited in the state highway ac-
35 count;

36 (f) Seven dollars and fifty cents (\$7.50) of each fee for a motorcycle
37 endorsement and motorcycle endorsement instruction permit shall be de-
38 posited in the state highway account;

39 (g) Five dollars and thirty cents (\$5.30) of each fee for a four-year
40 class D driver's license, and ten dollars and sixty cents (\$10.60) of
41 each fee for an eight-year class D driver's license, and four dollars
42 (\$4.00) of each fee charged for a license pursuant to subsection (1) (d)
43 and (e) of this section, and one dollar and thirty-three cents (\$1.33)
44 of each fee charged for a license pursuant to subsection (1) (f) of this
45 section shall be deposited in the driver training account;

46 (h) Twelve dollars and seventy cents (\$12.70) of each fee for a
47 four-year class D driver's license, and twenty dollars and forty cents
48 (\$20.40) of each fee for an eight-year class D driver's license, and ten
49 dollars and fifty cents (\$10.50) of each fee charged for a license pur-
50 suant to subsection (1) (d) and (e) of this section, and six dollars and

1 eighty-three cents (\$6.83) of each fee charged for a license pursuant
2 to subsection (1) (f) of this section shall be deposited in the highway
3 distribution account;

4 (i) Two dollars and sixty cents (\$2.60) of each fee for a class D in-
5 struction permit, duplicate class D license or permit, and class D li-
6 cense extension shall be deposited in the driver training account;

7 (j) Seven dollars and forty cents (\$7.40) of each fee for a class D in-
8 struction permit, duplicate class D license or permit, and class D li-
9 cense extension shall be deposited in the highway distribution account;

10 (k) Ten dollars (\$10.00) of each fee for a class A, B or C skills test
11 shall be deposited in the state highway account;

12 (l) One dollar (\$1.00) of each fee for a class A, B, C or four-year D
13 driver's license, and two dollars (\$2.00) of each fee for an eight-year
14 class D driver's license, and one dollar (\$1.00) of each fee charged for
15 a license pursuant to subsection (1) (b), (d) and (e) of this section,
16 and thirty-four cents (34¢) of each fee charged for a license pursuant
17 to subsection (1) (c) and (f) of this section shall be deposited in the
18 motorcycle safety program fund established in section 33-4904, Idaho
19 Code;

20 (m) Six dollars and fifty cents (\$6.50) of each fee for a class D skills
21 test shall be deposited into the state highway account; and

22 (n) Each voluntary contribution of two dollars (\$2.00) as described in
23 subsection (2) of this section, less actual administrative costs asso-
24 ciated with collecting and transferring such contributions, shall be
25 deposited into the organ donation contribution fund created in section
26 49-2447, Idaho Code.

27 (10) The contractor administering a class A, B or C skills test shall
28 be entitled to not more than one hundred ninety dollars (\$190) of the skills
29 test fee. A contractor administering a class A, B or C skills test may col-
30 lect an additional fee for the use of the contractor's vehicle for the skills
31 test.

32 (11) Sixty dollars (\$60.00) of each restricted driving permit and each
33 restricted school attendance driving permit shall be deposited in the state
34 highway account.

35 (12) The department may issue seasonal class B or C driver's licenses to
36 drivers who are employees of agri-chemical businesses, custom harvesters,
37 farm retail outlets and suppliers, and livestock feeders that:

38 (a) Will only be valid for driving commercial vehicles that normally
39 require class B or C commercial driver's licenses;

40 (b) Will be valid for seasonal periods that begin on the date of is-
41 suance and that are not to exceed one hundred eighty (180) days in a
42 twelve (12) month period;

43 (c) May only be obtained twice in a driver's lifetime;

44 (d) Are valid only within a one hundred fifty (150) mile radius of the
45 place of business or farm being serviced; and

46 (e) Will be valid only in conjunction with valid Idaho class D driver's
47 licenses.

48 (13) The department may issue seasonal class B or C driver's licenses to
49 drivers who:

- 1 (a) Have not violated the single license provisions of applicable fed-
2 eral regulations;
3 (b) Have not had any license suspensions, revocations or cancella-
4 tions;
5 (c) Have not had any convictions in any vehicle for any offense listed
6 in section 49-335(1) or (2), Idaho Code, or any one (1) serious traffic
7 offense;
8 (d) Have at least one (1) year of driving experience with a class D or
9 equivalent license in any type motor vehicle; and
10 (e) Are at least sixteen (16) years old.

11 SECTION 2. That Section 49-2444, Idaho Code, be, and the same is hereby
12 amended to read as follows:

13 49-2444. IDENTIFICATION CARD ISSUED -- FOUR-YEAR OR EIGHT-YEAR. (1)
14 The department shall issue a distinguishing identification card that shall
15 set forth the information contained in the application, in a form as pre-
16 scribed by the department. All identification cards issued on or after Jan-
17 uary 1, 1993, shall not contain the applicant's social security number. An
18 applicant's social security number shall be exempt from disclosure except
19 for inquiries from agencies or institutions authorized to obtain such infor-
20 mation by federal law or regulation, from peace officers, or from jury com-
21 missioners. Each card shall have printed on it the applicant's full name,
22 date of birth, Idaho residence address, sex, weight, height, eye color, and
23 hair color and shall be issued a distinguishing number assigned to the ap-
24 plicant. If an applicant has submitted an application pursuant to the provi-
25 sions of chapter 58, title 19, Idaho Code, then the applicant's identifica-
26 tion card shall contain his or her alternative Idaho mailing address in place
27 of his or her Idaho residence address. Each card shall also have printed on
28 it the name of this state, the date of issuance, and the date of expiration.
29 An identification card shall not be valid until it has been signed on the sig-
30 nature line by the applicant. Each card shall bear upon it a color photograph
31 of the applicant, which shall be taken by the examiner at the time of appli-
32 cation. The photograph shall be taken without headgear or other clothing or
33 device that disguises or otherwise conceals the face or head of the appli-
34 cant. A waiver may be granted by the department allowing the applicant to
35 wear headgear or other head covering for medical, religious or safety pur-
36 poses as long as the face is not disguised or otherwise concealed. At the re-
37 quest of the applicant, an identification card may contain a statement or in-
38 dication of the medical condition of the applicant.

39 No person shall receive an identification card unless and until he sur-
40 renders to the department all identification cards in his possession issued
41 to him by Idaho or any other jurisdiction, or any driver's license issued by
42 any other jurisdiction within the United States, or until he executes an af-
43 fidavit that he does not possess an identification card or any driver's li-
44 cense.

45 Identification cards issued to persons under eighteen (18) years of age
46 shall include a notation "under 18 until (month, day, year)," and identifi-
47 cation cards issued to persons eighteen (18) years of age to twenty-one (21)
48 years of age shall include a notation "under 21 until (month, day, year)."
49 The nonrefundable fee for a four (4) year identification card issued to

1 persons twenty-one (21) years of age or older shall be ~~ten~~ fifteen dollars
 2 (\$~~10~~5.00), of which ~~five~~ ten dollars (\$~~5~~10.00) shall be retained by the
 3 county and credited to the current expense fund, and five dollars (\$5.00)
 4 shall be deposited in the state treasury to the credit of the highway dis-
 5 tribution account. The nonrefundable fee for identification cards issued
 6 to persons under twenty-one (21) years of age shall be ten dollars (\$10.00),
 7 of which five dollars (\$5.00) shall be retained by the authorized issuing
 8 agent or, if issued by the county, shall be credited to the current expense
 9 fund, and five dollars (\$5.00) shall be deposited in the state treasury to
 10 the credit of the highway distribution account. The nonrefundable fee for an
 11 eight (8) year identification card shall be twenty-five dollars (\$~~20~~5.00),
 12 of which ~~ten~~ fifteen dollars (\$~~10~~5.00) shall be retained by the authorized
 13 issuing agent or, if issued by the county, shall be credited to the current
 14 expense fund, and ten dollars (\$10.00) shall be deposited in the state trea-
 15 sury to the credit of the highway distribution account. At the option of
 16 the applicant, the identification card issued to a person twenty-one (21)
 17 years of age or older shall expire either on the ~~cardholder's~~ card holder's
 18 birthday in the fourth year or the eighth year following issuance of the
 19 card, except as otherwise provided in subsection (3) of this section. Ev-
 20 ery identification card issued to a person under eighteen (18) years of age
 21 shall expire five (5) days after the person's eighteenth birthday, except
 22 as otherwise provided in subsection (3) of this section. Every identifica-
 23 tion card issued to a person eighteen (18) years of age but under twenty-one
 24 (21) years of age shall expire five (5) days after the person's twenty-first
 25 birthday, except as otherwise provided in subsection (3) of this section.

26 Individuals required to register in compliance with section 3 of the
 27 federal military selective service act, 50 U.S.C. App. 451 et seq., as
 28 amended, shall be provided an opportunity to fulfill such registration re-
 29 quirements in conjunction with an application for an identification card.
 30 Any registration information so supplied shall be transmitted by the depart-
 31 ment to the selective service system.

32 (2) Every identification card, except those issued to persons under
 33 twenty-one (21) years of age, shall be renewable on or before its expiration,
 34 but not more than twenty-five (25) months before, and upon application and
 35 payment of the required fee.

36 (3) Every identification card issued to a person who is not a citizen or
 37 permanent legal resident of the United States shall have an expiration date
 38 that is the same date as the end of lawful stay in the United States as indi-
 39 cated on documents issued and verified by the department of homeland secu-
 40 rity, provided however, that the expiration date shall not extend beyond the
 41 expiration date for the same category of identification card issued to citi-
 42 zens. Persons whose department of homeland security documents do not state
 43 an expiration date shall be issued an identification card with an expiration
 44 date of one (1) year from the date of issuance.

45 (4) When an identification card has been expired for less than twenty-
 46 five (25) months, the renewal of the identification card shall start from
 47 the original date of expiration, regardless of the year in which the applica-
 48 tion for renewal is made. If the identification card is expired for more than
 49 twenty-five (25) months, the application shall expire, at the option of the
 50 applicant, on the applicant's birthday in the fourth year or the eighth year

1 following reissuance of the identification card, except as otherwise pro-
2 vided in subsection (3) of this section.

3 (5) (a) If an Idaho identification card has expired or will expire and
4 the identification ~~cardholder~~ card holder is temporarily out of state,
5 except on active military duty, the identification ~~cardholder~~ card
6 holder may request in writing on a form prescribed by the department an
7 extension of the identification card. The request shall be accompanied
8 by the fee fixed in section 49-306, Idaho Code, and the extension shall
9 be no more than a twelve (12) month period. If the department determines
10 that an extension of the identification card is necessary, it may issue
11 an identification card showing the date to which the expired identifi-
12 cation card is extended. Identification card extensions are limited
13 to two (2) consecutive extensions per identification ~~cardholder~~ card
14 holder.

15 (b) Upon returning to the state of Idaho, the identification ~~cardholder~~
16 card holder shall, within ten (10) days, apply for a renewal of the ex-
17 pired identification card and surrender the extended identification
18 card and the expired identification card.

19 (6) An Idaho identification card issued to any person prior to serv-
20 ing on active duty in the armed forces of the United States, or a member of
21 the immediate family accompanying such a person, if valid and in full force
22 and effect upon entering active duty, shall remain in full force and effect
23 and shall, upon application, be extended for a period of four (4) years as
24 long as active duty continues, and the identification card shall remain in
25 full force and effect sixty (60) days following the date the ~~cardholder~~ card
26 holder is released from active duty.

27 (7) A person possessing an identification card who desires to donate
28 any or all organs or tissue in the event of death, and who has completed a
29 document of gift pursuant to the provisions for donation of anatomical gifts
30 as set forth in chapter 34, title 39, Idaho Code, may, at the option of the
31 donor, indicate this desire on the identification card by the imprinting of
32 the word "donor" on the identification card. The provisions of this subsec-
33 tion shall apply to persons possessing an identification card who are fif-
34 teen (15) years of age or older but less than eighteen (18) years of age if
35 the requirements provided in chapter 34, title 39, Idaho Code, have been com-
36 plied with.

37 (8) A person possessing an identification card or an applicant for an
38 identification card who is a person with a permanent disability may request
39 that the notation "permanently disabled" be imprinted on the identification
40 card, provided the person presents written certification from a licensed
41 physician verifying that the person's stated impairment qualifies as a per-
42 manent disability according to the provisions of section 49-117, Idaho Code.

43 (9) A person who is a veteran may request that his or her status as such
44 be designated on an identification card at no additional cost. Any such re-
45 quest shall be accompanied by proof of being a current or former member of
46 the United States armed forces. Upon request and submission of satisfactory
47 proof, the department shall indicate such person's status as a veteran on any
48 identification card issued pursuant to the provisions of this section. Such
49 designation shall be made upon original issuance or renewal of an identifi-
50 cation card. Designation shall also be made on any duplicate identification

1 card issued, provided that the fee for such duplicate card is paid in accor-
2 dance with this section.

3 Satisfactory proof of being a current or former member of the United
4 States armed forces must be furnished by an applicant to the department be-
5 fore a designation of veteran status will be indicated on any identification
6 card. Acceptable proof shall be a copy of form DD214 or an equivalent docu-
7 ment or statement from the department of veterans affairs that identifies a
8 character of service upon separation as "honorable" or "general under hon-
9 orable conditions."

10 (10) In the case of a name change, the applicant shall provide legal doc-
11 umentation to verify the change in accordance with department rules.

12 (11) Whenever any person, after applying for or receiving an identifi-
13 cation card, shall move from the address shown on the application or on the
14 identification card issued, that person shall, within thirty (30) days, no-
15 tify the transportation department in writing of the old and new addresses.

16 (12) The department shall cancel any identification card upon determin-
17 ing that the person was not entitled to the issuance of the identification
18 card, or that the person failed to give the required and correct information
19 in his application or committed fraud in making the application. Upon can-
20 cellation, the person shall surrender the canceled identification card to
21 the department.

22 (13) If any person shall fail to return to the department the identifi-
23 cation card as required, the department may direct any peace officer to se-
24 cure its possession and return the identification card to the department.

25 (14) The department may issue a no-fee identification card to an indi-
26 vidual whose driver's license has been canceled and voluntarily surrendered
27 as provided in section 49-322(5), Idaho Code. The identification card may be
28 renewed at no cost to the applicant as long as the driver's license remains
29 canceled.

30 (15) It is an infraction for any person to fail to notify the department
31 of a change of address as required by the provisions of subsection (11) of
32 this section.
