AN ACT 1 RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF ADMINISTRATION FOR THE 2 DIVISION OF PUBLIC WORKS FOR FISCAL YEAR 2021; APPROPRIATING AND TRANS-3 FERRING MONEYS FROM THE GENERAL FUND TO THE PERMANENT BUILDING FUND; AP-4 5 PROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF ADMINISTRATION FOR THE DIVISION OF PUBLIC WORKS AND DIRECTING THE ALLOCATION OF FUNDS FOR 6 SPECIFIC PROJECTS FOR FISCAL YEAR 2021; AND DECLARING AN EMERGENCY. 7 Be It Enacted by the Legislature of the State of Idaho: 8 q SECTION 1. CASH TRANSFER. There is hereby appropriated and the Office of the State Controller shall transfer \$89,217,500 from the General Fund to the Permanent Building Fund as soon as practicable for the period July 1, 11 2020, through June 30, 2021. 12 13 SECTION 2. In addition to the appropriation made in Section 1, Chapter 184, Laws of 2020, and any other appropriation provided by law, there is 14 hereby appropriated to the Department of Administration for the Division of 15 Public Works \$89,217,500 from the Permanent Building Fund to be expended for 16 capital outlay for the period July 1, 2020, through June 30, 2021, for the 17 following projects: 18 MAINTENANCE PROJECTS IN THE FOLLOWING AREAS: 19 20 Alteration and Repair Projects \$45,700,000 TOTAL MAINTENANCE PROJECTS 21 \$45,700,000 CAPITAL PROJECTS: 22 23 IDJC St. Anthony Cottages \$6,400,000 South Idaho Correctional Institution East Dorm 24 13,000,000 IDOC Connection and Intervention Station Housing 25 10,000,000 26 Military - Youth ChalleNGe Academy Dorms 7,417,500 UI Parma Agricultural Research Campus 27 3,000,000 CEI Future Tech Facility 28 3,000,000 UI Seedling Production Greenhouses 29 700,000 TOTAL CAPITAL PROJECTS 30 \$43,517,500

SECTION 3. An emergency existing therefor, which emergency is hereby declared to exist, this act shall be in full force and effect on and after its passage and approval.
