## STATEMENT OF PURPOSE

## RS28713 / H0272

This is the FY 2022 original appropriation bill for the Supreme Court. It appropriates a total of \$75,240,800. For benefit costs, the bill maintains the current appropriated amount for health insurance at \$11,650 per eligible FTP, extends the holiday for the employer's sick leave contribution rate for another year, and restores funding for the employer's unemployment insurance contribution rate. The bill also provides funding for the equivalent of a 2% change in employee compensation for permanent state employees. The bill funds two line items, which provide 2.00 FTP and \$271,700 to hire two new magistrate judges for the Third Judicial District (Canyon County); and \$344,200 for various staff positions for the guardian ad litem programs.
