Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. In addition to the appropriation made in Section 1, Chapter 226, Laws of 2020, and any other appropriation provided by law, there is hereby appropriated to the Department of Agriculture for the Plant Industries Program the following amounts to be expended according to the designated expense classes from the General Fund for the period July 1, 2020, through June 30, 2021, for the purpose of administering an industrial hemp program:

SECTION 2. FTP AUTHORIZATION. In addition to any other appropriation provided by law, there is hereby appropriated to the Department of Agriculture for the Plant Industries Program the following amounts to be expended according to the designated expense classes from the General Fund for the period July 1, 2021, through June 30, 2022, for the purpose of administering an industrial hemp program:

SECTION 4. FTP AUTHORIZATION. In addition to any other authorization provided by law, the full-time equivalent position authorization provided to the Department of Agriculture is hereby increased by one and five-tenths
