CONVENED: Chairman Thayn called the meeting of the Senate Education Committee

(Committee) to order at 3:00 p.m.

RS 28191 Relating to Education; Amends Idaho Code 33-205 to allow for student

hearings in executive session. Senator Zito outlined the bill's scope for the

committee.

MOTION: Senator Johnson moved to send RS 28191 to print. Senator Lent seconded the

motion. The motion carried by voice vote.

PRESENTATION: Dr. Marlene Tromp, President, Boise State University; Kevin Satterlee, President,

Idaho State University; **Dr. Cynthia Pemberton**, President, Lewis-Clark State College; and **C. Scott Green**, President, University of Idaho, gave a joint presentation to the Committee concerning the four year universities of Idaho (see

Attachment 1).

DISCUSSION: Vice Chairman Crabtree asked how the campuses were addressing the subject

of social justice. **Dr. Tromp** said they teach students how to think, not what to think. **Senator Ward-Engelking** wanted to know more about the rural initiative. **Dr. Tromp** said the community impact program went into communities with a low rate of engagement, and asked what types of programs would be helpful to the residents, and the colleges responded by offering those courses. **Chairman Thayn** asked about the sacrifices the faculties had to make based on budget cuts. **Mr. Satterlee** said transparency was key in keeping faculty informed. **Senator Ward-Engelking**

asked when the upgrades to the University of Idaho Parma Research and Extension Center would be initiated. **Mr. Green** said he was aware of the current condition of the Parma Research and Extension Center and that local industry has awarded \$3 million to upgrade the facility, which he hopes will be matched by the state. **Chairman Thayn** asked if there was any interest in the Career and

Technical Education (CTE) facility near Lewis-Clark State College. Dr. Pemberton

said interest was very high and she expects that interest to grow. **Senator Den Hartog** asked if any metrics for dual enrollment students have been gathered. **Mr. Satterlee** said a study was performed last year and students who participated in the CTE program are graduating at a higher rate and graduating college sooner.

PRESENTATION: Alexandra Dominguez, Director, State Government Relations, the College Board,

gave the Committee information about the Big Features program (see Attachment 2). **Ms. Dominguez** said she would send links to the program website to the

Committee members for inclusion in their newsletters.
