16.03.24 – THE MEDICALLY INDIGENT PROGRAM DOCKET NO. 16-0324-2201 (CHAPTER REPEAL) NOTICE OF RULEMAKING – ADOPTION OF TEMPORARY RULE

EFFECTIVE DATE: The effective date of the temporary rule is March 29, 2022.

AUTHORITY: In compliance with Sections 67-5226, Idaho Code, notice is hereby given this agency has adopted a temporary rule. The action is authorized pursuant to Sections 56-202 and 56-203, Idaho Code.

DESCRIPTIVE SUMMARY: The following is the required finding and concise statement of its supporting reasons for adopting a temporary rule:

This chapter of rule is no longer in effect due to the passage of H0735 by the 2022 legislature and is now being repealed in its entirety.

TEMPORARY RULE JUSTIFICATION: Pursuant to Section 67-5226(1)(b), Idaho Code, the Governor has found that temporary adoption of the rule is appropriate in order to comply with the deadlines in amendments to governing law or federal programs, specifically H0735 (2022), Section 11, which eliminated the statutory authority for this chapter of rule, effective March 29, 2022.
