STATEMENT OF PURPOSE

RS29760 / H0757

This is the FY 2023 original appropriation bill for the Soil and Water Conservation Commission. It appropriates a total of \$5,485,400 and caps the number of authorized full-time equivalent positions at 18.75. For benefit costs, the bill increases the appropriated amount for health insurance by \$850 to \$12,500 per eligible full time FTP, includes a one-year holiday of unemployment insurance, and adjusts workers' compensation amounts. The bill also provides funding for permanent employees for the equivalent of a 3% salary structure shift and provides \$1.25 per hour per eligible employee to be distributed based on merit for change in employee compensation. The bill funds two line items, which provide additional General Fund and federal funds that are passed-through to the 50 local Soil and Water Conservation Districts, and matching funds for the Conservation Enhancement Reserve Program. Also included in this bill is a onetime FY 2022 supplemental, which provides funds for the Water Quality Program for Agriculture.
