1 RELATING TO APPROPRIATIONS FOR FISCAL YEAR 2023; APPROPRIATING ADDITIONAL
2 MONEYS TO THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT PROGRAM'S DIVISION OF
3 ADMINISTRATORS FOR FISCAL YEAR 2023; APPROPRIATING ADDITIONAL MONEYS
4 TO THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT PROGRAM'S DIVISION OF OP-
5 ERATIONS FOR FISCAL YEAR 2023; APPROPRIATING GENERAL FUND MONEYS FOR
6 TRANSFER TO THE PUBLIC SCHOOL INCOME FUND FOR FISCAL YEAR 2023; CLARI-
7 FYING THE ORIGINAL FUND SOURCE FOR EXPENDITURES TO THE PUBLIC SCHOOLS
8 EDUCATIONAL SUPPORT PROGRAM FOR FISCAL YEAR 2023; APPROPRIATING ADDI-
9 TIONAL MONEYS TO THE LEGISLATURE FOR FISCAL YEAR 2023; AND DECLARING AN
10 EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

12 Be It Enacted by the Legislature of the State of Idaho:

13 SECTION 1. In addition to any other appropriation provided by law,
14 there is hereby appropriated to the Public Schools Educational Support Pro-
15 gram for the Division of Administrators \$3,000,000 from the Public School
16 Income Fund for the period July 1, 2022, through June 30, 2023.

17 SECTION 2. In addition to any other appropriation provided by law,
18 there is hereby appropriated to the Public Schools Educational Support
19 Program for the Division of Operations \$20,500,000 from the Public School
20 Income Fund for the period July 1, 2022, through June 30, 2023.

21 SECTION 3. There is hereby appropriated and the Office of the State
22 Controller shall transfer \$23,500,000 from the General Fund to the Public
23 School Income Fund on July 1, 2022, or as soon thereafter as practicable for
24 the period July 1, 2022, through June 30, 2023.

25 SECTION 4. Of the additional amounts appropriated in Sections 1 and 2 of
26 this act for the Public School Support Program, \$23,500,000 shall be consid-
27 ered expended from the General Fund for the period July 1, 2022, through June
28 30, 2023.

29 SECTION 5. In addition to any other appropriation provided by law,
30 there is hereby appropriated to the Legislature \$100,000 from the General
31 Fund to be expended for operating expenditures for the period July 1, 2022,
32 through June 30, 2023, for the purpose of establishing an interim committee
33 to review the public school funding formula as provided for in House Bill
34 No. 723, as enacted by the Second Regular Session of the Sixty-sixth Idaho
35 Legislature.

36 SECTION 6. An emergency existing therefor, which emergency is hereby
37 declared to exist, this act shall be in full force and effect on and after
38 July 1, 2022.
