RELATING TO THE APPROPRIATION TO THE IDAHO COMMISSION FOR LIBRARIES; AP PROPRIATING MONEYS TO THE IDAHO COMMISSION FOR LIBRARIES FOR FISCAL
 YEAR 2023; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT PO SITIONS; PROVIDING REAPPROPRIATION AUTHORITY; REAFFIRMING STATUTORY
 COMPLIANCE REGARDING OBSCENE MATERIAL; AND DECLARING AN EMERGENCY AND
 PROVIDING AN EFFECTIVE DATE.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. There is hereby appropriated to the Idaho Commission for Libraries the following amounts to be expended according to the designated expense classes from the listed funds for the period July 1, 2022, through June 30, 2023:

SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519, Idaho Code, the Idaho Commission for Libraries is authorized no more than thirty-seven and five-tenths (37.50) full-time equivalent positions at any point during the period July 1, 2022, through June 30, 2023, unless specifically authorized by the Governor. The Joint Finance-Appropriations Committee will be notified promptly of any increased positions so authorized.

SECTION 3. REAPPROPRIATION AUTHORITY. There is hereby reappropriated
 to the Idaho Commission for Libraries any unexpended and unencumbered bal ances appropriated to the Idaho Commission for Libraries from the American
 Rescue Plan Fund for fiscal year 2022, in an amount not to exceed \$2,300,000,
 to be used for nonrecurring expenditures for the period July 1, 2022, through

June 30, 2023. The Office of the State Controller shall confirm the reappropriation amount, by fund, expense class, and program, with the Legislative
Services Office prior to processing the reappropriation authorized herein.

SECTION 4. OBSCENE MATERIAL. The Idaho Commission for Libraries shall, 4 to the maximum extent possible with available staffing and resources: (1) 5 6 Verify that the Commission's library resources for K-12 students comply with Sections 33-137 and 33-2508, Idaho Code; (2) Incorporate references to rele-7 vant statutes regarding obscene material in the Commission's Electronic Re-8 sources Collection Development Policy; and (3) Provide a written report to 9 the Joint Finance-Appropriations Committee no later than September 1, 2022, 10 detailing progress in complying with this section and any associated inter-11 nal audits. 12

SECTION 5. An emergency existing therefor, which emergency is hereby declared to exist, this act shall be in full force and effect on and after July 1, 2022.
